Pediatrics: An Evolving Concept for the 21st Century

Pediatrics is rapidly evolving, and the diagnostic tools are expanding the spectrum of diagnoses that can be identified at the bedside. The recent progress identified in pediatrics of the last 20 years is astonishing and has consolidated the concept that children are not "smaller adults" and indeed, perinatal and pediatric pathology has become an independent subspecialty in pathology with impressive intersections with fetal medicine, neonatology, and pediatrics. The neonatal intensive care unit (NICU) as well as the pediatric intensive care unit (PICU) play a major role in modern hospitals. These sections of the hospital provide sick newborns and children with the highest level of medical care. Differently from the general medical floors, both units allow intensive nursing care and continuous monitoring of vital parameters, including heart rate, breathing, and blood pressure. The survival of premature babies and small for date newborns has increased exponentially in the last few decades. On the other hand, the immune system, as well as the pulmonary and gastrointestinal organs, remain difficult to manage. At this age an increased rate of infection has been identified, and gastrointestinal dysfunction is common [1–6]. Cardiovascular function and sepsis are intimately related and may trigger early death without NICU or PICU intervention [7]. Although the diagnostic procedures in newborns are often overlapping with diagnostic algorithms used at older age, they continue to be a complex and dynamic process which requires a proper investigation of the obstetrical and medical history, skillful physical examination, appropriate laboratory tests, and imaging studies with or without pathological examination of tissue biopsies. On the other hand, even with these steps, diagnosis may remain elusive. The journey from the first appearance of symptom or sign to the final diagnosis may seem sometimes interminable. Today, new techniques seem to shorten this journey swiftly, and next-generation sequencing (NGS) will play a major role in the next decade. NGS is becoming more and more used in clinics other than in academia, although one of the most challenging aspects of NGS testing may reside in its analytical validity. The field of metabolomics is indeed developing at a remarkable rate, particularly in pediatrics. Over the last few years, the pre-clinical detection of pathologies has become more robust and efficient. In electronic libraries, new biomarkers are being identified for several pathologies in neonatology and pediatrics. Management of pediatric diseases may become extenuating, and the use of single nucleotide polymorphisms for the improvement of our approach to some pediatric diagnostic algorithmic failures targeting the interindividual variability may be considered. Pediatric trial networks provide pediatricians, researchers, and agencies with new information on how children may respond to drugs and medications. The present Special Issue collects wet lab research and review articles to highlight some fields of pediatrics that may shape future directions in the diagnosis and management of some diseases. Pediatric heart failure is a challenge in neonatology and pediatrics, and quality assurance criteria are key [7–11]. An open-heart surgery with cardiopulmonary bypass (CPB) remains an interventional procedure accompanied by a high mortality/morbidity rate. Satriano et al. investigated whether blood concentrations of glutathione (GSH), a powerful endogenous antioxidant, changed in the perioperative period [12]. In the perioperative period, the increase in GSH may suggest that a compensatory mechanism to

oxidative damage during surgical procedure takes place. The measurement of the interferon (IFN) score has been suggested for the screening of monogenic interferonopathies, like the Aicardi–Goutières syndrome. Moreover, it may be useful to stratify subjects with systemic lupus erythematosus before receiving IFN-targeted treatments. Pin et al. developed an approach to reduce the inter-laboratory variability [13]. These authors provide shared strategies for the IFN signature analysis. They allow different centers to compare data and merge their experiences. Diabetic retinopathy (DR) is a dramatic and major microvascular complication of diabetes mellitus, and very few studies have evidenced the magnitude of this disorder in the pediatric population [14]. The International Society for Pediatric and Adolescent Diabetes (ISPAD) mandates that annual screening for DR should be performed in patients aged 11 years after diabetes of 2 years' duration and from 9 years of age with diabetes of 5 years' duration [15]. Kołodziej et al. studied the width of individual retinal layers in patients with type 1 diabetes (T1DM) correlating their data with markers of diabetes metabolic control applying the optical coherence tomography (OCT) study performed using a high definition OCT Cirrus 5000 [16]. The authors found a positive correlation between center thickness and spectral-domain for average glycemia and temporal CT with age at examination, suggesting that selected parameters may be applied as potential markers of preclinical phase of DR in patients with T1DM. Allen and Gupta highlight the current and nearest futuristic perspective of “artificial pancreas” suggesting that soon such a system may not require any manual patient input allowing patients to eat throughout the day without entering any blood sugars or counting carbohydrates [17]. Such a device may be commercially available as technology continues to advance in this direction using artificial intelligence. Sarcoidosis is an inflammatory syndrome of non-necrotizing granulomatous type with multisystemic manifestations, and its occurrence in pediatrics is not an isolated finding any longer. Few cases have been reported of this intriguing disease in children and youth [18]. Chiu et al. revised this topic in detail in this issue [19]. These authors focused on early-onset sarcoidosis, high-risk sarcoidosis, and atypical sarcoid-related diseases. Blau syndrome and early-onset sarcoidosis occur in children younger than five years manifesting with extra-thoracic findings but usually without lymphadenopathy and pulmonary involvement. Endoscopic bronchial ultrasound (EBUS) and transbronchial fine-needle aspiration (TBNA) sampling of intrathoracic lymph nodes and lung may provide good diagnostic yield and excellent patient safety profile in childhood. Respiratory syncytial virus (RSV) bronchiolitis remains an important cause of morbidity in early infancy. RSV belongs to the species of *Orthopneumovirus*. The human RSV (HRSV) infects 60% of infants during their first RSV season, and usually all children show an infection record with this virus by 2–3 years of age [20]. Among the infants infected with RSV, 2–3% will develop bronchiolitis, necessitating hospitalization [21]. RSV bronchiolitis is a major cause of infection and hospitalization in infancy and childhood worldwide. Palivizumab can be employed to prevent this infection in preterm babies, infants with certain congenital heart defects (CHD), infants affected with bronchopulmonary dysplasia (BPD), and infants with congenital malformations of the airway. HRSV bronchiolitis is treated with supportive care, including oxygen therapy, continuous positive airway pressure (CPAP) or nasal high flow oxygen, as required. Rodriguez-Gonzalez et al. identified that left ventricular myocardial dysfunction (LVMD) might occur in healthy infants with HRSV bronchiolitis who develop severe disease and need to be treated at the PICU [22]. N-terminal pro-B-type natriuretic peptide (NT-proBNP) seems to increase the accuracy of traditional clinical markers in predicting the outcomes. Duvekot et al. report a rare event complicating a common adenotonsillectomy. Subcutaneous and mediastinal emphysema followed by group A beta-hemolytic streptococci mediastinitis occurred in a young child, reminding us the life-threatening complications of such surgical procedure [23]. Primary indications for adenotonsillectomy are obstructive sleep apnea (OSA) and recurrent pharyngotonsillitis. Although there is evidence-based medicine supporting the use of such surgical procedures on children affected with OSA that is mainly derived on sleep studies, quality of life, and child behavior, it seems that the impact of surgery on recurrent sore throat symptoms is less well delineated. It has been indicated that children younger than three years and children with OSA of moderate to severe degree, as well as infants affected with significant

comorbidities should be admitted for overnight observation. In most patients, simple analgesia is adequate postoperatively, while codeine is contraindicated due to cases of postoperative death as consequence of respiratory suppression. Pain and postoperative hemorrhage (2–4%) are the most common complications, but bleeding can be life-threatening, nevertheless the mortality rate remains small but substantial (1:30,000) [24]. Besides tonsillar enlargement, salivary gland enlargement is a condition which enters in the differential diagnosis of head and neck (H&N) masses. Branchial cysts, sialadenosis, and inflammation of the salivary glands are often seen in childhood and youth, but H&N malignant pathologies also need to be taken into consideration. Sergi et al. critically review the diagnostic features of a pediatric mass of the H&N region [25]. Somatosensory evoked potentials (SSEPs) are crucial in assessing the functional integrity of the neural pathways and for predicting the outcome of perinatal injuries. Barkhuizen et al. studied the translational potential of SSEPs together with sensory function in rodents with perinatal hypoxic-ischemic events [26]. No group differences in the amplitude or latency of the evoked potentials of the preceding sensory response were seen, but nevertheless this method of study is intriguing for the functional recovery. Das and van Landeghem revise the clinicopathological spectrum of bilirubin encephalopathy/kernicterus, which is relatively rare but continues to occur despite universal newborn screening, particularly in middle and low income countries [27]. The authors illustrate the array of clinicopathological findings, and the procedures of diagnostic testing reported to be key in the context of bilirubin encephalopathy and kernicterus. Khan and Sergi report on sialidosis, which is a rare, autosomal recessive inherited disorder, caused by α -N-acetyl neuraminidase deficiency resulting from a mutation in the neuraminidase gene (*NEU1*) and accompanied by cerebral and extra-cerebral manifestations combining the underlying molecular biology, the clinical features, and the morphological patterns of this disorder [28].

Finally, the attention should be drawn to the frontispiece of this book. It is a photograph of a famous sculpture of Horatio Greenough (6 September 1805–18 December 1852). He was an American sculptor who was best known for his two United States government commissions, “The Rescue” and “George Washington”, among others. Before graduating from Harvard, Horatio Greenough sailed to Italy, Rome, to study art. There, the sculptor created many busts. In 1833, he realized “The Ascension of a Child Conducted by an Infant Angel” in marble. The gift to the Museum of Fine Arts in Boston, Massachusetts, United States of America, is a marvelous and touching piece of art and may combine the most elysian characteristics of all Greenough’s sculpture. Both the child and the angel are animated by a deep serenity, which may deeply contrast to the austere Hadrian’s words engraved in the sculpture support (*Animula, vagula, blandula - Hospes comesque corporis - Quae nunc abibis in loca Pallidula, rigida, nudula - Nec, ut soles, dabis iocos?* Little, suave, and wanderer soul, guest and partner of the body - Where are you off to now? Somewhere without color, severe, and empty - Never will you participate in gags as usual). Publius Aelius Hadrianus Augustus was a Roman emperor from 117 to 138 A.D., who died at the age of 62 years following a long and restless reign. Suffering from hypertension and coronary atherosclerosis in the last years of his life, he probably died of congestive heart failure as extensively reported by Dio Cassius and the *Historia Augusta* records [29]. This suffering has probably shaped some of his scripts. The “Ascension of a Child Conducted by an Infant Angel” conveys an astonishingly gentle, warm, and attractive message of peacefulness, hope, and spirituality in an age of high infant mortality. In 1911, Newmayer wrote that the country which first recognizes its responsibilities to the child would be given the appreciation of the world as being the leading civilized nation [30]. At this time, the United States lagged in the child’s health and welfare, and the infant mortality rate (IMR) positioned the United States as ranked in the 18th position out of 30 countries, with a rate of 135 deaths per 1000 live births. Following the European example, US public health leaders started a national campaign to reduce infant mortality, and, in 1912, the US Children’s Bureau (USCB) was founded (Broscio 1999). Federal and state programs multiplied and, progressively, pediatricians and children’s hospitals also surfaced as the ideal supply of healthcare for children. The improvement of nutrition and treatment of rickets were also crucial and the results of these efforts during the last century have been impressive in all states consolidating the concept of pediatric healthcare in other

countries, such as Canada, as well [31]. Digitalization of the imaging in radiology and pathology is a reality in several healthcare institutions worldwide [32,33]. Advances in medical diagnosis and therapy with the implementation of new technologies will be the basis for the future of pediatric healthcare, personalized pediatrics, and quality assurance and controls in the 21st century.

Glutathione Blood Concentrations: A Biomarker of Oxidative Damage Protection during Cardiopulmonary Bypass in Children

Abstract: Background. Pediatric open-heart surgery with cardiopulmonary bypass (CPB) still remains a risky interventional procedure at high mortality/morbidity. To date, there are no clinical, laboratory, and/or monitoring parameters providing useful information on perioperative stress. We therefore investigated whether blood concentrations of glutathione (GSH), a powerful endogenous antioxidant, changed in the perioperative period. Methods. We conducted an observational study in 35 congenital heart disease (CHD) children in whom perioperative standard laboratory and monitoring parameters and GSH blood levels were assessed at five monitoring time points. Results. GSH showed a pattern characterized by a progressive increase from pre-surgery up to 24 h after surgery, reaching its highest peak at the end of CPB. GSH measured at the end of CPB correlated with CPB duration, cross-clamping, arterial oxygen partial pressure, and with body core temperature. Conclusions. The increase in GSH levels in the perioperative period suggests a compensatory mechanism to oxidative damage during surgical procedure. Caution is needed in controlling different CPB phases, especially systemic reoxygenation in a population that is per se more prone to oxidative stress/damage. The findings may point the way to detecting the optimal temperature and oxygenation target by biomarker monitoring.

1. Introduction

Pediatric open-heart surgery with cardiopulmonary bypass (CPB) still remains a risky interventional procedure at high mortality and morbidity [1]. Hemodynamic and thermal changes occurring during CPB are known to trigger a cascade of events (i.e., ischemia-reperfusion injury, surgical procedure, endothelial dysfunction, activation of complement, coagulation, and inflammatory processes) that can lead to tissue damage [2].

The assessment of proinflammatory cytokines and intracellular biomarkers has been recently proposed in order to offer useful information on tissue stress in the perioperative period [3]. In this regard, it has been shown that glutathione (GSH) is essential for vascular and cardiac function and determines cell survival [4–7]. Moreover, in humans and in animal heart failure models, exacerbated tumor necrosis factor and soluble tumor necrosis factor receptor-1 expression was related to systemic and cardiac GSH deficiency supporting the notion of GSH's role in the defense against oxidative stress [4,5,8–10].

GSH has been detected in different biological fluids and it has been suggested that its presence provides a good source of this protective antioxidant for newborns. GSH performs several important physiological functions, such as (a) inactivation of oxygen-derived highly reactive species [10,11]; (b) detoxification of various types of xenobiotics and carcinogens [10,12]; (c) maintenance of the oxidative status of other antioxidants, such as ascorbic acid and α -tocopherol [13]; and (d) cell immune response improvement by activation of lymphocytes [14]. In this light, GSH in adults undergoing surgical repair with CPB has been shown to increase, reflecting a cellular defense mechanism against oxidative damage during reperfusion [15]. Conversely, data on GSH concentrations in children, affected by congenital heart disease (CHD) and undergoing cardiac surgery, are still lacking or are a matter of debate. Reduced GSH levels has been recently shown to play an important role in inflammatory response [3], whereas changes in GSH blood levels were observed according to different CPB phases (i.e., controlled antegrade low oxygen warm reperfusion before de-clamping and aortic cross-clamping release) [15].

Therefore, in the present observational study we investigated whether, in CHD children undergoing cardiac surgery with CPB, blood concentrations of a powerful endogenous antioxidant, namely GSH, changed in the perioperative period.

2. Materials and Methods

We conducted an observational study at our third-level referral center for pediatric cardiac diseases of 35 CHD children without pre-existing neurological disorders or other co-morbidities. CHD characteristics as well as main interventions and clinical laboratory parameters recorded at admission into the study are reported in Table 1.

Informed and signed consent from parents was obtained, before the patients' inclusion in the study, which was approved by the local human investigation committee (N718, EC Policlinico San Donato Milanese, 12, 12, 2012).

At admission to our unit, all children underwent clinical and standard laboratory and monitoring parameter recordings and GSH assessment. Blood samples were drawn at five predetermined times before, during, and after surgery, namely, before the surgical procedure and anesthesia (time 0, T0); during the surgical procedure after sternotomy and before CPB (time 1, T1); at the end of CPB (time 2, T2); at the end of the surgical procedure (time 3, T3); 24 h after the surgical procedure (time 4, T4). The following parameters were also recorded: peripheral temperature; nasopharyngeal temperature; pump flow rate; heart rate (HR) mean arterial systolic and diastolic blood pressure (BP); left and right atrium BP (LA, RA); pulsed arterial oxygen tension (SaO₂); and laboratory parameters such as arterial blood pH and oxygen (PaO₂) and carbon dioxide (PaCO₂) partial pressures, bicarbonate (HCO₃), base excess (BE), and hemoglobin (Hb) concentrations, hematocrit rate (Ht), platelet count, and creatinine, urea, lactate dehydrogenase, creatine kinase, and glucose blood levels.

2.1. Anesthetic Technique

After premedication with midazolam (Ipnovel, Roche, Milan, Italy), 0.5 mg/kg-bw (intramuscular), induction was achieved with oxygen and 3% sevoflurane (SevoFlo, Zoetis Belgium SA, Louvain-la-Neuve, Belgium) administered via mask (single-breath induction), followed by intravenous sufentanil (Fentanest, Pharmacia and Upjohn, Milan, Italy) 1 (g/kg-bw) and vecuronium (Norcuron, NV organon, Oss, The Netherlands) (0.15 mg/kg-bw). Maintenance was achieved with 3% sevoflurane (except during CPB) and with additional doses of sufentanil (0.5 g/kg-bw) and vecuronium (0.1 mg/kg-bw) every 30–40 min. During CPB, in the absence of sevoflurane, additional midazolam at 0.2 mg/kg-bw dosage was given. Sufentanil infusion at 0.25 g/kg-bw was continued in the intensive care unit for sedation [16].

2.2. Cardiopulmonary Bypass Management

The study population underwent a CPB procedure according to our protocols [16]. CPB was established after systemic heparinization (3 mg/kg-bw) by standard single-stage aortic and bicaval cannulation, and maintained via non-pulsatile pump flow with a membrane oxygenator (Dideco Laboratories, Modena, Italy). Flow velocity was kept at 120–150 mL/kg-bw, and mean arterial blood pressure at 45 mmHg; hypothermia was attained by core and surface cooling. Three patients were operated in deep hypothermic circulatory arrest (DHCA) (19 ± 7 min) and the minimum temperature reached was 25 °C. Mean rewarming time was calculated from the final temperature during hypothermic circulatory arrest to 36.5 °C. The pump priming solution was composed of electrolyte solutions (Normosol-R 250 to 650 mL, Abbott Hospital Products, Abbott Park, IL, USA or Plasma-Lyte A, Travenol Laboratories, Inc., Deerfield, IL, USA), albumin (25%), heparin 1000 to 5000 units in the total solution, sodium bicarbonate (25–30 mEq/L), and packed red blood cells or fresh frozen plasma. A standard total circuit prime volume was used, according to body weight, varying from 400 mL (bw < 4.5 kg), to 600 mL (bw > 4.5 kg and bw < 7.5 kg) and to 700 mL (bw > 7.7 kg). Packed red blood cells (200 to 500 mL) were transfused as needed to maintain a hematocrit level above 30% during CPB. Protamine (1 mg for each mg of heparin) was administered at the end of CPB. The α -stat regimen was used, and the PaCO₂ maintained between 35 and 40 mmHg, without mathematical correction for the effects of the temperature, by varying the membrane oxygenator gas flow [16].

Modified ultrafiltration (MUF) was routinely performed before removal of arterial and venous cannulae. In the CPB circuit, the arterial line was connected to the inlet and the venous line to the outlet of the ultrafilter. As the patient was separated from the CPB, the clamp was removed from the inlet of the filter, allowing the blood to flow through the arterial line to the filter (10–15 mL/kg/min) and, finally, from a venous line to the RA. The filter allows the passage of molecules smaller than 65 kD molecular weight. When it was necessary to maintain the intravascular volume and stabilize the

hemodynamics, the blood returned via the venous reservoir and the venous cannula to the RA. This technique was performed until the Ht achieved the target of 35% [17].

2.3. GSH Measurement

Levels of nonproteic thiol groups were measured in 200 μ L of blood, in accordance with the method presented by Hu [18], with partial modifications. This spectrophotometric assay is based on the reaction of thiol groups with 2,2-dithio-bis-nitrobenzoic acid (DTNB) in absolute ethanol to give a colored compound absorbing at $\lambda = 412$ nm. Since the DTNB method is strongly affected by pH, the possibility of avoiding acids (trichloroacetic or sulfosalicylic acid) to precipitate proteins represents a remarkable advantage to ensure the accuracy of the assay. We then carried out the removal of proteins with an excess of absolute ethanol, followed by centrifugation at 3000g for 10 min at room temperature. Each value represents the mean \pm SD of three experimental determinations for each sample. Results were expressed as micromoles per milliliter of blood.

2.4. Neurological Follow-up

Neurological examination was performed daily according to Prechtl [19]. Each child was assigned to one of three diagnostic groups—normal, suspect, abnormal. A child was considered to be abnormal when one or more of the following neurological syndromes were unequivocally present: (a) increased or decreased excitability (hyperexcitability syndrome, convulsion, apathy syndrome, coma); (b) increased or decreased motility (hyperkinesia, hypokinesia); (c) increased or decreased tonus (hypertonia, hypotonia); (d) asymmetries (peripheral or central); (e) defects of the central nervous system; (f) any combination of the above. When indications of the presence of a syndrome were non-conclusive or if only isolated symptoms were present (e.g., mild hypotonia or only a slight tremor), the children were classified as suspect. Abnormal and suspect cases were excluded from the study.

2.5. Statistical Analysis

For the calculation of sample size, we used GSH changes as the main parameter. As no basic data are available for a studied population, we assumed a decrease of 0.5 SD in GSH to be clinically significant. Indeed, considering $\alpha = 0.05$ and using a two-sided test, we estimated a power of 0.80 recruiting 33 CHD patients. We added $n = 2$ cases to allow any dropout. The sample size was calculated by using nQuery Advisor (Statistical Solutions, Saugus, MA, USA), version 5.0. The Kolmogorov–Smirnov test showed values having a Gaussian distribution, and data were expressed as the mean (SD). Statistical significance was assessed using one-way ANOVA for repeated measures (followed by the post-hoc Tukey test for multiple comparisons) and the unpaired *t*-test when only two groups were compared. Linear regression analysis was used for correlation between GSH and CPB and laboratory parameters. Statistical significance was set at $p < 0.05$.

3. Results

Monitoring and laboratory variables at the predetermined perioperative time points are shown in Table 2. Clinical parameters recorded during surgery remained within limits regarded as within the reference ranges during this type of procedure. No significant differences from T0 to T4 ($p > 0.05$, for all) were observed regarding hemoglobin concentration; hematocrit rate; arterial blood pH, PaCO₂, HCO₃, BE, and SaO₂; HR; LA BP; RA BP; systolic and diastolic BP; and glucose blood levels. PaO₂ showed a pattern, from T0 to T4, characterized by a significant ($p < 0.01$, for all) progressive increase in concentration reaching its highest peak at T2 ($p < 0.001$) and progressively decreasing at the end of surgery up to 24 h after the surgical procedure (Table 2).

No overt neurological injury was observed in surviving patients during the first week after surgery. In CHD children, GSH blood levels were measurable at all monitoring time points. GSH showed a pattern characterized by a progressive increase from T0 (before surgery) to T4 (at 24 h after surgery), reaching its highest peak at T3 (at the end of CPB) and remaining at high levels up to T4 ($p < 0.01$, for all) (Figure 1).

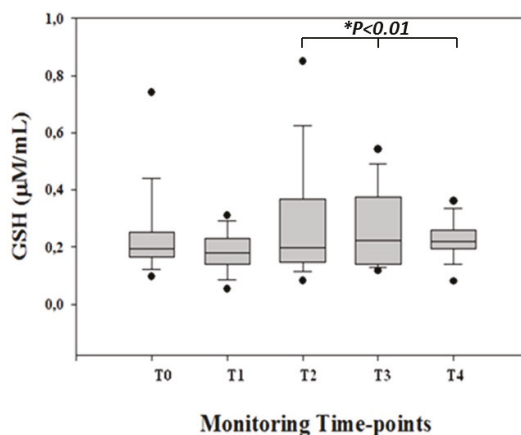


Figure 1. GSH concentrations ($\mu\text{M}/\text{mL}$) expressed as median and 5°–95° centiles at different monitoring time points: before the surgical procedure (T0); during the surgical procedure after sternotomy and before CPB (T1); at the end of CPB (T2); at the end of the surgical procedure (T3); and at 24 h after the surgical procedure (T4) in congenital heart disease children. GSH was significantly ($*p < 0.01$, for all) higher at T3 and T4 vs. T0 monitoring time points.

No significant differences ($p > 0.05$, for both) in GSH levels were shown from T0 to T2. Moreover, in order to evaluate the potential side effects of PaO₂ on GSH levels, we calculated the PaO₂/GSH ratio.

The PaO₂/GSH pattern was characterized by a significant ($p < 0.05$, for all) increase from T0 to T3, whereas no differences ($p > 0.05$) were found between T0 and T4.

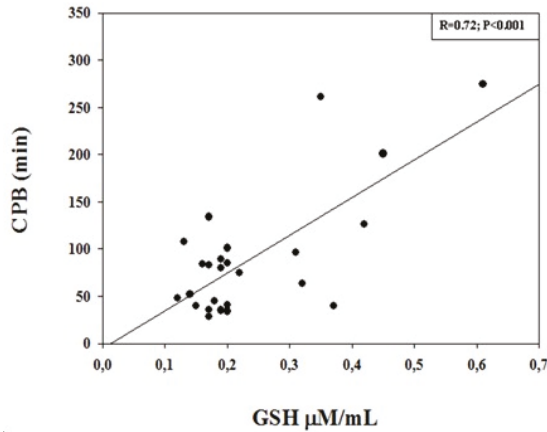


Figure 2. Correlation between GSH concentrations ($\mu\text{M}/\text{mL}$) measured at the end of cardiopulmonary bypass (CPB) procedure and CPB duration (min). There was a significant positive correlation ($R = 0.72$; $p < 0.001$).

Linear regression analysis showed a significant correlation between GSH levels measured at the end of CPB (T2). In particular, a positive significant correlation was found with CPB duration ($R = 0.72$; $p < 0.001$), with cross-clamping ($R = 0.62$, $p < 0.001$), and with PaO₂ ($R = 0.53$; $p = 0.002$), whereas a negative significant correlation was observed with body core temperature ($R = -0.49$; $p = 0.012$) (Figures 2–4).

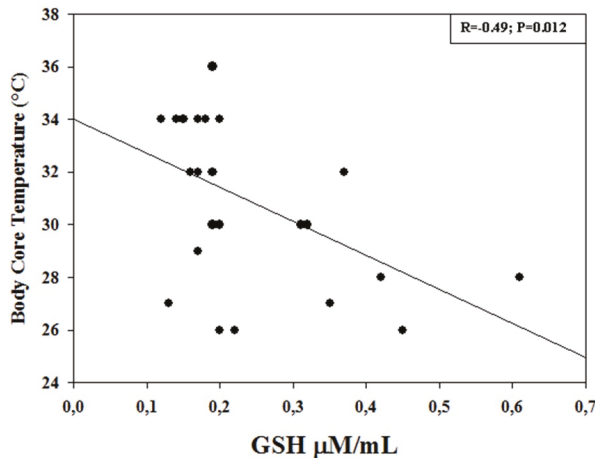


Figure 3. Correlation between GSH concentrations ($\mu\text{M}/\text{mL}$) measured at the end of cardiopulmonary bypass (CPB) procedure and body core temperature ($^{\circ}\text{C}$) during CPB. There was a significant negative correlation ($R = -0.49$; $p = 0.012$).

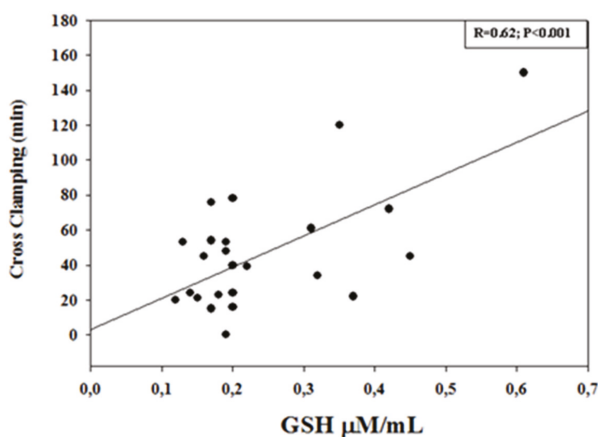


Figure 4. Correlation between GSH concentrations ($\mu\text{M/mL}$) measured at the end of cardiopulmonary bypass (CPB) procedure and cross-clamping duration (min). There was a significant positive correlation ($R = 0.62$; $p < 0.001$).

Moreover, an identical pattern was found when PaO_2/GSH was correlated with CPB duration ($R = 0.56$; $p = 0.004$), with cross-clamping ($R = 0.51$, $p < 0.010$), and with body core temperature ($R = 0.68$; $p < 0.001$).

4. Discussion

It is widely known that congenital heart diseases are the most frequent malformations, affecting 1–20 infants in 1000 live births [1]. According to CHD characteristics, they may account for up to 15% of mortality, as well as about 4.8% of short-term and 40–50% of long-term developmental abnormalities at school age [1,20,21]. However, there are still no conclusive clinical, laboratory, or monitoring parameters able to provide useful information on perioperative stress [22–25]. In this setting, open-heart surgery and CPB are commonly accepted to cause harmful effects on whole body organs. Vascular resistance impairment, intra/postoperative hypoperfusion leading to ischemia reperfusion injury, and systemic inflammation are known to enhance an oxidative stress reaction in the perioperative period [26].

In the present study, we found that the blood levels of a well-established marker of oxidative stress, namely GSH, significantly increased during surgical procedure by CPB, remaining constantly elevated up to 24 h after surgery. Furthermore, GSH levels measured at the end of the CPB procedure positively correlated with CPB, cross-clamp duration, and PaO_2 , whereas a negative correlation was observed with body core temperature. These results are, in part, in agreement with previous observations in adults and in children [15,27], showing increased GSH levels in the postoperative period and in the different CPB phases. Discrepancies are in relation to the different monitoring time points, CPB procedure, and patient recruitment [15].

The finding of elevated GSH levels in the perioperative period warrants further consideration. In particular, increased GSH levels during CPB procedure are (1) related to enhanced oxidative damage due to hypoxia or hyperoxia insults during CPB itself [2]; (2) correlated with the complexity of surgical procedures, especially in those cases requiring DHCA [23]; (3) temperature-dependent due to changes in the oxygen–hemoglobin dissociation curve, enhancing hemoglobin affinity for oxygen with an increase in reduced/oxidized glutathione ratio [28]; and, (4) related to the use of hyperoxic anesthesia that stimulates the production of reactive nitrogen and oxygen species (RNOS) by neutrophils and mitochondria [29].

Altogether, it is reasonable to conclude that the increased release of GSH into systemic circulation in CHD children who had undergone open heart surgery can be considered as a compensatory

mechanism to oxidative damage. The fact is of relevance bearing in mind that GSH is implicated the most in the protection against oxidative injury in glia, astrocytes, and neurons [30]. The mechanism through which GSH exerts its antioxidant action is, at this stage, not fully elucidated. One explanation resides in hypoxia or hyperoxia insults able to trigger the cellular GSH content, increasing the effect of N-acetylcysteine on repletion of GSH and further increasing key enzyme activities that regulate GSH production, glutamate cysteine ligase, and glutathione synthase [31,32]. In this light, it is reasonable to suggest that high GSH levels in blood may be the expression of a cascade of events affecting the glutathione/glutathione-oxidized ratio, which is hypoxia or hyperoxia mediated. Of note, high GSH levels in systemic circulation enhance its antioxidant capacity, thus reducing the proteins' defense mechanisms by oxidative damage. Another explanation resides in therapeutic strategies performed in the perioperative period such as transfusions (red blood cells, platelets), which contribute to redox imbalance being an important source of RNS [33,34]. Finally, the possibility that therapeutic strategies such as anesthesia and fluid balance management can somewhat affect GSH levels must be taken into account. The fact is of relevance bearing in mind that (i) perioperative therapeutic strategies performed did not contain any thiol group, and (ii) fluid management was not responsible for any hemodilution/concentration phenomenon. Since no significant differences in Hb and Ht rate were observed at monitoring time points, these findings argue against the hypothesis.

In the present study, we also found that GSH increases in the perioperative period as PaO₂ peaks. Therefore, in order to limit the potential influence of oxygenation on GSH levels, we calculated the PaO₂/GSH ratio. The PaO₂/GSH ratio pattern increased during surgery up to the end of the procedure when it started to decrease, being superimposable to preoperative levels. The PaO₂/GSH ratio showed a positive correlation with CPB duration, cross-clamping, and body core temperature.

The finding of a correlation between GSH and PaO₂ deserves further consideration. In particular, increased GSH has shown the following: (i) in animal models, controlled normoxic reoxygenation limited brain injury [35]; (ii) in CHD children, lipid peroxidation increased and antioxidant reserve capacity decreased, being maintained by endogenous radical scavengers such as GSH [35–40]; and (iii) during CPB, increased oxygen toxicity affected endothelial permeability [2,35]. Altogether, it is reasonable to suggest that the higher GSH levels occurring during systemic reoxygenation in CHD children may be indicative of a compensatory mechanism due to CPB and hyperoxia-mediated stress.

Lastly, we found that the PaO₂/GSH ratio was superimposable to the one detected at the preoperative time point. The explanation may reside in the decay of PaO₂ levels at 24 h after surgery and explained by the short half-life of GSH (about 10 min) [41].

Finally, the present study shows some limitations. The main ones reside in the small population studied that did not allow to correct for the occurrence of cyanotic and non-cyanotic CHD and in the lack of an expanded oxidative stress evaluation with other biomarkers such as glutathione disulfide, non-protein bind iron and lipid hydroperoxides. Further studies in this regard are awaited.

In conclusion, the present data on elevated GSH levels, in CHD children undergoing open heart surgery and CPB, suggest that caution is needed in controlling different CPB phases such as DHCA, core body temperature, and systemic reoxygenation in a population that is per se more prone to CNS stress or damage. The findings may lead to further investigation to detect the “optimal” temperature and PaO₂ target [40] by monitoring biomarkers as much as possible to avoid perioperative CNS stress or damage.

An Easy and Reliable Strategy for Making Type I Interferon Signature Analysis Comparable among Research Centers

Abstract: Interferon-stimulated genes (ISGs) are a set of genes whose transcription is induced by interferon (IFN). The measure of the expression of ISGs enables calculating an IFN score, which gives an indirect estimate of the exposition of cells to IFN-mediated inflammation. The measure of the IFN score is proposed for the screening of monogenic interferonopathies, like the Aicardi-Goutières syndrome, or to stratify subjects with systemic lupus erythematosus to receive IFN-targeted treatments. Apart from these scenarios, there is no agreement on the diagnostic value of the score in distinguishing IFN-related disorders from diseases dominated by other types of cytokines. Since the IFN score is currently measured in several research hospitals, merging experiences could help define the potential of scoring IFN inflammation in clinical practice. However, the IFN score calculated at different laboratories may be hardly comparable due to the distinct sets of IFN-stimulated genes assessed and to different controls used for data normalization. We developed a reliable approach to minimize the inter-laboratory variability, thereby providing shared strategies for the IFN signature analysis and allowing different centers to compare data and merge their experiences.

Keywords: interferon signature score; inter-laboratory variability; data sharing; systemic lupus erythematosus; interferonopathies; biostatistics

1. Introduction

Type I interferon (IFN) production is part of the innate immune response to viruses or intracellular bacteria, which is triggered by the sensing of pathogen-associated nucleic acids [1]. Even though the identification of IFNs dates back to the 50s–60s [2], the description of a group of mendelian disorders with dysregulated IFN-mediated inflammation has only recently shed light on the fine regulation of the production and action of these cytokines [3]. Of note, this new group of disorders, known as type I interferonopathies, displays significant phenotypic overlaps with both systemic lupus erythematosus (SLE) and congenital viral infections of the TORCH (Toxoplasmosis, Rubella, Cytomegalovirus, Herpes simplex) and HIV (human immunodeficiency virus) groups [3,4].

Type I interferonopathies are marked by the hyper-expression of a set of genes (IFN-stimulated genes, ISGs) in inflamed tissue and often in peripheral blood, leading to the definition of the so-called “IFN signature” [5,6]. The IFN signature was firstly defined in subjects with SLE to assess the level of IFN related inflammation and to help stratify patients to receive IFN targeted treatments [7–9].

Since then, the measure of expression of the ISGs (IFN signature analysis) is increasingly used in biomedical research centers, as well as for the functional classification of other conditions characterized by a type I IFN dysregulation [10], to distinguish such conditions from classical inflammatory disorders predominantly mediated by other cytokines, like Tumor Necrosis Factor α and Interleukin 1 (i.e., inflammatory bowel diseases, rheumatoid arthritis, and periodic fevers) [11].

Different ISG sets were identified to evaluate interferon-mediated autoinflammation and are frequently restricted to 5-6 targeted genes [6,10,12,13], suitable, for example, for the discrimination of Aicardi-Goutières syndrome (AGS) [6,10]. However, IFN signature analysis could be extended to larger gene lists [7] or even restricted to just one single gene, particularly when directly assessed in affected tissues, as in the case of dermatomyositis [14–16].

Even though the IFN signature measure has become widely available at research hospitals, there is no consensus for the selection of calibration controls. Thus, it is hard to compare data among distinct centers and to estimate the potential of IFN signature testing for discriminating among inflammatory conditions in the clinical practice. For example, thousands of subjects with antiphospholipid syndrome have been described in multicenter studies [17], while the interferon score has been separately studied in several small series without allowing the merging of results [18–22].

The main problem hindering the use of IFN signature analysis for *in vitro* diagnostics is the expression of data relativized to independent healthy control(s) in each laboratory, leading to unpredictable inter-laboratory variability. It is logical to assume that the use of pooled cDNA from healthy donors can represent a convenient strategy for calibrating Real Time quantitative PCR (qPCR) for the assessment of the IFN score. However, it can be difficult to predict the optimal number of samples to be pooled, which requires minimizing variability between one pool and another prepared at distinct laboratories, as already pointed out by others [23,24].

This study aims to investigate, through laboratory, bioinformatic, and statistical analyses, a reliable approach to minimize the variability that can be observed in inter-laboratory assays.

The final goal is providing shared recommendations for IFN signature analysis and interpretation of data in the clinical practice, thereby allowing data sharing among reference centers and improving knowledge on IFN-related disorders.

2. Materials and Methods

The study is part of the IRCCS Burlo Garofolo project RC #24/2017, approved by the Institutional Review Board and by the Friuli Venezia Giulia Independent Ethical Committee (2018-SPER-079-BURLO, N. 0039851, approved on 12 December 2018). All investigations were performed after obtaining written informed consent from volunteers and patients or their parents/guardians.

2.1. Subjects

On wet IFN signature analysis was assessed by quantitative PCR (qPCR) in ten young-aged healthy subjects (Dataset A, ten out of eleven individuals, five males and five females).

To establish whether data from qPCR and RNAseq analysis were comparable, IFN signature on wet (by qPCR) and *in silico* (by RNAseq) analysis was performed in twenty subjects with inflammatory diseases, such as systemic lupus erythematosus (SLE), interferonopathies or inflammatory bowel diseases (IBD), and patients' relatives, recruited at our center (Dataset E). A brief description of patients' clinical diagnosis is displayed in Table S1.

To increase healthy donors numerosity, *in silico* IFN signature investigation (by RNAseq) has been performed in twenty healthy individuals, collected at our center Dataset A (four out of eleven individuals), and selected from different whole blood RNA-sequencing (RNAseq) open-access web-based datasets: we sorted another three datasets, while considering exclusively healthy control samples, accessible at ArrayExpress (accession number E-MTAB-5735, Dataset B, five individuals) and at the Gene Expression Omnibus (GEO) (accession number GSE112057, Dataset C, nine individuals; GSE90081, Dataset D, two individuals). Specification about gender was not available for all the

samples. However, sex has been easily inferred by expression analysis of the sex-specific genes *RPS4Y1* and *USP9Y*.

The dataset composition is shown in Table 1.

2.2. Sample Collection, RNA Isolation and cDNA Preparation

Peripheral blood was collected in PAXgene Blood RNA Tubes (PreAnalytiX, Hombrechtikon, Switzerland) and, after two-hours incubation at room temperature, tubes were frozen at $-20\text{ }^{\circ}\text{C}$ until processing. Total RNA was extracted with PAXgene Blood RNA Kit (PreAnalytiX, Switzerland), following the manufacturer’s instructions, and quantified with NanoDrop Spectrophotometer (Thermo Fisher, Waltham, MA, USA). RNA integrity was checked using an Agilent Technologies 2100 Bioanalyzer.

Up to 1 μg of total RNA was retro-transcribed using SensiFAST cDNA Synthesis Kit (Biolone, London, UK).

2.3. IFN Signature Analysis

The expression of six IFN-stimulated genes was assessed by qPCR using AB 7500 Real Time PCR System (Applied Biosystems, Waltham, MA, USA), TaqMan Gene Expression Master Mix (Applied Biosystems, USA) and UPL Probes (Roche, Basel, Switzerland) for *IFI27*, *IFI44L*, *IFIT1*, *ISG15*, *RSAD2*, and *SIGLEC1*. Using AB 7500 Real Time PCR software, each target quantity was normalized with the expression level of *HPRT1* and *G6PD*, and the relative quantification (RQ) was conducted relating to a “calibrator” sample (mix of ten healthy controls, Dataset A) using the $2^{-\Delta\Delta\text{Ct}}$ method [25]. The median fold change of the six genes was used to calculate the IFN score for each patient.

2.4. RNAseq Analysis

Transcriptome sequencing was performed using the TruSeq Stranded mRNA Sample Preparation kit (Illumina, San Diego, CA, USA) and sequenced on a NovaSeq 6000 platform (Illumina, San Diego, CA, USA), generating 2X100 bp paired-end reads (30 million reads per sample) in twenty subjects from Dataset E (patients and patients’ relatives) and four out of eleven controls from Dataset A.

RNAseq raw data (either our data and open-access web-based data) workflow was conducted as follows: quality control by FastQC (<https://www.bioinformatics.babraham.ac.uk/projects/fastqc/>), quality filtering by Trim Galore (https://www.bioinformatics.babraham.ac.uk/projects/trim_galore/),

read alignment to hg38 using annotation from GENECODE v.31 (<https://www.gencodegenes.org/>) with STAR [26], reads counting into genes by featureCounts [27].

Data of patients with autoinflammatory diseases and three healthy individuals of our dataset were normalized and analyzed for differentially expressed genes by DESeq2 [28]. From the result table, we only considered the ISGs and evaluated their relative fold changes on each patient compared to the set of controls.

To assess the ISGs expression variability within the group of twenty healthy subjects, shortlisted from the datasets described above, we determined the expression values for each gene, normalized by Fragments Per Kilobase per Million mapped reads (FPKM) method with edgeR (*rpkm* function) [29,30], using the values from the “Length” column, in the featureCounts’ output, for the calculation.

Principal component analysis (PCA), useful for data visualization, was conducted with DESeq2, to define the overall variability between samples.

2.5. Statistical Analyses

Considering that each of the six genes measured was expressed on a different scale, we decided to calculate the sample size based on the coefficient of variation, instead than the mean and the standard deviation. We further hypothesized that different runs did not increase the variation in comparing the samples, assuming the only origin of variability to be represented by the subjects’ heterogeneity.

To determine the statistical power for data obtained by qPCR and RNAseq, we computed the noncentrality parameter (λ) using GPower 3.1.9.2. software [31,32], with a generic two-tailed *t*-test, given $\alpha = 0.05$, $\beta = 0.2$, and degrees of freedom equal $N-1$. If the noncentrality parameter under these conditions (reference value, “ λ_{ref} ”) resulted in being lower than the one calculated on our samples, we considered the sample size as appropriate.

GraphPad Prism 6 software was employed for χ^2 contingency analysis; *p*-values <0.05 were considered significant.

To identify the appropriate sample size for variability assessment, we computed λ for increasing numerosity (up to forty) using GPower 3.1.9.2. (Heinrich-Heine University Düsseldorf, Germany), and determined a “plateau value” by an exponential decay function (GraphPad Prism 6 software, La Jolla California USA).

3. Results

3.1. Variability Assessment in IFN-Stimulated Genes Expression in Healthy Controls (Dataset A) Analyzed by qPCR

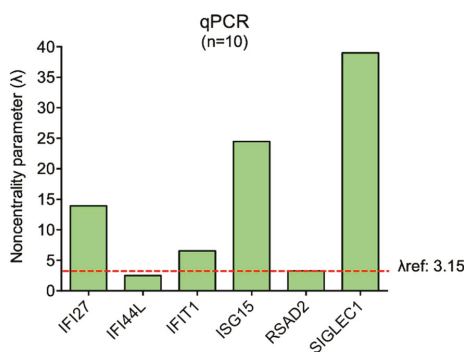


Figure 1. Graphical representation of the noncentrality parameter (λ) calculated for each ISG by on wet qPCR analysis. The λ_{ref} for ten subjects is displayed by the dashed line and reported in the figure. Sample size is considered as appropriate when λ computed on each gene is higher than λ_{ref} .

The variability of expression of the six ISGs (*IFI27*, *IFI44L*, *IFIT1*, *ISG15*, *RSAD2*, *SIGLEC1*) was assessed in ten healthy controls processed by on wet qPCR analysis. Five out of six genes showed low variability coefficients and noncentrality parameters (λ) that fulfilled the analysis criteria (as described in Materials and Methods, Section 2.5) (Table 2). Only *IFI44L* did not comply with the analysis parameters, presenting higher variability and a lower λ than the reference value (λ_{ref}) (Figure 1)

Thus, ten healthy controls could not be considered an appropriate sample size to represent an ideal healthy population, in which the physiologically floating expression values of the ISGs present acceptable variability. For this reason, we should increase the numerosity of healthy controls to obtain a suitable pool in which the gene expression variability is minimized.

3.2. IFN-Stimulated Genes Expression Evaluated by qPCR or RNAseq Analysis Are Comparable

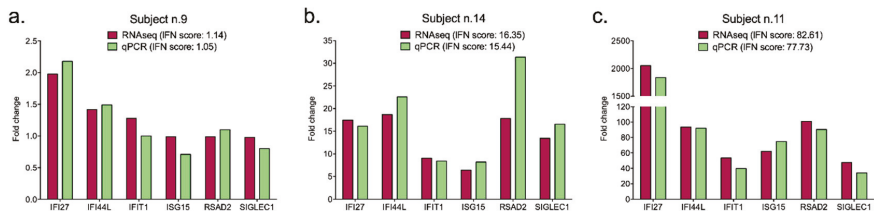
To improve the power of the variability measurement, we decided to take advantage of RNAseq open-access web-based data, as an easy source to increase the number of healthy subjects to calculate ISGs interindividual differences. This choice came from comparisons between the relative ISGs fold change assessed in the same twenty subjects (Dataset E) by both qPCR and RNAseq analysis, selecting the same set of three out of eleven healthy controls from Dataset A, to normalize data for both techniques.

Some subjects showed different relative expression values for the same gene calculated by on wet qPCR and in silico RNAseq, but the overall results of the IFN signatures (IFN scores) were extremely consistent between the two techniques for each individual (χ^2 contingency analysis p -value = 0.405, not significant). The comparability of IFN scores is easily explained, considering that these values represent the median of the six relative ISGs quantifications, and they broadly reflect the overexpression status in the analyzed sample (Table 3). Thus, the two methods provided the same trend in gene expression in subjects presenting low, intermediate, and high IFN signatures, as indicated by the three representative graphs in Figure 2 (Subject n.9: low IFN signature; Subject n.14: intermediate IFN signature; Subject n.11: high IFN signature).

3.3. Preliminary Analysis for Sample Selection and Variability Assessment in IFN-Stimulated Genes Expression Analyzed by RNAseq

Given the comparability of data between qPCR and RNAseq, we exploited the availability of large open-access web repositories containing RNAseq data to calculate the proper sample size for the assessment of the IFN score with an acceptable inter-laboratory variability.

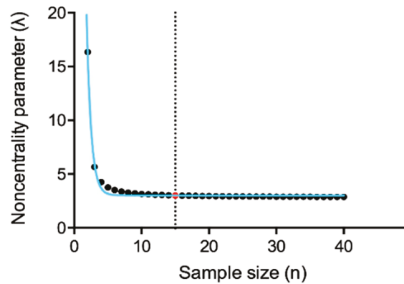


Figure 3. Plateau value (reported as a red dot) threshold (reported as a dotted vertical line) of λ computed for sample sizes up to forty subjects. Each sample size is represented by a black dot. In blue the exponential decay function curve of the previously computed λ .

To select the appropriate sample size, we firstly calculated the noncentrality parameter (λ) on a numerosity up to forty individuals using GPower software. Then, we determine the plateau value of the exponential decay function of the previously computed λ values. The provided plateau (3.01) corresponds to λ for sample size $n = 15$ (Figure 3), leading us to consider fifteen subjects as an appropriate sample size. For more experimental strength, we considered both $n = 15$ and $n = 20$ in

the following analyses. We did not further increase the sample size over twenty subjects, whereas exceeding this number might bring difficulties in term of donors' collection.

We performed a principal component analysis (PCA), a data visualization analysis, to evaluate the total expression variation of the six ISGs and to define the most homogeneous set of twenty healthy individuals. This investigation allows the detection of possible rare outliers with the highest variance that might not be considered as suitable controls to study IFN signature.

RNAseq records have been chosen considering the presence of similar features such as blood collection type, RNA extraction protocol and library selection, to reduce as much as possible the technical procedure variability (Table 3).

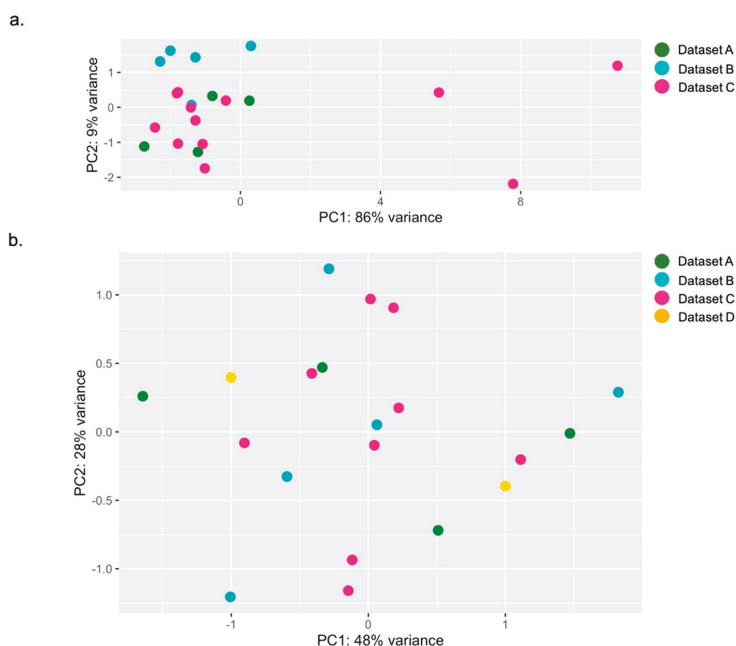


Figure 4. Overall ISGs expression variance between individuals. PCA of the first selection (a), with evidence of the three outliers from Dataset C, and of the final twenty-controls-sized group (b), showing twenty samples uniformly distributed (4 from Dataset A, 5 from Dataset B, 9 from Dataset C and 2 from Dataset D).

As a first attempt, we investigated all the RNAseq samples of healthy donors from Dataset A (data from our center, $n = 4/11$), Dataset B (E-MTAB-5735, $n = 5$) and Dataset C (GSE112057, $n = 12$), twenty-one specimens in total. Figure 4a displays the PCA results showing the overall ISGs expression variability between individuals. The analysis exhibited a higher variance in three out of twenty-one subjects: we thus decided not to include these three samples in further studies, collecting eighteen samples that were suitable for our purpose. To get the proper numerosity ($n = 20$), we examine Dataset D (GSE90081, $n = 12$) and we ran the same analysis again, obtaining a satisfactory level of variation, without outliers, between datasets and among individuals. From these preliminary observations, we randomly chose two out of twelve samples from Dataset D, combining them with data previously selected. Again, we observed an acceptable gene expression variability among our final twenty-controls-sized group (Table 4), as shown in Figure 4b.

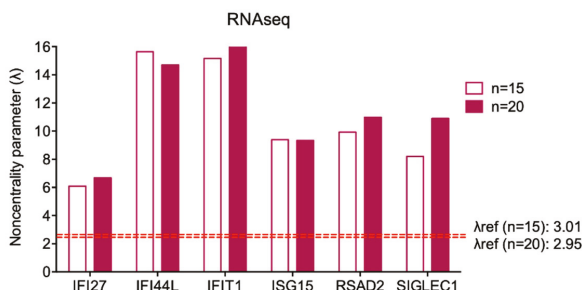


Figure 5. Graphical representation of λ calculated for each ISG by in silico RNAseq analysis. The λ_{ref} s for fifteen and twenty subjects are displayed by the red dashed line and reported in the figure. Sample size is considered appropriate when λ computed on each gene is higher than λ_{ref} .

We calculated the λ ref for larger samples of healthy controls (fifteen and twenty subjects) using GPower software, and the variability of the ISGs expression in fifteen and twenty healthy controls processed by in silico RNAseq analysis. Table 5 shows that all the variability coefficients are considerably low and all λ calculated fulfilled the analysis parameters (Figure 5) (expression values of single gene for

each control are displayed in Table S2. Thus, we can hypothesize that pooling together samples from fifteen or twenty healthy subjects could also be considered a proper sample size in qPCR analyses.

3.4. Pooling Twenty Subjects Could Be Considered an Optimal Strategy to Minimize Gene Expression Variability among Healthy Controls for on Wet IFN Signature Analysis

We checked whether the values of mean, SD and variability coefficient obtained by on wet qPCR on ten controls met the λ criteria considering $n = 15$ and $n = 20$ subjects as already calculated, assuming that the variability coefficient does not change as the sample size increases (Table 6).

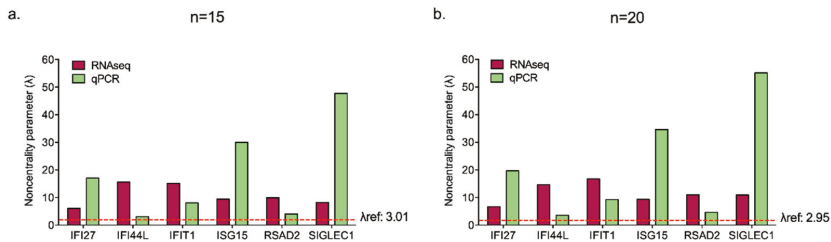


Figure 6. Graphical representation of λ calculated for each ISG by in silico RNAseq analysis and hypothesized qPCR assessment considering fifteen (a) and twenty (b) subjects. The λ_{ref} values are displayed by the red dashed line and reported in the figure. Sample size is considered appropriate when λ computed on each gene is higher than λ_{ref} .

The analysis provides quite good results for both sample sizes tested, even if *IFI44L* showed a λ (3.08) very close to λ_{ref} (3.01). For this reason, we can consider more adequate to increase the numerosity to twenty subjects, a still easy-to-gather number of healthy donors. Thus, we could assert that twenty healthy controls could be considered a suitable sample size for IFN signature analysis performed by qPCR, as predicted by in silico RNAseq (Figure 6).

4. Discussion

The clinical employment of the IFN signature is strictly related to the screening of pathological conditions characterized by type I IFN dysregulation [24]. However, several studies have been carried out to associate the IFN-related inflammation with specific clinical or laboratory features of rheumatologic conditions, like systemic lupus erythematosus, primary antiphospholipid syndrome, Sjögren syndrome, rheumatoid arthritis, autoimmune myositis and systemic sclerosis [18,20,33–38]. Some Authors proposed that the assessment of IFN inflammation may help identify subgroups of patients with a better response to specific treatments, as B cell targeted therapies [39–42]. Moreover, since most anti-inflammatory or immunomodulatory agents have only a weak effect on IFN inflammation, the calculation of the IFN score may also serve to guide targeted therapy approaches with novel drugs like Janus Kinase inhibitors [10].

However, there is no consensus on a shared and validated method to classify different inflammatory conditions by transcriptome analysis. Crow and collaborators used pooled cDNA from healthy donors as calibrator for qPCR, and after assessing a large number of healthy controls and patients with Aicardi-Goutières Syndrome calculated a fixed cut-off value of normality suitable for the screening of interferonopathies [6]. However, this cut-off has been validated to facilitate the detection of monogenic

interferonopathies and not to assess IFN inflammation in other conditions. Moreover, the reference to locally pooled control cDNA may make it difficult to compare results obtained in distinct centers.

Even though multiple ISG panels have been described either in peripheral blood cells or affected tissues, many laboratories set their assays by analyzing a minimal set of 5-6 targeted-genes, usually including the set proposed by Crow et al. This set has been applied to thousands of analyses and its potential for screening of monogenic interferonopathies is established. After the normalization of results on at least two housekeeping genes, the main source of variability limiting interlaboratory comparison of data consists in the use of different controls for data normalization. Indeed, this is a remarkable problem, considering that the potential role of IFN signature analysis in clinical practice can be defined only by sharing data among research centers, comparing or merging case series. Of course, the best option for the future should rely on the development of industrially manufactured kits validated for In Vitro Diagnostics (IVD) and usable worldwide with the same reference values, not only in the most advanced research areas. Conversely, only the analysis and comparison of data available at various centers can tell industries whether the development of such diagnostic kits is worthwhile or not. Thus, we focused on a strategy that could be immediately applied in biomedical laboratories to facilitate the sharing of experience and minimize the inter-laboratory variability.

We investigated if using a pool of biological samples from healthy controls could solve the data normalization issue, which is the main source of inter-laboratory variability. We proposed that this strategy could “equalize” the differences in gene expression that physiologically occur among individuals.

For this purpose, we evaluated if any pool of healthy controls more than a given number n of subjects could be suitable to level differences, through an approach based on laboratory (qPCR), bioinformatic (RNAseq), and statistical data integration analyses.

Starting from the ISGs expression assessment in peripheral blood from ten healthy subjects by on wet qPCR analysis, we found that this sample size is not suitable for equalizing the variable expression levels of all the six ISGs in healthy volunteers. To find the appropriate number of samples to be pooled together with low enough variability, we further investigated if public data from RNAseq can be exploited to expand our analysis. We thus compared relative ISGs fold change values calculated by qPCR and RNAseq analysis for the same subjects with the same calibrator, showing that the two methods yield comparable results with very low variability between each other. Previous studies compared gene expression measurements generated by *in silico* RNAseq and on wet qPCR assays, showing consistent results between the two methods for most genes, with the only exception of some genes generally characterized by small size and low expression levels. None of the ISGs is included in the list of genes with inconsistent estimation of expression according to the Authors [43]. Our results confirmed that RNAseq and qPCR generate consistent results in the assessment of ISGs expression levels. Thus, based on the literature and on our preliminary results, we considered RNAseq as a good asset to increase the number of healthy subjects on which to calculate interindividual differences in ISGs expression, exploiting both RNAseq samples available at our center and open-access web-based data.

The results of our study support the choice of pooling twenty healthy controls for the normalization of the assay, allowing to express results as relative to a “standard set of controls”. Of note, we validated this sample size only for the selected set of six ISGs in peripheral blood cells. The expression of other genes included in larger panels, may present higher variability among donors and between different affected tissues. However, the same procedure that we have described can also be used to define the optimal sample size for other transcription profiles, for interferonopathies or for other rheumatologic disorders. The performance of the proposed twenty-controls-sized standard could be improved by analyzing all the donors separately before pooling, and by performing cluster variance analysis, which can enable excluding rare donors with outlier variance.

The HD-OCT Study May Be Useful in Searching for Markers of Preclinical Stage of Diabetic Retinopathy in Patients with Type 1 Diabetes

Abstract: The aim of the study was to analyze the thickness of individual retinal layers in patients with type 1 diabetes (T1D) in comparison to the control group and in relation to markers of diabetes metabolic control. The study group consisted of 111 patients with an average of 6-years of T1D duration. The control group included 36 gender- and age-matched individuals. In all patients optical coherence tomography (OCT) study was performed using HD-OCT Cirrus 5000 with evaluation of optic nerve head (ONH) parameters, thickness of retinal nerve fiber layer (RNFL) with its quadrants, macular full-thickness parameters, ganglion cells with inner plexus layer (GCIPL) and choroidal thickness (CT). Lower disc area value was observed in the study group as compared to controls ($p = 0.0215$). Negative correlations were found both between age at examination and rim area ($R = -0.28$, $p = 0.0007$) and between superior RNFL thickness and duration of diabetes ($R = -0.20$, $p = 0.0336$). Positive correlation between center thickness and SD for average glycemia ($R = 0.30$, $p = 0.0071$) was noted. Temporal CT correlated positively with age at examination ($R = 0.21$, $p = 0.0127$). The selected parameters the HD-OCT study may in the future serve as potential markers of preclinical phase of DR in patients with T1D.

1. Introduction

Type 1 diabetes (T1D) is one of the most common metabolic diseases diagnosed in children and is associated with the risk of development of numerous chronic complications. Diabetic eye disease—as the most common of the chronic complications of T1D—may be connected with abnormalities in various eye structures. However, the complication related to the greatest risk of loss of vision is diabetic retinopathy (DR) and accompanying diabetic macular edema (DME) [1,2]. DR is considered to be the earliest chronic complication of type 1 diabetes because it is present even after several years of its course [3]. The development and progression of diabetic retinopathy is influenced mainly by the degree of metabolic diabetes control, diabetes duration, presence of dyslipidemia, proteinuria, arterial hypertension, pregnancy and genetic predisposition [4]. Many studies have shown that proper control of glycemia, blood pressure and lipid levels may reduce the risk of DR development and significantly slow its progression [5].

Currently, fluorescein angiography (FA) remains the gold standard in the diagnosis of clinical phase of diabetic retinopathy, which enables detailed assessment of blood vessels of the fundus of the eye as an invasive method [6]. FA is a test that involves taking a series of photographs of the fundus after intravenous administration of a contrast agent (fluorescein). FA enables visualization of the circulation in the retinal vessels and indirectly the uvea, as well as evaluation of the state of the retinal pigment epithelium and retinal blood vessels which are not visible during fundus examination. This technique has become fundamental when assessing the complications of diabetic retinopathy, retinal vascular obstruction, or when diagnosing many macular diseases. However, FA is associated with severe potential risks [7].

Thus, in an attempt to optimize diagnostic procedures, the most informative and least invasive diagnostic method should be identified. Optical coherence tomography (OCT) is a safe, non-contact, non-invasive and effective technique of imaging tissue and could be considered as a valid alternative to FA. Intra-retinal leakage is not necessary to confirm the presence of DME, and FA is useful only as a guide for focal or grid laser treatment of thickened areas. Therefore, numerous new diagnostic tools such as high-definition OCT (HD-OCT) and spectral-domain (SD) OCT are being evaluated clinically. These methods provide improved capabilities for the imaging of the intra-retinal morphology and/or allow for the analysis of the structural and functional aspects of leakage activity. Moreover, they offer realistic 3D imaging of retinal and subretinal levels in various diseases [8]. Cirrus HD-OCT (Carl Zeiss Meditec, Inc., Dublin, OH, USA) is an SD-OCT that has an axial resolution of 5 μm and a scan velocity of 27,000 axial scans per second. These features improve the ability to visualize smaller and thinner structures that are difficult to visualize with time-domain OCT (Stratus OCT).

Therefore, alternative imaging methods such as OCT study are suggested in patients, especially considering the new approach to pathologic mechanisms leading to DR development [9]. Until now, diabetic retinopathy has been considered to be a mainly vascular complication, however, it is now known that neurodegenerative processes take place in the retina before the clinical retinopathy, which is its preclinical period [5]. Recent publications have shown that these early symptoms of neuronal damage of the retinal layer are present before the appearance of changes visible at the fundus of the eye and may contribute to the development of microvascular abnormalities [10,11]. These reports also indicate a decrease in retinal thickness in diabetic patients, mainly in macular ganglion cells. This suggests progress in neurodegeneration as an early, preclinical stage of diabetic retinopathy [12,13].

In addition, it is known that previous attempts to treat diabetic retinopathy are being made in its clinical phase [14,15], whereas, from the patient's point of view, it would be worthwhile to try to stop the progress of retinal neurodegeneration at the earliest possible stage [16]. The lack of unambiguously defined early markers of DR preclinical phase leads to their search based on new and non-invasive imaging studies.

The aim of the study was to evaluate the thickness of retina in its individual layers in patients with type 1 diabetes as compared to the control group and in relation to the parameters of metabolic diabetes control.

2. Materials and Methods

The study was conducted in accordance with the Declaration of Helsinki, and the study protocol was approved by the University Bioethics Committee at the Medical University in Lodz, Poland (RNN/374/17/KE, 19/12/2017). Patients and/or their parents gave written informed consent for participation in the study.

The work described has been carried out in accordance with The Declaration of Helsinki of 1975 and revised in 2013 for experiments involving humans.

The study group consisted of 111 patients (F-61/M-50) including 82 children and 29 adults aged 5.6 to 50.8 (min-max) years at the time of study, with an average 6-year course of clinically overt T1D. In all patients, diabetes was diagnosed according to WHO criteria. The presence of autoantibodies

characteristic for T1D and decreased C-peptide plasma levels were observed in all patients at T1D onset. Detailed characteristics of the study group are shown in Table 1.

The control group consisted of 36 healthy (F-23/M-13) gender- ($p = 0.3466$) and age-matched ($p = 0.1688$) individuals with no glucose tolerance disturbances.

Patients under 5 years of age with diagnosed arterial hypertension, clinically manifest diabetic retinopathy, diabetic kidney disease and previous ocular surgery, any eye disease, myopia and hyperopia above 3 diopters, chronic use of topical medications were excluded from the study and control groups.

The HD-OCT study was performed in the patients from the study and control groups in the Department of Ophthalmology and Vision Rehabilitation of the Medical University of Lodz, Poland using the Cirrus HD-OCT device (5000: Carl Zeiss Meditec. Inc., Dublin, OH, USA) after mydriasis and evaluated independently by two experienced ophthalmologists.

Two scans, including one macular scan centered on the fovea (macular cube 512×128 protocol) and one peripapillary retinal nerve fiber layer (RNFL) scan centered on the optic disc (optic disc cube 200×200 protocol) were acquired through dilated pupils. The mean retinal thickness values were obtained on all images for foveal subfield and the inner and outer rings of a standard ETDRS (Early Treatment of Diabetic Retinopathy Study) grid. Macular ganglion cell layer/inner plexiform layer (GCIPL), RNFL (retinal nerve fiber layer) and optic nerve head (ONH) parameters were measured automatically using the internal ganglion cell, RNFL and ONH analysis algorithms, respectively. The following GCIPL thickness measurements were analyzed: Average, minimum and sectoral (superonasal, superior, superotemporal, inferotemporal, inferior and inferonasal). RNFL total thickness as well as superior, inferior, temporal and nasal RNFL thickness were evaluated. For the ONH analysis, the following parameters were included: Disc area, rim area, cup volume and cup-to-disc (c/d) ratio. Choroidal thickness (CT) was measured manually from the outer portion of the hyperreflective line corresponding to the retinal pigment epithelium to the inner surface of the sclera, using the Cirrus linear measurement tool (HD 21-line raster). To be included in this study, images had to be at least 6 of 10 in intensity and taken as close to the fovea as possible, by choosing to image the thinnest point of the macula, with the understanding that slight differences in positioning could affect the measured thickness. Choroidal thickness was measured at the fovea and 1-mm temporal and nasal to the fovea. Averages from measurements in both eyes were calculated and used for further analysis.

The HD-OCT results were related to individual parameters and indicators of clinical course of diabetes including: Age at the time of the study (years), gender, age at diabetes onset (years), duration of diabetes (years), average HbA1c from the last year preceding the study (%), average blood glucose (BG) level from 14 days before an examination (mg/dL), standard deviation (SD) for BG evaluating

the fluctuations in BG results from 14 days before an examination, BMI-Z-score and mean insulin uptake (U/kg).

HbA1c was determined by high-performance liquid chromatography (HPLC) using the Bio-Rad VARIANT™ Hemoglobin A1c Program (Bio-Rad Laboratories Inc., Hercules, CA, USA) with its values represented as percentages and in addition as mmol/mol according to IFCC (International Federation of Clinical Chemistry).

Statistical Analysis

The assessment of the normality of distribution was carried out using the Kolmogorov-Smirnov test and verified by the Shapiro-Wilk test. Comparisons of the HD-OCT variables between study and control groups were performed using a non-parametric Mann-Whitney's test. For the correlation analysis, a Spearman correlation test was used. Categorical variables were presented as numbers with appropriate percentages and continuous variables as medians with interquartile range (IQR). Results with p -values < 0.05 were considered as statistically significant. Analyses were performed using Statistica 13.1 PL software (Statsoft, Tulsa, OK, USA).

3. Results

The parameters of optic nerve head (ONH); thickness of retinal nerve fiber layer (RNFL) and its quadrants; average retinal thickness, central retinal thickness, total retinal volume; macular ganglion cell layer/inner plexiform layer (GCIPL) thickness; and choroidal thickness (CT) were compared between the study and control groups. A significantly lower disc area value was observed in the study group (Me 1.84 mm²; IQR 1.62–2.04) in comparison to the control group (Me 1.98 mm²; IQR 1.82–2.14, $p = 0.0215$) (Table 2). There were no statistically significant differences in other HD-OCT parameters between the studied groups (Table 2).

Then, in the study group the correlations between HD-OCT and individual parameters and markers of clinical course of diabetes were analyzed.

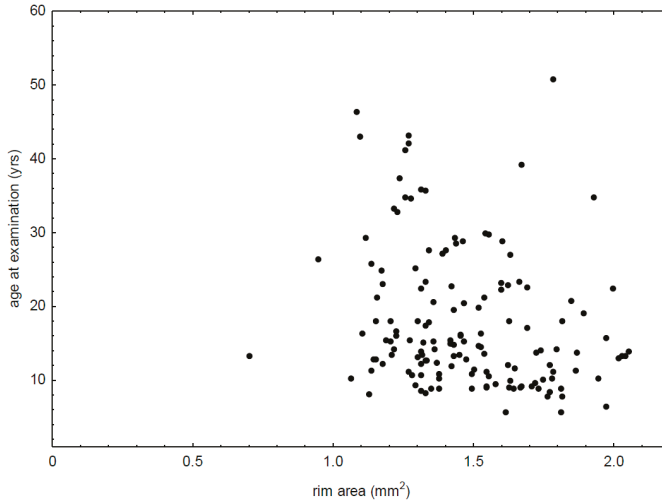


Figure 1. Correlation between rim area and age at examination in patients with type 1 diabetes ($R = -0.28, p = 0.0007$).

A negative correlation between rim area and age at the time of examination was observed ($R = -0.28, p = 0.0007$) (Figure 1). Moreover, the c/d ratio correlated positively with age of patients at the study time ($R = 0.17, p = 0.0449$). There was also a tendency to negative correlations between rim area and age at T1D onset ($R = -0.19, p = 0.0517$) and disc area and HbA1c value ($R = -0.17, p = 0.0843$).

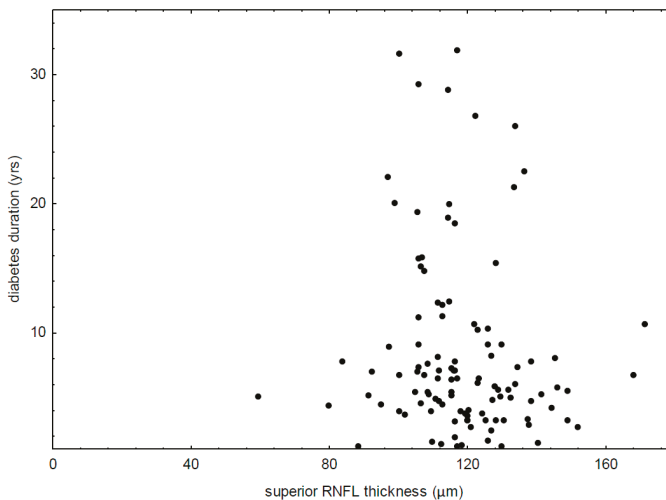


Figure 2. Correlation between thickness of superior retinal nerve fiber layer and duration of type 1 diabetes ($R = -0.20, p = 0.0336$).

In the study group, negative correlations between superior RNFL thickness and duration of diabetes ($R = -0.20, p = 0.0336$) (Figure 2) and between inferior RNFL thickness and HbA1c ($R = -0.20, p = 0.0364$) were also noted. There were positive correlations between macular center thickness and SD for average blood glucose level ($R = 0.30, p = 0.0071$).

The age of patients at the study time showed a trend to negative correlations with both average GCIPL thickness ($R = -0.15$, $p = 0.0706$) and GCIPL lower thickness ($R = -0.15$, $p = 0.0759$). A trend with respect to a negative correlation between GCIPL low-temporal thickness and HbA1c ($R = -0.18$, $p = 0.0696$) was also found.

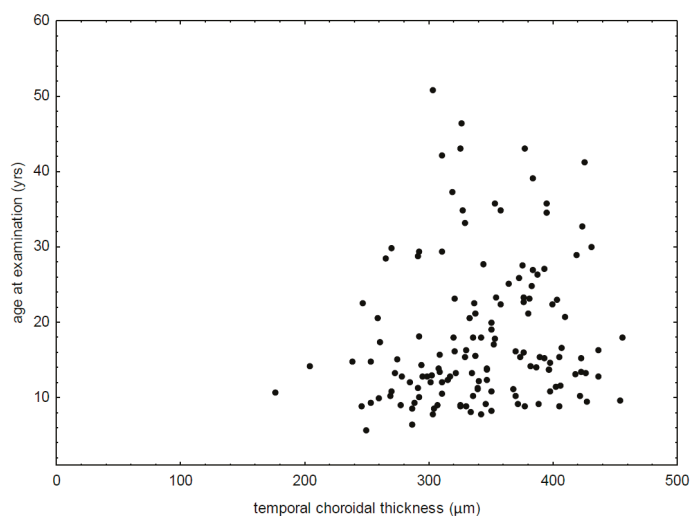


Figure 3. Correlation between temporal choroidal thickness and age at examination in patients with type 1 diabetes ($R = 0.21$, $p = 0.0127$).

It was also observed that temporal CT correlated positively both with age at the examination time ($R = 0.21$, $p = 0.0127$) (Figure 3) and age at diabetes diagnosis ($R = 0.22$, $p = 0.0255$). A positive correlation was also found between the subfoveal CT and the age at diabetes onset ($R = 0.23$, $p = 0.0189$), while a tendency to a positive correlation between the subfoveal CT and the age at examination ($R = 0.16$, $p = 0.0596$) was observed. Other parameters of clinical course of type 1 diabetes did not correlate with the HD-OCT parameters ($p > 0.1$).

4. Discussion

In the present study, for the first time such a large number of patients with type 1 diabetes, both children and young adults, were examined using the HD-OCT study.

A significant reduction of the disc area in the study group was observed in comparison to healthy controls. Moreover, in patients with T1D the selected ONH parameters correlated with their age. In previous studies, no differences in rim area, disc area or cup to disc ratio between pediatric patients with T1D and control group [17] were found. Only significant differences in c/d ratio were noted in patients with type 2 diabetes (T2D) without DR as compared to the control group [18]. In the studies, more binocular RNFL thickness asymmetry in diabetic patients in relation to the controls without significant differences in RNFL thickness [17,18] was also noted.

In our study, negative correlations in the study group between superior RNFL thickness and duration of diabetes, and between inferior RNFL thickness and mean HbA1c value were observed. Similar to our results, Tekin et al. noticed negative correlations between both global RNFL thickness and macular thickness and HbA1c value and diabetes duration using the SD-OCT study in children with T1D without clinical overt DR. They also found significantly thinner global RNFL thickness as well as temporal and inferior outer macular thickness in relation to the controls [19]. Both overall and superior RNFL thickness correlated with the age of T1D patients in the Dehghani et al. study, at the same time being an indicator of peripheral neuropathy in the patients [20]. In other research, the significant thinning of RNFL and its individual quadrants was confirmed in T2D patients without retinopathy

in comparison to the controls [21]. Furthermore, there are also studies in which RNFL thinning was found to correlate with the severity of retinopathy, but it was found also in T2D patients [22]. Interestingly, early structural damage of neuroretina was also related to glucose fluctuations assessed in continuous glucose monitoring (CGM) in the group of T1D patients [23]. In our study, to evaluate glucose variability, the SD for the average blood glucose (BG) level was measured within the two weeks prior to the HD-OCT study. However, it correlated positively only with macular center thickness confirming earlier reports of the effect of glucose fluctuations on the DR presence accompanied by DME [24,25].

In the present study, no differences were found between the groups with respect to other macular full-thickness parameters or GCIPL thickness. Only tendencies to correlation of average GCIPL and lower GCIPL thickness with age and HbA1c were observed. In several studies, however, a reduced GCIPL thickness was found in both pediatric T1D patients and adults with T2D without retinopathy, suggesting that the presence of chronic hyperglycemia may have an early neurodegenerative effect on retinal ganglion cells, even when vascular disorders are not yet present [26,27].

Previous studies on DR pathogenesis have shown that neuronal dysfunction and progressive neurodegeneration are closely correlated with microvascular disorders. According to many authors, the best method to prevent the appearance of diabetic eye disease is correct glycemetic control, reducing the risk of developing microvascular complications [28]. However, it seems that local hyperperfusion may be present already at the preclinical stage of DR and may accompany the neurodegeneration progress. In the paper by Golebiewska et al. it was noted that—besides the presence of early neuroretinal lesions—the central choroidal thickness tends to be thicker in T1D children without DR in comparison to healthy children and shows a correlation with gender of the subjects in favor of girls. However, it does not correlate with the duration of diabetes or HbA1c [29]. In our study we did not observe a relationship between CT and the gender, but with the age of the subjects. Moreover, positive correlations between subfoveal and temporal parts of CT with the age of patients were found, both at the time of examination and at the time of diabetes diagnosis.

The Niestrata-Ortiz et al. study carried out in the group of children with type 1 diabetes compared to the age-matched control group also revealed that choroidal thickness is higher in patients with T1D compared to the control group, and increases with the duration of diabetes, which makes it useful for screening in children with type 1 diabetes [30].

Concluding, the results obtained in the group of children and young adults with type 1 diabetes indicate a relationship between age of patients, duration of diabetes, chronic hyperglycemia, glycemia fluctuations and the size of the ONH parameters, thickness of superior and inferior RNFL quadrant, center macular thickness and subfoveal and temporal choroidal thickness.

Our findings can also confirm earlier observations of the researchers that the Cirrus HD-OCT system achieves approximately double the axial resolution of the previous generation Stratus OCT device and allows for better visualization of tissues. This processing HD-OCT software is unique because images are generated by evaluating all of the pixel data to reduce noise and construct the best possible image. This enables visualization and measurement of the full thickness of the choroid and satisfactory repeatable GCIPL thickness measurements using the Cirrus HD-OCT Ganglion Cell Analysis (GCA) algorithm [31,32].

The limitation of our work may be the lack of other—apart from SD for blood glucose level—indicators of glycemia variability, which require CGM system connection to patients, as well as ophthalmic parameters, including the assessment of visual acuity. The obtained results also require further confirmation on a larger group of patients.

However, it seems that simultaneous measurement of choroidal thickness and several neurodegeneration parameters using HD-OCT is useful and the selected parameters may be promising markers of preclinical phase of diabetic retinopathy in patients with type 1 diabetes. This indicates the usefulness of the HD-OCT study as a diagnostic tool and confirms the need for the HD-OCT study in patients with several years of clinical course of type 1 diabetes.

Current Diabetes Technology: Striving for the Artificial Pancreas

Abstract: Diabetes technology has continually evolved over the years to improve quality of life and ease of care for affected patients. Frequent blood glucose (BG) checks and multiple daily insulin injections have become standard of care in Type 1 diabetes (T1DM) management. Continuous glucose monitors (CGM) allow patients to observe and discern trends in their glycemic control. These devices improve quality of life for parents and caregivers with preset alerts for hypoglycemia. Insulin pumps have continued to improve and innovate since their emergence into the market. Hybrid closed-loop systems have harnessed the data gathered with CGM use to aid in basal insulin dosing and hypoglycemia prevention. As technology continues to progress, patients will likely have to enter less and less information into their pump system manually. In the future, we will likely see a system that requires no manual patient input and allows users to eat throughout the day without counting carbohydrates or entering in any blood sugars. As technology continues to advance, endocrinologists and diabetes providers need to stay current to better guide their patients in optimal use of emerging management tools.

1. Introduction

Type 1 diabetes (T1DM) is an autoimmune disease in which the β cells of the pancreas are damaged and subsequently destroyed. Since these cells are critical in the production of insulin hormone, this leads to a state of insulin deficiency. Landmark studies, such as the Diabetes Control and Complications Trial (DCCT) and the ongoing Epidemiology of Diabetes Interventions and Complications (EDIC) follow up study, have conclusively proven the long-term benefits of early and intensive blood glucose control on the future development of diabetes-related complications, such as heart, eye, kidney, and nerve disease, and improved life expectancy [1]. As a result, frequent blood glucose (BG) checks and multiple daily insulin injections have become standard of care in T1DM management. These advances have brought forth challenges of managing a chronic illness as well as opportunities to apply technological advances from engineering to medicine.

Diabetes was referenced as early as 1500 B.C. in Egyptian manuscripts as a disease noted for increased urination. The techniques for diagnosis of T1DM were described by the middle of the 16th century when it was recognized by detection of sugar in the urine [2]. However, insulin was not discovered until 1921, when Charles Best and Frederick Banting used canine pancreas extracts to successfully treat diabetic dogs. In 1923, Eli Lilly introduced the first insulin product, a further purified pancreas extract, to the market [3]. Since that time, many different insulins and innovative insulin delivery devices have been developed from insulin pens to insulin pumps. Both diagnostic tools and treatments have continued to evolve in the 20th and 21st centuries.

The field of glucose monitoring and insulin administration technology has transformed in the past two decades. Patients in the developed world use palm-size or smaller handheld glucometers as a standard of care for managing their diabetes. Additionally, continuous glucose monitor (CGM) devices, which allow patients to wear a sensor and obtain frequent automated BG readings, are quickly gaining a central place in T1DM management. Furthermore, integrated insulin pump and CGM systems are now increasingly available; this has improved the ease of insulin delivery in addition to prevention of severe hypoglycemia, one of the most feared complications of treatment with insulin. As the technology in diabetes care continues to evolve, providers must be up-to-date on available systems and advocate for the care of their patients. In this review article, we discuss currently available and shortly anticipated diabetes technology available for T1DM patients within the United States (US) and Europe with the goal of providing a historical perspective and an update to clinicians caring for patients with diabetes so they can facilitate discussions on therapeutic options with their patients.

2. Methods

A thorough review of the existing literature was conducted via PubMed and Google Scholar. Keywords included were 'diabetes', 'T1DM', 'continuous glucose monitor', 'CGM', 'insulin pump', 'continuous insulin infusion system', 'hybrid closed loop system', 'bihormonal', 'Abbott Freestyle Libre', 'Dexcom', 'Medtronic', 'Tandem', 'OmniPod', 'iLet'. Relevant studies from 2007–2019 published in the English language were reviewed and included.

3. Continuous Glucose Monitors

Continuous glucose monitors are devices that help patients with diabetes to monitor their glucose levels over time. They allow for dynamic information that indicates direction of glucose change allowing the user to observe the influence of diet, exercise, and insulin dosing on the patient's glucose level in real-time. Additionally, they can be used in conjunction with insulin pumps to better guide insulin therapy. Studies have shown that CGM use can increase time spent in normoglycemia and decrease the frequency and severity of hypoglycemia episodes [4,5]. In a randomized study of adults with hypoglycemia unawareness, researchers found that patients in the CGM group had a 72% reduction in hypoglycemia events [6]. Alarms may be set on some of these devices to alert the user to urgent low glucose levels or elevated glucose levels. Many devices even allow sharing of data to multiple smartphones providing parents with access to remotely monitor their child's glucose levels and allowing physicians to view their patient's glucose trends and accordingly adjust insulin therapy [7].

Medtronic Minimed CGM was the first CGM system approved by the FDA in 1999 after it had been tested in Caucasian adults with T1DM [8]. This first available system was not meant to be used in real-time and BG trends could only be evaluated after the window of therapy [9]. Additionally, the FDA specifically stipulated that this device be used in conjunction with regular finger-stick BG checks. Over the 20 years since the introduction of the first CGM system to market, many new systems and updates have been introduced and have revolutionized management of T1DM. In early 2017, the Centers for Medicare & Medicaid Services (CMS) determined that CGM systems that are FDA approved for treatment decisions could be eligible for Medicare coverage [10]. Recently the American Diabetes Association has endorsed use of CGMs in children and adolescents with T1DM to help improve glucose control while minimizing risk of hypoglycemia [11].

A CGM consists of an electrode sensor placed subcutaneously, a transmitter, and a receiver. The sensor detects glucose levels by electrochemical detection of glucose [9]. This sensor measures the glucose levels in the interstitial fluid and is attached to a transmitter that sends the data to a receiver. The glycemic data and trends are displayed on the receiver or on the pump screen of part of an integrated system.

Various sensors that have been used include biosensors, which involve the use of natural oxygen cofactor, artificial redox mediators, direct electron transfer between glucose oxidase and the electrode,

and direct electro-oxidation of glucose [12]. The most commonly used method in CGM technology today uses electrochemical sensors because of increased sensitivity and accuracy [13]. Typically, this will use glucose oxidase (GOx) to detect glucose levels. This particular enzyme electrochemical sensor reaction has gained widespread use because GOx remains stable at variable pH values and temperatures. GOx, with the aid of a cofactor, facilitates transfer of electrons and production of hydrogen peroxide. The electrochemical sensor detects the number of electron transfers and, therefore, the number of glucose molecules present. Oxygen is important for this reaction to occur in the subcutaneous tissue. In the setting of poor perfusion or hypoxia, sensors may not be able to accurately detect glucose levels without appropriate levels of oxygen present [13,14]. Fluorescence-based sensors have also been used and are discussed in further detail below.

Current recommendations for BG monitoring advise 6–10 BG readings daily to guide insulin management of T1DM patients [15]. CGM systems allow for readings every five minutes approximately throughout the day and night and, thus, provide information about accurate trends that previously were not accessible. Additionally, with some of the new systems, routine BG checks for mealtime insulin dosing may be replaced with CGM readings. At this point in time, there is a recommendation to check a finger-stick BG manually to confirm hypoglycemia or if clinically warranted; however, this may change in the future as sensor accuracy continues to improve.

Accuracy of systems is a critical aspect of CGM use and system calibrations have typically been required to ensure accuracy of readings. With typical home glucometer use, there is approximately a 20% margin of error for BG measurements [16]. Additionally, it is important to remember, that finger-stick BG values measure glucose from capillary blood while CGM sensors measure glucose from the interstitial fluid in the subcutaneous fat. These compartments do have slightly different glucose values especially during periods of rapid change in glycemia. This discrepancy in measurement values is known as ‘lag time’ in which the interstitial fluid glucose levels are lagging behind the blood values by a median of 6.8 min and up to almost 10 min in some cases [17,18]. The accuracy of systems is typically reported as a mean absolute relative difference (MARD) which is determined using data from clinical trials and calculated by using the difference in the CGM measurement and concurrent reference measurement of glucose used in the study [19]. Currently available CGM systems are discussed further in the sections below with system comparisons outlined in Table 1.

3.1. Standalone

3.1.1. Abbott Freestyle CGM Systems

Abbott’s first CGM was the Freestyle Navigator and was initially FDA approved in 2008. This product was then subsequently pulled when Abbott’s newer system the Freestyle Libre Flash

CGM, which did not require patient calibration with glucose entry, came out in 2014. Recently, the system has been updated and may be worn for 14 days prior to requiring a new sensor. The sensors are factory calibrated and require no calibration for the duration of the 14-day wear period [14]. There is a 1 h warm up period for the device to start generating data. The data are transferred to the reader when it is brought in proximity to the sensor. The reader then displays the current blood sugar with an arrow indicating the direction of the glucose trend and the readings over the last 8 h. The sensor is able to hold 8 h of data and data may be lost if the reader is not used in more than 8 h. The reader can hold data for up to 90 days and may be uploaded using device software or accessed via an approved smartphone device and the Freestyle LibreLink application. The Freestyle Libre has been approved for insertion in the arm [24]. While in the US, it is approved by the FDA in patients greater than 18 years old, it has been cleared for pediatric patients ages four years and up in Europe and Australia [25].

3.1.2. Dexcom CGM Systems

Dexcom is a company that focuses solely on CGM technology for diabetes patients. They first came out with their Short-Term Sensor (STS) system in 2006. In 2015, they released the Dexcom G4 Platinum CGM system. This system consists of a small sensor that measures glucose levels subcutaneously, a transmitter that is attached to the top of the sensor, and a receiver which displays the glucose readings and trends. With the introduction of their G4 system, Dexcom added share technology so that BG readings and trends may be monitored remotely via smartphone. The system originally worked exclusively with iOS systems, but is now compatible with some android devices. The Dexcom G5 system allowed users to bypass the receiver altogether and directly send data from the sensor/transmitter unit to their smartphone. The newest iteration, the Dexcom G6, can integrate with Tandem and display CGM data on the Tandem X2 insulin pump.

In March 2018, Dexcom released the G6 CGM system that is FDA approved for patients as young as two years old [26]. The G6 is factory calibrated with no need for calibration or finger-sticks to make clinical decisions based on FDA approval. Additionally, the G6 system is approved for wear up to 10 days. Through the smartphone application or receiver, alarms can be set for glucose target ranges to alert the user to episodes of hypoglycemia or hyperglycemia. Additionally, data may be shared with more than one smartphone device allowing parents and caregivers to remotely monitor the patient's glucose measurements.

3.1.3. Senseonics Eversense CGM System

Senseonics Eversense is the only implantable CGM device currently on the market. The device consists of an implantable sensor, removable transmitter, and a smartphone application. The transmitter activates the sensor which flashes an LED light source exciting the fluorescent polymer coating on the outside of the sensor. Glucose in the interstitial fluid will reversibly bind to the coating and alter the amount of light emitted by the polymer coating. The amount of emitted light is proportional to interstitial glucose concentration and is measured by photodetectors inside the sensor. The smart transmitter is attached to the skin with an adhesive, sitting directly over the sensor, and vibrates for alerts including hypoglycemia even when the smartphone is not in range. The transmitter is rechargeable and does not need to be replaced every three months with the implantable sensor. The implantation process can be done in the outpatient office setting by trained health care professionals. There is a 24-h warm up period after the sensor is initially placed followed by an initialization period that requires multiple calibrations within another 12-h period. Thereafter, the system requires two calibrations daily and advises finger-stick checks for treatment decisions regarding hypoglycemia or hyperglycemia. The transmitter does require charging daily that takes approximately 15 min to complete. The transmitter is water resistant up to a depth of 3.3 feet for 30 min at a time; however, the user needs to avoid submersion for the first five days of wear [27].

In the PRECISE study, Eversense was tested in 71 adults with type 1 and type 2 diabetes in multiple European countries. The mean absolute relative difference (MARD), a standard measure of

CGM accuracy, was 11.1% with a similar error profile to current CGM technology [28]. Following the initial study, the calibration methods were updated and a follow up study called PRECISE II was performed. This study was a multicenter US, nonrandomized, blinded trial in 90 adults and reported a MARD of 8.8% [23]. The in-development closed loop system iLet works in conjunction with the Eversense CGM system [29].

3.2. CGM Integrated with Insulin Pumps

Medtronic CGM Systems

As mentioned before, the Medtronic Minimed CGM was released in 1999 and was the first FDA-approved CGM device available. This system included a subcutaneous glucose sensor, a monitor, a connecting cable, and a ComStation compatible with Windows 95. It was updated to include alarms for hyperglycemia and hypoglycemia with a new device name, the Guardian Real-time CGM system. The next Medtronic system approved in 2016 was the Medtronic Minimed iPro2 system and was designed to be compatible with the Medtronic 530G insulin pump system.

The most recent Medtronic CGM system is the Guardian Sensor 3 system and works in conjunction with the Medtronic 670G insulin pump utilizing hybrid closed loop technology or with the Medtronic 630G insulin pump providing low glucose suspend. The Guardian Sensor 3 requires calibration at least twice daily, but recommends 3–4 calibrations per day for optimal accuracy. The new system does not require the purchase of a separate receiver, but directly transmits data via Bluetooth to the Medtronic insulin pump and/or an approved smartphone with the Medtronic application. The Medtronic Guardian Sensor 3 CGM can also be used in conjunction with insulin injections and features prediction of highs and lows with an alert 10–60 min prior to hyper- or hypoglycemia [30]. This sensor can alert patients to glucose changes via their smartphone or smartwatch similar to SMS messaging.

3.3. Limitations

Continuous glucose monitor systems have improved the monitoring of BGs for T1DM patients and allowed medical providers, caregivers, and patients access to BG trends that would otherwise be missed. However, there are significant limitations that must be considered with CGM systems. The cost of a CGM system can be prohibitive for patients who are uninsured or for whom insurance does not cover CGM. There are not only initial costs for the transmitter and receiver set up, but also monthly costs for sensor and transmitter replacement. Typically, sensors will last from 7–14 days depending on the CGM model. Transmitters additionally may need to be replaced monthly to a couple times per year. Since 2017, Medicaid has started to cover CGM costs with commercial insurance groups beginning to cover CGM prior to that time.

Continuous glucose monitors also require an additional body site for insertion away from an insulin pump site or injection site. In children and adults, CGM devices only have approval in particular sites. For the pediatric population, typically this is in the abdomen or gluteus. Patients however often need to interchange between multiple insertion sites most often in the abdomen, gluteus, or bilateral arms. There seems to be no difference in accuracy between sites among pediatric patients [31]. CGM systems over time have shown a variable degree of water resistance; therefore, patients need to pay attention to specific system capabilities: Abbott Freestyle Libre is water resistant to 3 feet for up to 30 min, Dexcom G6 sensor/transmitter are water resistant, Medtronic Guardian Sensor 3 is water resistant to 8 feet for up to 30 min, and Senseonics Eversense is water resistant to 3.3 feet for up to 30 min [25–27,30]. Due to the need for Bluetooth technology to transmit data to the receiver, CGMs may lose contact during water-based activities, such as showers, baths, and swimming [26]. During times when data is not being received, alerts based on glucose values will not be functional.

While glucose measurements are comparable during times of homeostasis between CGM systems and finger-stick glucose values, CGMs can lag behind when rapid glucose changes occur. Like all populations, patients with T1DM are encouraged to engage in physical activity for their overall health.

However, sudden changes in glucose might pose a challenge to current CGM capacity to accurately depict glucose trends and forewarn patients of impending hypoglycemia during or after physical activity. Zaharieva et al. reported a case study where they had a 40-year-old patient with T1DM who wore a Medtronic 670G pump and CGM integrated system, a Dexcom G5, and an Abbott Freestyle Libre during exercise. The patient performed one hour of moderate intensity running and monitored glucose values through the CGM systems and finger-stick measurements. All three of the CGM systems lagged behind finger-stick values when glucose values dropped during exercise with the largest difference in glucose levels noted in the first 30 min of exercise [32]. Additional studies have supported the finding that discrepancies between CGM and finger-stick values are greatest during exercise and return to previous accuracy within a couple hours after aerobic exercise [33].

3.4. Future Directions

Continuous glucose monitors have improved immensely in the last 20 years of clinical care. Future CGMs will need to improve upon the lag time of current devices to allow for better monitoring and management during physical exercise and periods of rapid glucose changes. As these products continue to develop, sensors and transmitters will likely become smaller and lower profile to skin for ease of wearability. Additionally, new adhesive strategies need to be employed to keep these devices in place as the lifetime of a sensor continues to improve. CGMs are already being used in hybrid closed-loop systems with insulin pumps; simultaneously, more collaborations are ongoing to make currently available CGM devices compatible with other independent insulin pumps with the goal of developing closed loop and suspend before low systems in the near future.

4. Insulin Pumps

Currently, it is estimated that more than one million people worldwide use an insulin pump for diabetes management including nearly 400,000 patients with T1DM in the US [34]. Insulin pumps are small devices that deliver short acting insulin subcutaneously via a small cannula self-placed by the patient every few days. They are designed to provide a near-continuous low dose of insulin delivered frequently in small boluses to mimic the actions of the β cells of the pancreas and also allow for bolus delivery of insulin at meal times or when needed for rapid correction of glucose. Insulin is given through a small tube called a cannula that is inserted into the subcutaneous tissue with a small needle and taped to the skin. Some insulin pump systems have tubing that runs from the device's insulin reservoir to the insertion site and some insulin pumps are tubing free. Tubing free systems stick directly to the skin with a cannula inserted into the subcutaneous tissue below the pump.

The pump itself is a battery-powered programmable device that holds multiple settings. Providers and patients are able to program multiple insulin delivery settings based on the time of day and in multiple profiles. Within a profile, there will be basal rates for 24-h, and typically a programmed carb ratio and insulin sensitivity factor with a target glucose. Additionally, settings may include insulin action time to allow the pump to calculate current insulin activity when giving additional boluses. Most pumps contain an insulin reservoir that typically is in a cylindrical shape. When the user programs the pump to deliver insulin, the plunger is pushed by the pump's internal mechanisms to precisely deliver the amount of insulin desired. The Tandem insulin pumps, however, use a bag reservoir for the insulin to allow for a smaller pump size.

The first insulin pump was designed by Dr. Arnold Kadish in the 1960s and was the size of a large backpack. In the 1970s, Dean Kamen introduced the AS2C, also known as the 'blue brick', and later the 'autosyringe.' These initial systems were large and often difficult to use even requiring a screwdriver to adjust insulin doses. By the mid-1980s, smaller and more precise systems were starting to emerge [35]. A large producer of insulin pumps, Animas announced in 2017 that it would be discontinuing insulin pump production and support. The insulin pump market has continued to evolve and now has three major companies producing insulin pumps in the US: Medtronic, Insulet, and Tandem. There are

multiple other insulin pump brands out on the market and in development worldwide, including Cellnovo, Kaleido, Roche Diagnostics Accu-Chek, and Sooil Dana Diabecare systems discussed below.

A major advantage of insulin pumps is that they allow patients to avoid multiple daily injections. Some pumps have even featured remote bolus programming allowing for parents of pediatric patients a convenient way to dose insulin for active kids. Additionally, insulin pumps allow for variable basal rates throughout the day. Circadian rhythms affect insulin requirements over a 24-h period and these differences can be more pronounced in pubertal patients [36]. Pumps certainly allow for better accommodation of differences in circadian rhythm than is possible with a long acting insulin administered once to twice daily. Insulin pumps allow for precise delivery of small insulin doses with some pumps even allowing for dosing changes down to increments of 0.01 units and minimal insulin delivery of 0.025 units per hour which may be helpful in very young patients who are often very sensitive to insulin. Furthermore, some providers have argued that use of U10 (1/10th the concentration) insulin instead of standard U100 insulin in insulin pumps could improve precision by allowing delivery of very small doses [37]. However, others argue that insulin delivery is not truly continuous, but is delivered frequently in small boluses to mimic endogenous basal production. Therefore, the option for diluted insulin or very small basal dose increments may not change care in clinical practice.

When considering insulin pump therapy, accuracy of insulin delivery is also an important consideration. Insulin pump manufacturers specify delivery accuracy to $\pm 5\%$ of insulin dose entered by using an international standard method. Typically these evaluations look at an average of the accuracy over 100 consecutive boluses within the system of interest. A 2013 study looked at insulin delivery accuracy of three conventional insulin pumps and one patch insulin pump by testing bolus accuracy in these systems. They noted a statistically significant difference in accuracy between the traditional systems and patch insulin pump with better single-dose accuracy noted in the traditional insulin pumps [38]. A standard measure of insulin pump accuracy, IEC 60601-2-24, helps to provide consistent testing of systems, but some researchers argue that this measure may be incomplete and alternative measures are being proposed [39].

Most importantly, pumps have been shown to improve glycemic control resulting in a lower HbA1c. In a recent study of pediatric patients with T1DM, patients with insulin pump therapy were shown to have lower rates of severe hypoglycemia, lower incidence of diabetic ketoacidosis, lower HbA1c, and lower total daily insulin doses than matched patients on multiple daily insulin injection therapy [40]. Insulin pumps allow patients increased flexibility in their routines and account of insulin action time thereby reducing the risk of insulin stacking. Temporary basal rates can be used to decrease hourly insulin during or after intense exercise. Patients are able to give multiple doses without requiring additional injections and utilize variable bolus settings for high fat meals. In the following sections, currently available insulin pumps are introduced and Table 2 provides a comparison of systems available within the US.

4.1. Medtronic Insulin Pumps

Medtronic was founded initially in 1949 as a medical device repair shop. In 1983, they released their first insulin pump to the market, the Minimed 502. Over the next several years, they launched updates to insertion sites and infusion sets that allowed for temporary detachment from the pump system. In 2003, they introduced the BolusWizard which wirelessly shared the glucose value from the system-integrated glucometer and suggested an insulin dose. In 2006, they released the MiniMed Paradigm Real-Time System that integrated CGM data for viewing on the insulin pump display. In 2013, the FDA approved the MiniMed 530G with Enlite for patients greater than age 16 years. This was the first system available in the US that provided ‘Threshold Suspend’ automation and would stop insulin delivery for up to two hours if the glucose level reached a preset low limit with no user response to the alert. The 630G was released in 2016 and was followed quickly by their most recent insulin pump the Medtronic 670G System [41].

The Medtronic 670G system features two operational modes: manual mode in which the system acts as a traditional pump, and auto mode in which the system acts as a hybrid closed loop device using CGM input to alter basal insulin output. The Medtronic 670G system will be discussed in greater detail below.

4.2. OmniPod Insulin Pumps

Insulet Corporation, the maker of OmniPod, was founded in 2000 and first received FDA clearance for OmniPod in 2005. This system was the first developed ‘patch’ insulin pump with two components: a disposable OmniPod infusion pump and the OmniPod Personal Diabetes Manager (PDM) [42]. The PDM is a handheld battery-powered device that controls insulin delivery from the disposable infusion pump. The infusion pump can be worn for up to 3 days and is waterproof up to 25 feet for 60 min. It will deliver insulin based on the programmed basal rates set up in the PDM. The PDM communicates wirelessly with the infusion pump and needs to be within five feet to give a bolus insulin delivery or change previously set basal insulin delivery rates.

The most recent iteration, OmniPod DASH, is anticipated for wide availability in early 2019 [43]. This system uses Bluetooth technology for communication between the PDM and infusion pump and allows users to view their PDM data on mobile phone applications. Additionally, with the smartphone applications, users will be able to share data with up to 12 people. The application will integrate Dexcom G6 CGM data with insulin delivery data on a single screen for streamlined analysis of information. However, the user will still need the PDM to make basal rate delivery changes or to give bolus insulin doses.

4.3. Tandem Insulin Pumps

In 2008, Tandem Diabetes Care, Inc. was founded from a previous company Phluid, Inc. [44]. The t:slim insulin pump received FDA clearance in 2011 and was the first ever touchscreen insulin pump. In 2015, they received FDA approval for integration with the Dexcom G4 CGM system. The t:slim, via Bluetooth technology, offered Dexcom G4 CGM data display on the insulin pump screen. This allowed for data to be interpreted in real-time with only one device. The newest Tandem product, the X2, was released in 2016.

The Tandem X2 insulin pump features integration with Dexcom G5 or G6 CGM systems. They use Basal-IQ technology to reduce incidence of hypoglycemia in patients using both the X2 insulin pump and a Dexcom G6 CGM. The PROLOG trial showed significantly reduced rates of hypoglycemia without rebound hyperglycemia with use of the Tandem Basal-IQ system. The algorithm works by predicting glucose levels 30 min into the future and suspends insulin delivery if the predicted glucose value is <80 mg/dL or the actual glucose value is <70 mg/dL [45]. Updates of the Tandem insulin pump will be through software updates that can be downloaded to the patient’s pump as new systems are released.

4.4. *Insulin Pumps Systems Available Only Outside of the US*

4.4.1. Cellnovo Insulin Pumps

The Cellnovo system is an insulin pump available to patients in Europe, but not currently available in the US. The system is comprised of a small insulin pump that is controlled via Bluetooth technology with a locked down Android device. The pump has short tubing and uses an adhesive to attach to the skin. It is water resistant to a depth of 36 feet for up to 1 h. This system also includes an activity tracker and food library, as well as applications for data management [46].

4.4.2. Kaleido Insulin Pumps

The Kaleido insulin pump is newly available in Europe at this point. Some of this pump's unique features include the option of placing the infusion site with variable lengths of tubing to accommodate for different locations on the body and the insulin pump can be placed on the skin with an adhesive or placed in a pocket. Also, the system comes with two rechargeable pumps that can be used interchangeably and a handset that controls insulin delivery via Bluetooth technology. The pumps are water resistant up to a depth of 3.3 feet for up to 1 h; however, the pump charging station and handset must be kept dry. Kaleido also offers 10 color options for the insulin pump [47].

4.4.3. Roche Diagnostics Accu-Chek Insulin Pumps

The Accu-Chek Combo system first became available in the US in 2012 following approval by the FDA. The system was comprised of an insulin pump and glucometer that was connected via Bluetooth technology. The Accu-Chek insulin pumps are no longer supported in the US; however, they are still prominent in Europe and continue to support glucometers within the US. Their most recent systems, the Accu-Chek Spirit Combo and Accu-Chek Insight, are currently supported in many countries around the world and offer some advantages. The systems, comprised of an insulin pump and smart glucometer, allow the patient to change pump settings and use a bolus calculator without directly changing settings on the pump by input through the Bluetooth connected glucometer. The Accu-Chek Insight also allows patients to use pre-filled insulin cartridges instead of filling cartridges manually when replacing insulin [48].

4.4.4. Sooil Dana Diabecare Insulin Pumps

The Sooil Company has two insulin pumps currently on the market, Dana Diabecare R and Dana Diabecare RS insulin pumps. They are currently available in multiple countries in Europe and Asia. The Dana Diabecare R model features a connected glucometer and lightweight design. The system also allows for remote control of pump settings through an Android based smartphone application [49]. The Dana Diabecare RS system was released in 2018 and connects with smartphone applications for both Android and iOS systems via Bluetooth technology [50].

4.5. *Limitations*

Insulin pumps have revolutionized insulin delivery by allowing for very precise insulin dosing and small dose delivery, but there are limitations to therapy. Cost is an important issue in care of patients with T1DM. In the DIAMOND study, researchers enrolled 75 adults with T1DM already using CGM and randomized them to either insulin pump therapy or continued multiple daily injections (MDI) therapy and followed these patients for 28 weeks [51]. They reported total per person costs for the length of the trial as \$8272 for patients in the CGM + insulin pump group and \$5623 for patients in the CGM + MDI group. Insulin pump therapy is often covered by insurance with improvement of out of pocket costs, but has associated monthly costs for supplies required for pump therapy including infusion sets, tubing, adhesives, batteries, insulin reservoirs or cartridges, and insulin.

At this point, many insulin pumps are considered 'open-loop', meaning that the device acts based on settings that have been programmed into the system and cannot alter its output based on the effect of insulin on glucose. This requires careful monitoring of glucose values during therapy and a well-trained patient or parent who can alter insulin pump settings to vary insulin delivery based on clinical need.

With insulin pump therapy, there has always been a concern for increased risk of diabetic ketoacidosis (DKA), a life-threatening complication of T1DM. Since insulin pumps utilize short-acting insulin, with pump site failure or disconnection, patients would not have the safety of subcutaneously injected long acting insulin to prevent DKA. In 2007, a consensus statement from the European Society for Paediatric Endocrinology issued a warning that 'individuals using continuous subcutaneous insulin infusion (CSII) are potentially at increased risk of developing DKA, with DKA rates varying from 2.7–9 episodes per 100 patient-years' [52]. More recently, Dogan et al. shared data from 205 adult T1DM patients treated with insulin pump therapy from 2006 to 2015. They noted only 10 cases of DKA in nine of their patients throughout the course of the study which indicates an incidence of 1.0 case/100 patient years which is reassuring [53]. Additionally, Hoshina et al. noted similar risk of DKA between patients using insulin pump versus multiple daily injection methods. Interestingly, they reported significantly lower rates of DKA in insulin pump patients who received care at a practice with experience caring for more than 250 insulin pump patients [54].

4.6. Future Directions

Over the last 50 years, insulin pumps have continued to advance and improve now with more precision and convenience than ever before. As these systems continue to evolve, more closed-loop systems will emerge onto the market. Multiple closed-loop systems are currently in development with unique algorithms designed to deliver insulin based on glucose levels measured with a connected CGM system.

Bihormonal therapy with glucagon and insulin working together has long been discussed as ideal to mimic the endogenous functioning pancreas. The iLet Bionic Pancreas which plans to utilize both glucagon and insulin has been in development for several years [55]. In a randomized controlled trial, bihormonal pump therapy was compared with insulin only pump therapy showing improvement in mean blood glucose and reduction in incidence of hypoglycemia [56].

5. Hybrid Closed-Loop Insulin Delivery Systems

With the emergence of the first commercially available hybrid closed-loop system, the Medtronic 670G, diabetes care advanced a step closer to development of an artificial pancreas. These systems have been shown to increase the percentage of time in glucose range for users. In a 2010 study, OmniPod and Freestyle Navigator CGM were used to compare an open- versus closed-loop system showing an improvement from 64% to 78% time within range for users [57]. Additionally, multiple studies have shown reduction in incidence and severity of hypoglycemia in patients using closed-loop systems in both pediatric and adult patients [58,59]. Multiple algorithms are under development for use in hybrid closed-loop systems. Release of new hybrid closed-loop systems including the OmniPod Horizon, the Tandem Control-IQ, and the Beta Bionics iLet, is anticipated in the next couple of years.

There are currently four main types of control algorithms being employed in the development of closed loop systems. Model predictive control (MPC) algorithms are the most commonly used and aim to predict glucose levels in the near future and adjust insulin delivery based on that prediction. Another algorithm is the proportional integral derivative type which responds to real-time measured glucose values. Fuzzy logic algorithms determine insulin doses based on CGM data in the way that an expert clinician would make insulin adjustments. There are also bio-inspired algorithms that utilize a mathematical model to determine insulin doses based on how β cells would act in response to glucose in the body [60].

5.1. Currently Available

Medtronic

The Medtronic 670G is the only hybrid closed-loop system currently available on the market and is approved in the US and Europe in patients 7 years and up. This hybrid system uses the Guardian 3 sensor as well as SmartGuard technology during Auto mode to adjust insulin basal rates to help keep glucose levels within target range. Basal insulin delivery is adjusted every five minutes based on CGM readings to increase time within range. Additionally, the suspend before low feature, that can also be used in manual mode, stops insulin up to 30 min prior to reaching a preset low glucose value. The insulin delivery will automatically restart when glucose levels have recovered to avoid rebound hyperglycemia.

The system requires patients to enter carbohydrate corrections at meal-times similar to a traditional pump when in Auto Mode. For CGM operation and use in Auto Mode, patients must calibrate with finger-stick glucose values every 12 h and when alerted by the pump to do so. However, at this time, the system does not allow for sharing of real time CGM data with friends or family. In their pivotal trial, they reported a decrease in average Hb A1c values from 7.4% to 6.9% and an increase in time within desired glucose range (70 mg/dL to 180 mg/dL) from 66.7% to 72.2% of the time [61]. Stone et al. provide a further review of the Medtronic 670G Hybrid Closed-Loop System [62].

5.2. Anticipated in the Next 1–2 Years

5.2.1. Beta Bionics

Beta Bionics is currently working on the iLet system that would allow for infusion of both insulin and glucagon in response to CGM data. The company is working with Senseonics Eversense CGM which is a physician subcutaneously implanted device that would read glucose levels for up to 3 months [29]. Initial release of the system is anticipated in 2020 as an insulin-only device with addition of glucagon anticipated in the next couple of years. In their 2017 study, they noted glycemic differences in the bihormonal treatment group versus traditional pump therapy including average CGM glucose of 140 mg/dL vs. 162 mg/dL and only 0.6% vs. 1.9% of time spent with glucose less than 60 mg/dL. They did, however, note an increase in complaints of nausea based on their scale scoring system [56].

5.2.2. OmniPod

The OmniPod Horizon Automated Glucose Control System is under development. The system uses Dexcom G6 CGM input and Insulet personal MPC algorithm. They presented the results of their clinic trial at the 2018 American Diabetes Association meeting, showing increased time in range and decreased hypoglycemia during both day and night in adults, adolescents, and children. Their initial study showed mean time less than 70 mg/dL 0.7% in adults and 2% in pediatric patients and percentage of time in the target range 69.5–73% in adult and pediatric age groups [63]. The system release is anticipated in 2019.

5.2.3. Tandem

In 2016, Tandem announced the plan for development of a closed-loop insulin delivery system called Control-IQ using Tandem X2 insulin pumps, Dexcom G6 CGM system, and TypeZero artificial pancreas (AP) technology [64]. Their initial pilot study published in December 2018 included five adult patients with well-controlled T1DM and showed mean time in range of 86% overall, mean glucose of 130 mg/dL, and median time less than 70 mg/dL of 2.8% [65]. They have recently completed another clinical trial of the Control-IQ system and will likely submit results for FDA approval in the coming months. The new system is anticipated later in 2019.

5.3. Limitations

The current technology allows for closed-loop insulin delivery response to glucose values and trends. However, at this point, users still need to check glucose values at least twice daily to calibrate the CGM device used in conjunction with the closed-loop system. Additionally, currently available systems require users to manually give bolus insulin for meal times by entering in carbohydrates and the current glucose value from either CGM or finger-stick value.

For the currently available system the Medtronic 670G, options for glucose goals are limited while in Auto Mode to 120 mg/dL or 150 mg/dL. For many pediatric patients who experience hypoglycemia following exercise, an elevated glucose target of 150 mg/dL may be insufficient to prevent hypoglycemia. Conversely, for older patients who can achieve very tight glycemic control, a target of 120 mg/dL may be higher than desired. Patients have adapted to the system by giving 'fake' carbohydrate boluses to achieve tighter control; however, this practice could lead to increased risk of hypoglycemia in the user [66].

5.4. Future Directions

Hybrid closed-loop systems are still new to the market with multiple new systems anticipated in the coming years. Across the globe, several systems are currently in development or undergoing clinical trials and may be several years away from introduction into the market. Previous reviews have detailed systems in development extensively including the papers from Trevitt et al. and Bekiari et al. and should be referenced for a more detailed overview of anticipated systems [60,67]. As this technology continues to develop further, systems will ideally require less and less management from the patient and the provider. As systems move forward, length of time they may be worn will likely increase. Additionally, integrated CGM systems will require less calibration and significantly less finger-sticks.

As these systems continue to progress, meal-time insulin may no longer be required and therefore the patient would not be required to enter carbohydrates consumed. Studies have started to look at unannounced meals in the setting of hybrid closed-loop insulin delivery systems. In a study done by Cameron et al., patients wore a closed-loop system in a hospital setting and a hotel setting and challenged the system with unannounced meals and exercise. During the study, they were able to report daytime mean glucose of 158 mg/dL showing promising results for a future system [68]. Forlenza et al. further investigated with both adults and adolescents in a hotel setting. In their study, they tested an Android-based AP system with six adults and 4 adolescents in the setting of exercise and unannounced meals. Although they showed overall mean CGM data of 157 mg/dL throughout the study, they did note a significantly lower CGM value following announced versus unannounced meals at 140 mg/dL versus 197 mg/dL. Meal announcement is still superior in glycemic control at this time given current insulin pharmacokinetics, CGM accuracy and lag, and possible speed of insulin delivery in current systems [69].

In recent studies, bihormonal pump therapy has shown improvement in mean blood glucose and reduction in incidence of hypoglycemia in comparison with insulin only pump therapy [56]. In the pursuit of bihormonal pump development, glucagon still is unstable in extended time periods in liquid form. In the future, we will likely see the emergence of a bihormonal closed-loop system using both insulin and glucagon, possibly as a standard of care.

6. Conclusions

Type 1 Diabetes is a chronic disease requiring glucose monitoring and intensive insulin therapy. Diabetes technology has continually evolved over the years to improve quality of life and ease of care for affected patients. Continuous glucose monitors allow patients to observe and discern trends in their glycemic control. These devices also give peace of mind with preset alerts for hypoglycemia and the ability for family or friends to follow a patient's glucose trends. The major products available and

in use today are the Abbott Freestyle Libre, the Dexcom G6, the Medtronic Guardian Sensor 3, and the Senseonics Eversense.

Insulin pumps have continued to improve and innovate since their emergence into the market. Pumps allow patients to infuse insulin for up to 3 days without giving individual insulin injections. These devices allow for very low doses in pediatric patients and varied basal rates during different times of day and during different activities. They also allow for more freedom in dietary schedule and multiple carbohydrate-based doses in addition to mealtimes. Hybrid closed-loop systems have harnessed the data gathered with CGM use to aid in basal insulin dosing and hypoglycemia prevention. As technology continues to progress, patients will likely have to enter less and less information into their pump systems manually.

In the future, we will likely see a system that requires no manual patient input and allows users to eat throughout the day without counting carbohydrates or entering in any blood sugars. As technology continues to advance, endocrinologists and diabetes providers need to stay current to better guide their patients in optimal use of emerging management tools.

Pediatric Sarcoidosis: A Review with Emphasis on Early Onset and High-Risk Sarcoidosis and Diagnostic Challenges

Abstract: Sarcoidosis is a non-necrotizing granulomatous inflammatory syndrome with multisystemic manifestations. We performed a systematic review of sarcoidosis in the pediatric population with particular emphases on early onset sarcoidosis, high-risk sarcoidosis, and newly reported or unusual sarcoid-related diseases. Blau Syndrome and early onset sarcoidosis/ BS-EOS are seen in children younger than five years old presenting with extra-thoracic manifestations but usually without lymphadenopathy and/or pulmonary involvement. The prevalence of high-risk sarcoidosis is very low in children and is further limited by the difficulty of diagnosis in symptomatic children and underdiagnosis in subclinical or asymptomatic patients. Reports of sarcoidal syndromes in users of E-cigarette/marijuana/other flavorings and their induction in cancer immunotherapies are of interests and may be challenging to differentiate from metastatic malignancy. The diagnostic considerations in pediatric sarcoidosis are to support a compatible clinicoradiographic presentation and the pathologic findings of non-necrotizing granulomas by ruling out granulomas of infective etiology. There is no absolutely reliable diagnostic test for sarcoidosis at present. The use of endoscopic bronchial ultrasound (EBUS) and transbronchial fine needle aspiration (TBNA) sampling of intrathoracic lymph nodes and lung, and for superficially accessible lesions, with cytopathological assessment and pathological confirmations provide fair diagnostic yield and excellent patient safety profile in children.

1. Introduction

Sarcoidosis is a multisystemic syndrome with a highly variable clinical course and diverse disease manifestations [1]. The incidence of sarcoidosis in adults may be biphasic [2]. Historically, it was thought to commonly affect young adults 30–50 years of age, but recent studies have reported that more than half of incident diagnoses are made in patients over 55 years of age [2,3]. Erdal and others suggest that the rates of sarcoidosis are increasing [4]. Approximately 25% of affected individuals with the disease develop chronic and progressive disease, which contributes to increased disease burden [5,6]. The mortality rate also appears to be rising [7]. There is no single diagnostic test for sarcoidosis. Instead, the diagnosis relies on specific pathologic and radiographic features in the appropriate clinical settings. The disease is characterized by pathologic findings of non-necrotizing granulomas in one or more involved organ systems after alternative diagnoses, in particular, infective etiologies, have been entertained [8].

Sarcoidosis is an ever-evolving process. The clinical phenotypes range from single-organ, self-limited, asymptomatic disease to multi-organ involvement with high-risk manifestations [9]. Hilar lymphadenopathy and pulmonary interstitial infiltrations are the most common manifestations [10]. The term “high-risk sarcoidosis” was introduced at the National Heart Lung and Blood Institute Sarcoidosis Workshop 2017 [1] to denote several manifestations of sarcoidosis that are associated with impaired quality of life and relatively high risk of death [9]. These include treatment-resistant pulmonary sarcoidosis, cardiac sarcoidosis, neurosarcoidosis, and/or multi-organ involvement. The high-risk manifestations and multi-organ involvements are often missed until late in the disease course [9].

The diagnosis of sarcoidosis is relatively uncommon in children [8,11–13], and high-risk sarcoid may present differently in children than in adults [8,14]. In this review, we search the English literature and aim to review the clinical investigations and laboratory diagnostics of sarcoidosis in this population.

2. Materials and Methods

We performed a systematic narrative review on sarcoidosis with particular emphases on early onset sarcoidosis, high-risk sarcoidosis, and newly reported or unusual sarcoid-related diseases in the pediatric population. We searched PubMed, Scopus, Google Scholars, and Cochrane Database of Systematic Reviews, using the following terms: sarcoidosis, pediatric, juvenile, children; high-risk sarcoidosis; pulmonary sarcoidosis; treatment-resistant sarcoidosis; cardiac sarcoid; and neurosarcoidosis. We also searched references from the appropriate reviews and case reports.

3. Results

The true incidence and prevalence of sarcoidosis in children is unknown as the disease is much less common in children than in adults [13]. It is difficult to diagnose in symptomatic children and may remain undiagnosed in subclinical or asymptomatic patients [8,11]. Several larger reviews reported that the incidence of clinically recognized sarcoidosis in children was 0.22 to 0.29/100,000 children per year, and gradually increases with age to a small peak in teenagers at 13–15 years of age [2,8,11,13,15]. Two distinct forms of childhood sarcoidosis appear to exist. Older children and young adults present most frequently with a multisystemic disease in a combination of lymphadenopathy, pulmonary, ocular and cutaneous involvement (erythema nodosum) [2,8,11,13], followed by joint (sarcoidal arthritis) and hepatosplenic features [8,11,13]. The disease patterns and clinical outcomes are similar to those in adults.

3.1. Blau Syndrome and Early Onset Sarcoidosis (BS-EOS)

In younger children, the majority of cases of EOS seen in children younger than five years old uniquely presents with a clinical triad of uveitis, arthritis, and skin rash [2]. In 1985, Blau et al. reported a rare autosomal dominant inflammatory disease characterized by a clinical triad of granulomatous dermatitis, recurrent granulomatous uveitis, and systemic polyarthritis in 11 family members of four generations [16,17]. A mutation of nucleotide binding oligomerization domain 2 (NOD2), also termed caspase recruitment domain-containing protein 15 (CARD15), mapped on chromosome 16q12 was identified [18] and found to be responsible for these granulomatous inflammations [16,18]. Early onset sarcoidosis (EOS) is caused by a sporadic mutation of the NOD2 gene, with similar clinical manifestations to Blau Syndrome [16]. Blau Syndrome/EOS patients rarely present with pulmonary involvement, and ocular involvement tends to follow prior articular and cutaneous manifestations in these patients [16,19].

CARD15/NOD2 encodes a multidomain cytosolic protein and is expressed primarily in the cytosol of antigen-presenting cells [20]. Stimulation by bacterial or viral infection [21] may promote the activation of nuclear factor kappa-light-chain-enhancer of activated B cells (NF- κ B) and tumor necrosis factor receptor-associated factor 3 (TRAF3) signaling pathways [21]. A possible role of mycobacterial components has also been suggested as triggers of granulomatous autoinflammation in

CARD15/NOD2 mutations in BS/EOS [22–24]. Crohn’s disease (CD) is a granulomatous inflammatory bowel disease, involving any part of the gastrointestinal tract [25] but may mainly affect the distal ileum and colon [22,26,27]. The CARD15/NOD2 gene has been identified as one of the genes linked to susceptibility to CD [22,28]. It has been hypothesized that NOD2 susceptibility loci in intestinal Paneth cells led to defective NF- κ B activation, altered intestinal bacterial clearance and granulomatous inflammation [22,29,30]. Juvenile sarcoidosis presenting as Crohn’s disease of the GIT has been reported [31].

3.2. High-Risk Sarcoidosis

Approximately 25% of affected individuals with sarcoidosis develop chronic or progressive disease [6]. Manifestations of sarcoidosis associated with poor prognosis and a relatively high risk of death include treatment-resistant pulmonary-, cardiac-, neuro-, and multiorgan sarcoidosis [9]. Pulmonary disease is the most common cause of chronic disease and death in adults [9]. As in adults, older children usually present with hilar lymphadenopathy and up to 50% present with interstitial lung disease and multiorgan involvement, while progression to chronic diseases occurs in 12% of these children [2,8,13]. Korsten et al. defined pulmonary sarcoidosis refractory to treatment as progressive disease and significant impairment of life despite glucocorticoid therapy for at least three months and the need for additional anti-sarcoid drugs [32]. These patients develop progressive pulmonary fibrosis and associated complications, including pulmonary hypertension and infections and are seen in more than 10% of patients at specialized centers [32,33]. In infants and children younger than five years, the typical pulmonary diseases are usually not seen [8]. In a retrospective study of 41 pediatric patients, which were followed for 18 months on disease presentation, management, and clinical outcome, those patients with pulmonary sarcoidosis diagnosed before 10 years old were more likely to recover and presented with fewer relapses compared with the patients diagnosed after 10 years old [34].

Recent progress in cell-mediated immunity and granuloma formation has advanced our understanding of the development of sarcoidosis [8,35]. Macrophages bearing increased expression of major histocompatibility (MHC) class II molecules, different subsets of T-lymphocytes and other immune effector cells such as mast cells and natural killer cells may be at play [8,35]. In sarcoidosis involving the lung, before the formation of granulomas, early lesions consist of alveolitis with a high proportion of activated CD4+ T-cells [36]. T-cells play a role in amplification of the local cellular immune response and are responsible for secretion of cytokines, including tumor necrosis factor (TNF), which favors granulomatous response at the sites of disease activity. The diagnostic approach to pulmonary sarcoidosis has been revolutionized in the past decade by the use of endobronchial ultrasound (EBUS) real-time guided transbronchial sampling of intrathoracic lymph nodes and lung biopsies [6]. Cytopathological assessments by fine needle aspiration provide fair diagnostic yield and excellent patient safety profile in children [37,38]. Combining EBUS and transbronchial needle aspiration (TBNA) lung biopsy and cytopathologic study may increase the diagnostic sensitivity to close to 100% [39,40]. On bronchoalveolar lavage (BAL) fluid with lymphocytosis (15%) and increased ratio of CD4 to CD8 (>3.5:1), the specificity for the diagnosis of sarcoidosis approaches 95% [36,41].

Cardiac sarcoidosis (CS) is a rare but potentially fatal condition [42]. Clinically recognizable cardiac involvement occurs in 5% of adult patients with sarcoidosis [43], and granulomatous inflammation of the heart was recognized in up to 25% in an autopsy series [13,44]. Rare cases of pediatric cardiac sarcoidosis had been reported [8]. Patients with CS may present with a wide variety of signs and symptoms, ranging from asymptomatic ECG abnormalities to sudden death [42]. Congestive heart failure and conduction abnormalities are the two most common clinical manifestations in CS [42], with one case presenting with pericardial effusion [2,8]. Many patients with pulmonary/systemic sarcoidosis have asymptomatic cardiac involvement [43]. A high index of suspicion and early diagnosis are crucial when immunosuppression therapy may result in reduced mortality rate [8]. Various imaging modalities including echocardiography and/or CMR imaging may be utilized [43].

Neurosarcoidosis occurs in fewer than 5% of adult with systemic sarcoid with isolated neurosarcoidosis being more rare [45], and to our knowledge, 53 cases of pediatric neurosarcoidosis have been reported in the English literature [14,46]. In these children, the most common manifestations include headache, seizures, cranial neuropathy, optic neuritis, and hypothalamic and/or pituitary dysfunction [14,46]. Compared to the adult counterparts, prepubertal children with neurosarcoidosis are more likely to present with seizures and a space-occupying lesion but less likely with cranial nerve palsies. These children do however tend to evolve to an adult pattern of presentation during puberty [14]. Single cases of aqueductal stenosis [13] and obstructive hydrocephalus [47] have also been reported. The most reliable method for diagnosing neurosarcoidosis is via biopsy of lesion in the central nervous system revealing non-caseating granuloma [46]. Microscopically, granulomatous inflammation is typically found in the meninges, ventricles (including choroid plexus) and adjacent brain or spinal cord parenchyma. Inflammatory infiltrate may involve optic nerve and chiasm, cranial nerves such as facial, auditory, and vestibulocochlear nerve. In cases where biopsy is not possible, neuroimaging becomes an important diagnostic modality. The most common neuroimaging finding is said to be leptomeningeal enhancement on T1-weighted MRI with contrast administration [48]. Enhancement may also be seen in the basilar region, leading to abnormalities in the hypothalamus, optic chiasm, and pituitary region [46]. As neurosarcoidosis is a diagnosis of exclusion, differential diagnoses that need to be considered and ruled out include tuberculosis, fungus, Wegener's granulomatosis and hypertrophic meningitis, as these may also present with leptomeningeal enhancement and granulomas. To the best of our knowledge, cases of pediatric spinal neurosarcoidosis have not been reported in the English literature.

3.3. Acute Sarcoidosis

In contrast to the chronic progressive disease with organ dysfunction in high-risk sarcoidosis, two acute sarcoidosis syndromes are of relatively benign clinical outcome. Lofgren syndrome is characterized by fever, bilateral hilar lymphadenopathy, erythema nodosum, and arthralgia, typically in young women, primarily Caucasian. Prognosis is excellent with complete resolution of the disease in 90% of the patients within two years [8,49,50]. Heerfordt syndrome or uveoparotid fever, presenting with a combination of fever, parotidomegaly, anterior uveitis, and cranial nerve palsy is usually seen in adults but has been reported in children [8,49]. The disease is normally self-limiting with cure achieved between 1–3 years [8,51]. The acute sarcoidosis syndromes may be confidently diagnosed on clinical grounds without surgical biopsy confirmation in adults [8,49,52]. However, the clinical manifestations in children may be variable necessitating biopsy histopathology confirmation [8,15,49,53].

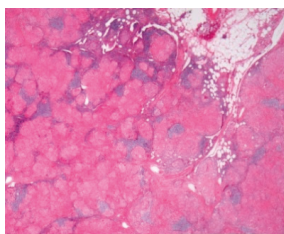


Figure 1. Mediastinal nodal sarcoidosis. H&E Magnification 20×.

Pathology images of the spectrum of pediatric sarcoidosis involving different organs (Figures 1–7).

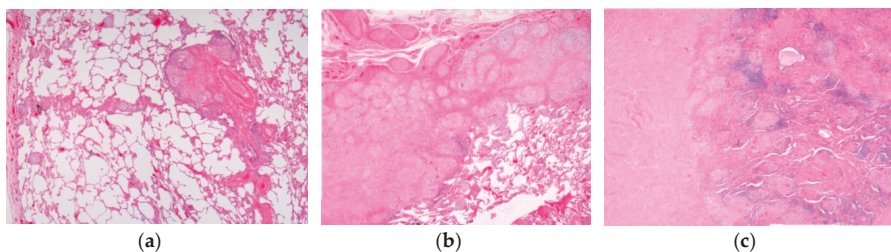


Figure 2. Pulmonary sarcoidosis. (a) Pulmonary sarcoidosis. (b) Pulmonary nodular sarcoidosis. (c) Pulmonary fibrotic sarcoidosis. H&E. Magnifications 20×, 50×.

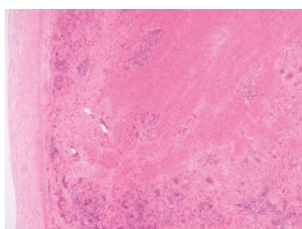


Figure 3. Cardiac sarcoidosis. H&E Magnification 50×.

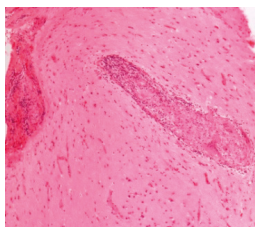


Figure 4. Neurosarcoidosis. H&E. Magnification 100×.

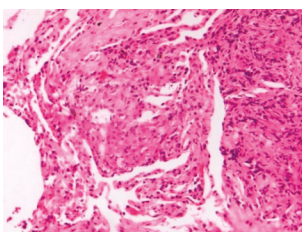


Figure 5. Lung sarcoidosis young E-cig vaper. H&E. Magnification 200×.

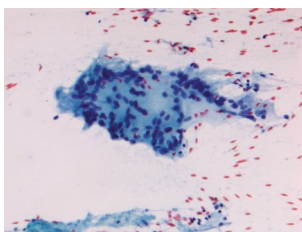


Figure 6. Acute sarcoidosis salivary gland. Cytopathology Pap stain 200×.

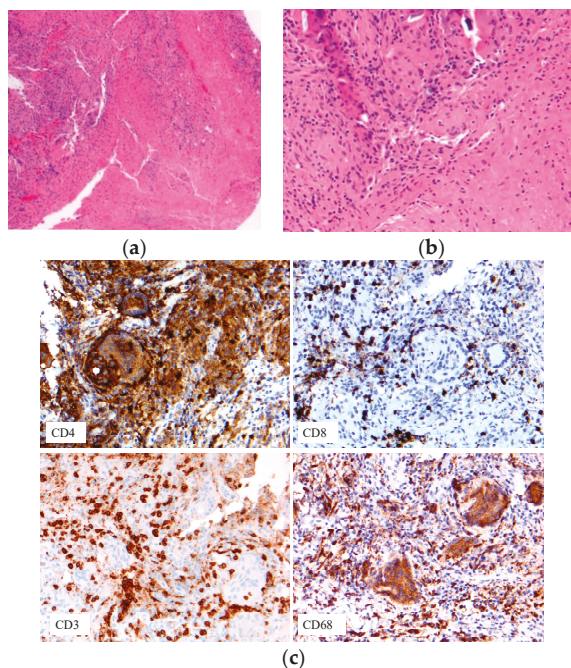


Figure 7. Immune cell phenotypes: T-cells: CD3, CD4, CD8; macrophage CD68. (a) Early onset sarcoidosis (EOS) skin sarcoidosis; (b–c) EOS skin sarcoidosis.

Recent case reports of sarcoidosis developing after antigen exposure to inhalation or in immune-therapy are of interests. The popularity of electronic cigarettes (E-cig) has recently been increasing among adolescents and young adults [54–56]. E-cig usage or “vaping” contains E-liquid carrier components, flavorings, and marijuana product with cannabidiol (CBD) formulations [57–60]. In anecdotal stories, the use of medical marijuana, in particular vaping with CBD oil may be linked to improvement of refractory pulmonary sarcoidosis [61]. In E-cig and marijuana users, sarcoidal granulomas are found in multiple organs in case reports, raising the clinical suspicion of metastatic malignancy [62,63]. The development of sarcoidal granulomas may be related to vaped marijuana product tetrahydrocannabinol (THC), E-cig flavorings, or contaminants. An association of vaped THC has been reportedly seen in close to 500 cases of severe pulmonary disease with six confirmed deaths [56]. As tumor necrosis factor-alpha (TNF- α) plays an important role in both formation and maintenance of sarcoidal granulomas, anti-TNF- α may provide a therapeutic option to patients with sarcoidosis [64]. However, many anti-TNF-associated cases of sarcoidosis have also been reported [65], negating its therapeutic usage. Pulmonary sarcoidal granulomas are found in patients undergoing interferon-alpha therapy [66]. The use of immune checkpoint inhibitors by enhancing anti-tumor immunity has revolutionized cancer therapy recently, and their use for cancer immunotherapy in pediatric patients may have potential benefits [67,68]. However, pulmonary sarcoidosis and the exacerbation of sarcoidosis leading to central nervous system involvement after immune checkpoint inhibitor therapy have been reported [25,69].

3.4. Diagnostic Challenges and Considerations in Pediatric Sarcoidosis

There is no absolutely reliable diagnostic test for sarcoidosis [52]. A number of clinical tests and biomarkers assay have evolved over time in the diagnosis and include: tubulin skin test of anergy (Kvim test), serum angiotensin-converting enzyme (SACE), serum amyloid A (SAA), and cytokine

levels [33,52,70]. The lack of sensitivity and specificity of these tests or biomarkers poorly suited as screening tests, disease activity or prognostic markers for sarcoidosis [33,52,70]. As in adults, the diagnosis is difficult to confirm in symptomatic children, and there is a significant number of asymptomatic patients who remain undiagnosed [13].

In the spectrum of pediatric sarcoidosis, depending on the initial clinical presentation and subsequent investigations including various diagnostic imaging modalities, sarcoidosis is a diagnosis of exclusion, with ruling out granulomatous infections, in particular by Mycobacterial and fungal organisms [8,52]. A high index of suspicion is critical in the diagnosis, especially in early onset of the disease or Blau syndrome in a child younger than five years of age who presents with a clinical triad of uveitis, arthritis, and skin rash, and without the adult manifestations of lymphadenopathy and/or pulmonary involvement. The early presentation of arthritis in early onset sarcoidosis may be misdiagnosed as juvenile rheumatoid arthritis (JRA) [71]. Pediatric sarcoidosis involving the gastrointestinal tract may raise a differential diagnosis mostly with Crohn’s disease [31]. Both sarcoidosis and CD are chronic granulomatous inflammatory disorders. The presence of granulomas in the gastrointestinal tract might be misleading and the diagnosis of sarcoidosis should be established when extraintestinal features become evident [31]. For BS/EOS and acute sarcoidosis syndromes, pathological and/or cytopathological confirmation and exclusion of other etiologies by biopsies of accessible lesions such as skin (including erythema nodosum, which is a non-granulomatous panniculitis) [49], salivary glands, and peripheral lymph nodes are highly desirable.

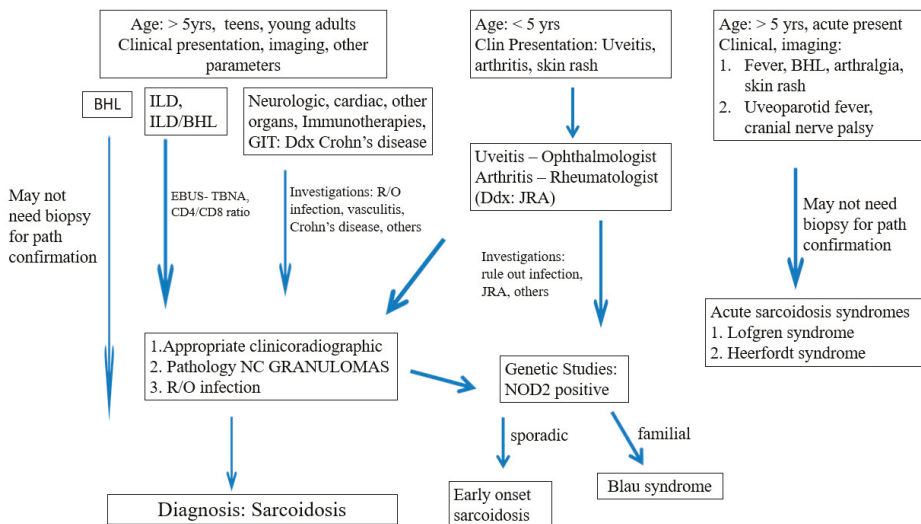


Figure 8. Paediatric Sarcoidosis: Diagnostic Considerations. Legends: BHL Bilateral hilar lymphadenopathy, ILD Interstitial lung disease, GIT gastrointestinal tract, EBUS-TBNA endoscopic bronchial ultrasound-transbronchial needle aspiration, NG non-necrotizing granulomas, JRA Juvenile rheumatoid arthritis, NOD2 Nucleotide binding oligomerization domain 2.

Cases of high-risk sarcoidosis in children with the involvement of treatment-resistant pulmonary disease, cardiac sarcoidosis, neurosarcoidosis, and multi-organ disease and the recent reports of E-cigarettes and immunotherapy-related sarcoidosis are uncommon. The lung is the most frequent site for biopsy confirmation, followed by skin, peripheral lymph nodes, and liver [49,72]. The diagnostic considerations are to support a compatible clinicoradiographic presentation and the demonstration of non-caseating granulomas. The use of EBUS-TBNA sampling of intrathoracic lymph nodes and lung [6], with cytopathological assessments and pathological confirmations provide fair diagnostic yield and excellent patient safety profile in children [6,52] (Figure 8).

4. Discussions

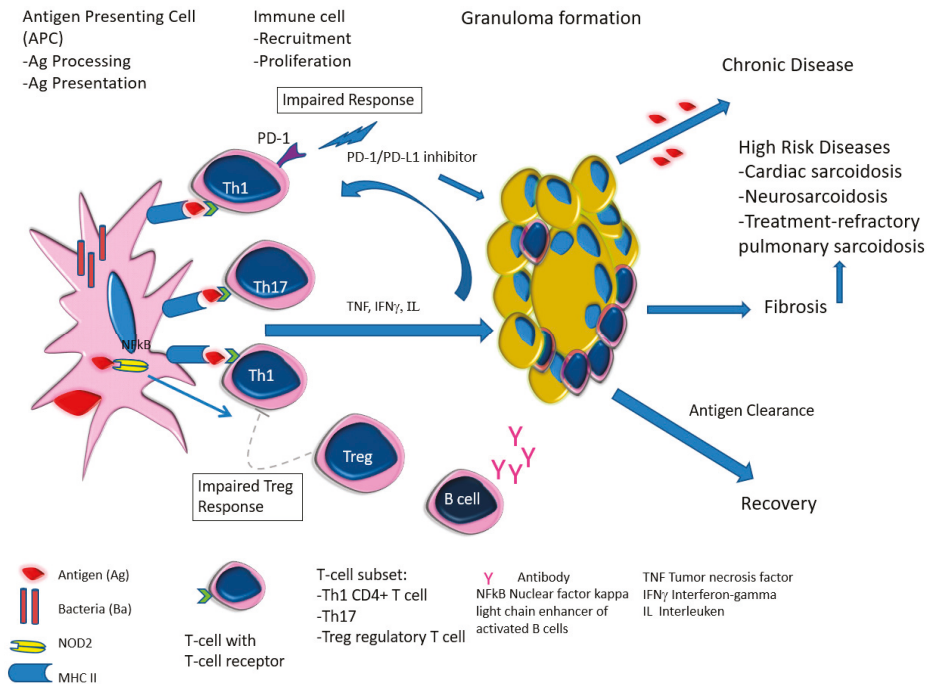


Figure 9. Proposed Pathogenetic Mechanisms in Pediatric Sarcoidosis.

Since the initial clinical description by Jonathan Hutchinson [73] in 1877, followed by the histologic findings of Caesar Boeck [74] in 1899, recent progress in immunology and molecular biology has advanced our understanding of the pathogenetic mechanisms for the development of sarcoidosis [8,35,75]. The proposed model of sarcoidal granuloma development in children involves the interplay of environmental triggers by a variety of antigens and immunologic/genetic/epigenetic factors, and requires three or more events to take place [8] (Figure 9)—environmental exposures to antigen (e.g., infectious agents, E-cigarettes flavorings, marijuana), acquired cellular immunity directed against the antigen, and the appearance of immune effector cells that promote a non-specific inflammatory response [8]. The subsequent Th1 (CD4+ T cell) polarized immune response with increased cytokine activities (TNF, IFN γ , interleukin) [75], and high-level IFN γ -secreting Th17 effector cells [35] are at play in the recruitment and proliferation of immune cells. Genetic factors (e.g., CARD15/ NOD2 mutation) may play a role by interacting with mycobacterial/bacterial/viral components, promoting the activation of NF- κ B and tumor necrosis factor receptor-associated factor 3 (TRAF3) signaling pathways and triggering granulomatous autoinflammation in BS/EOS patients [22–24]. Immune checkpoint inhibitor (PD-1/PD-L1) for the immunotherapy of a variety of cancers may activate T-cells and promote granuloma formation [25,69]. Progression of granulomatous inflammation and putative antigen persistence promotes fibrosis and the development of high-risk organ-system manifestations [35,75].

B lymphocytes may also be involved in sarcoidal granuloma formation, as Lofgren syndrome patients exhibit higher levels of Propionibacterium

acnes-specific IgA antibodies [77]. In chronic diseases, sarcoid T-reg fails to efficiently suppress proliferation and cytokine production by T helper cells [78], and with accumulation of Th1/Th17 cells, further support stabilization of granulomas and chronic disease progression [35]. In contrast, highly plastic and qualified effector T-cells aiming at clearance of the antigens from the granulomas leads to recovery [35,76].

We summarize the clinicopathologic spectrum of pediatric sarcoidosis and the diagnostic considerations in Table 1. Erdal and others suggest that the rates of adult sarcoidosis are increasing [4]. With the risks of increasing environmental exposure to increasing number of antigens, we would expect the prevalence of pediatric sarcoidosis also correspondingly increases. At present, there are no absolute diagnostic tests or biomarkers for screening, disease activity or prognostic markers for sarcoidosis. Fortunately, the diagnosis of sarcoidosis in children is improving with ever improving diagnostic techniques and imaging modalities. The development of minimally invasive procedures including EBUS-TBNA, for cytopathology or pathological confirmation of non-necrotizing granulomas and the resultant improving prognosis outcome appear promising. Recent advances in the use of genome-based approaches in identifying novel biomarkers to support the diagnosis and predict disease activity yield some promising results [70]. However, further researches are needed in sarcoidosis involving the young population.

Left Ventricular Dysfunction and Plasmatic NT-proBNP Are Associated with Adverse Evolution in Respiratory Syncytial Virus Bronchiolitis

Abstract: Aim: To investigate whether the presence of left ventricular myocardial dysfunction (LVMD) assessed by Tei index (LVTX) impacts the outcomes of healthy infants with Respiratory Syncytial Virus Bronchiolitis (RSVB). To explore whether N-terminal pro-B-type natriuretic peptide (NT-proBNP) increases the accuracy of traditional clinical markers in predicting the outcomes. Methods: A single-centre, prospective, cohort study including healthy infants aged 1–12 months old admitted for RSVB between 1 October 2016 and 1 April 2017. All patients underwent clinical, laboratory and echocardiographic evaluation within 24 h of admission. Paediatric intensive care unit (PICU) admission was defined as severe disease. Results: We enrolled 50 cases of RSVB (median age of 2 (1–6.5) months; 40% female) and 50 age-matched controls. We observed higher values of LVTX in infants with RSVB than in controls (0.42 vs. 0.36; $p = 0.008$). Up to nine (18%) children presented with LVMD (LVTX > 0.5), with a higher incidence of PICU admission (89% vs. 5%; $p < 0.001$). The diagnostic performance of NT-proBNP in predicting LVMD was high (area under the receiver operator characteristic curve (AUC) 0.95, CI 95% 0.90–1). The diagnostic yield of the predictive model for PICU admission that included NT-proBNP was excellent (AUC 0.945, CI 95% 0.880–1), and significantly higher than the model without NT-proBNP ($p = 0.026$). Conclusions: LVMD could be present in healthy infants with RSVB who develop severe disease. NT-proBNP seems to improve traditional clinical markers for outcomes.

1. Introduction

Respiratory Syncytial Virus Bronchiolitis (RSVB) is the leading cause of lower respiratory infection and hospital admission among children up to 2 years of age worldwide [1]. Approximately 2–6% cases of RSVB will develop a severe form of the disease, requiring admission to the paediatric intensive care unit (PICU) and mechanical ventilation (MV) [1,2]. RSVB constitutes approximately 13% of all PICU admissions [2]. Current guidelines recognize the identification of specific risk factors (congenital heart disease (CHD), chronic lung disease (CLD), prematurity, etc.) and clinical evaluation as the best tools to assess severity, predict evolution and tailor management [3].

Cardiovascular involvement seems to be a relevant prognostic factor in RSVB. Cardiovascular complications are present in up to 9% of cases of RSVB and constitute the second most common

extrapulmonary manifestation after infectious complications [4]. These events usually present in an abrupt and unexpected manner in children with severe RSVB, and infants with CHD are particularly susceptible to these complications and adverse outcomes [5]. Interestingly, nearly half of the children admitted to PICU with RSVB are healthy prior to the clinical event [2]. In these patients, the presence of acute lung injury secondary to RSVB can also lead to important cardiovascular effects, especially elevated pulmonary vascular resistance and overload on the right ventricle (RV) [6–8]. Moreover, previous studies assessing the plasma levels of cardiac troponin in RSVB suggest an underrecognized yet clinically significant incidence of myocardial damage in this population [9–11]. Furthermore, RV global dysfunction in ventilated healthy infants has been reported [12]. Recently, we found that mild to moderate forms of pulmonary hypertension (PH) could impact the outcome of healthy infants with RSVB [13].

Adverse RV–LV interactions and left ventricle (LV) myocardial dysfunction (LVMD) are emerging as important determinants of PH outcomes. PH can induce complex changes in LV geometry and causes an abnormal relaxation and non-uniform contraction pattern in the LV wall, leading to LVMD [14–16]. However, most studies in healthy infants with RSVB found no abnormalities when assessing LVMD through conventional echocardiographic parameters [12,13,17–19]. Remarkably, there are no studies to date assessing LVMD in RSVB by more sensitive methods such as tissue Doppler imaging (TDI) echocardiography.

N-terminal pro-B-type natriuretic peptide (NT-proBNP) is a hormone synthesized and released into the circulation by ventricular myocytes in response to pressure/volume overload and an increase in myocardial wall stress [20]. Elevated serum NT-proBNP levels have been defined as a powerful biomarker in the diagnosis of PH, and both LVMD and RV myocardial dysfunction (RVMD) secondary to pulmonary diseases [21–25]. Of note, we recently showed how NT-proBNP could be considered an adequate biomarker for PH in previously healthy infants with RSVB [13].

In this study, we aimed to investigate the presence of adverse RV–LV interactions and LVMD (assessed by TDI-echocardiography) in previously healthy infants with RSVB. We hypothesized that acute PH with RV pressure overload may indeed have a direct impact on LV performance. We also hypothesized that those infants with LVMD are prone to developing a more severe form of disease. Finally, we sought to test NT-proBNP as a biomarker for LVMD and explore whether NT-proBNP increases the accuracy of traditional clinical markers in predicting the severity of the disease.

2. Materials and Methods

2.1. Design, Settings and Study Population

This was a single-centre, prospective, cohort study including infants aged 1–12 months old admitted to the paediatric department in our institution (a tertiary university-affiliated hospital in Spain) due to RSVB (determined by a confirmed Respiratory Syncytial Virus (RSV) antigen test) between 1 October 2016 and 1 April 2017. All patients underwent clinical, laboratory and echocardiographic evaluation within 24 h of admission. We excluded patients with co-existing CHD or CLD, prematurity, those that received MV or intravenous fluid before assessment, and those with poor-quality echocardiographic images or incomplete medical records. Severe cases were screened for coinfection and, if present, were also excluded. The control group consisted of age-matched healthy infants who underwent evaluation for heart murmur at our paediatric cardiology outpatient clinic during the study period. These controls followed the same echocardiographic protocol as study patients. Our Institutional Review Board approved the study. Informed consent was obtained for all patients.

2.2. Clinical and Laboratory Assessment and Outcomes

The bronchiolitis score of Sant Joan de Déu (BROSJOD) [26] was used to assess severity at admission clinically. A BROSJOD score greater than 10 points is indicative of a severe clinical state. Venous pH and pCO₂ were determined and respiratory acidosis (RA) was diagnosed when pH

< 7.35 and pCO₂ > 45 mmHg. Plasma NT-proBNP levels at admission were determined using a commercially available electrochemiluminescent immunoassay kit (ElecSys 2010, Roche Diagnostics). The primary outcome was PICU admission during hospitalization. PICU admission criteria for RSVB at our institution include the presence of: apnea, extreme bradycardia, the need for respiratory support greater than high-flow nasal cannula oxygen therapy or inotropic support.

2.3. Echocardiographic Assessment

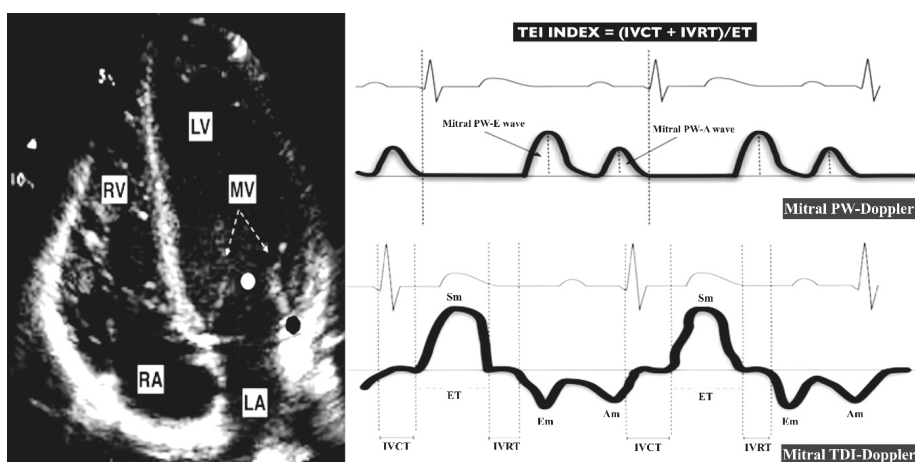


Figure 1. Echocardiographic parameters used for the estimation of LV performance. The left panel shows a four-chamber apical view. The right panel shows the waves used to assess LV performance. The Mitral PW-Doppler wave is obtained at the level of the LV inflow (white point). The Mitral TDI-Doppler wave is obtained at the level of the lateral mitral annulus (black point). MV (mitral valve; dotted arrow). RV (right ventricle). LV (left ventricle). RA (right atria). LA (left atria). PW (pulsed wave). DTI (Doppler tissue imaging). Sm (Doppler imaging (TDI)-derived peak systolic annular velocity). Em (TDI-derived early diastolic mitral annulus velocity). Am (TDI-derived late diastolic mitral annulus velocity). PW-E (PW-derived mitral peak early diastolic velocity). PW-A (PW-derived mitral peak late diastolic velocity). IVCT (TDI-derived isovolumic contraction time). IVRT (TDI-derived isovolumic relaxation time). ET (TDI-derived ejection time).

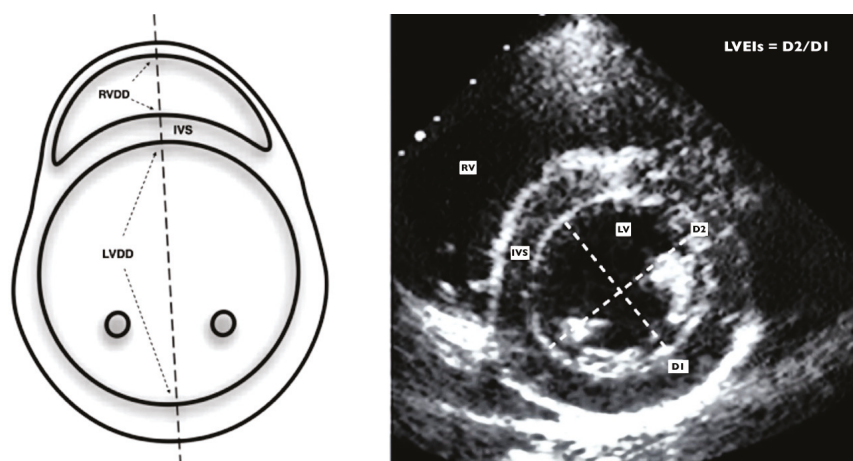


Figure 2. Echocardiographic parameters used for the estimation of RV and pulmonary hemodynamics. The figure shows a parasternal short axis view at the level of the papillary muscles. The left panel shows a schematic representation and the right panel shows real echocardiographic imaging. The LV systolic eccentricity index (LVEI) is obtained with de $D2/D1$ (dotted lines) ratio measured in systole as showed in the illustration. A $LVEI > 1.2$ is suggestive of raised RV pressures or pulmonary hypertension in infants³². RVDD (right ventricular diastolic diameter; dotted arrows). LVDD (left ventricular diastolic diameter; dotted arrows). IVS (Interventricular septum). RV (right ventricle). LV (left ventricle). D2 (LV systolic anteroposterior diameter). D1 (LV systolic laterolateral diameter).

Standard techniques to obtain M-mode, two-dimensional and Doppler (color, pulsed, continuous and TDI) echocardiograms were performed by the same experienced paediatric cardiologist (RGM) as recommended in the guidelines for the paediatric echocardiogram [27]. Images were obtained using a Phillips IE33 ultrasound scanner with an 8 or 12-MHz sectorial transducer. Each examination was recorded, and all the studies were reviewed off-line by 2 observers (RGM and PRA), who were blinded to the patient’s clinical profile. All echocardiographic measurements represent the average of 3 beats. Control and case echocardiographic data were deidentified before data analysis. Figures 1 and 2 show the main echocardiographic measures used in this study.

2.3.1. Right-Sided Echocardiographic Assessment

The RV end-diastolic diameter (RVEDD) and the RV/LV ratio (RVLVr) were used as indicators of RV dilation. RV systolic function was assessed by the tricuspid annular plane systolic excursion (TAPSE) [28], and by the tissue Doppler imaging (TDI) derived peak systolic annular velocity at the tricuspid level of the RV free wall (St). RV Tei index (RVTei) was used as a measurement of global (systolic and diastolic) RV function. It was calculated using the TDI-derived isovolumic contraction (IVC), isovolumic relaxation (IVR) and ejection time (ET) intervals (measured at the lateral part of the tricuspid annulus) as previously described [29]. RV systolic pressure was calculated by the systolic gradient of the tricuspid regurgitation jet (TRJG) and using the simplified Bernoulli equation [30]. Due to the absence of an adequate tricuspid regurgitation jet in most patients, the RV outflow tract acceleration time/ejection time ratio (ATET) [31], the LV systolic eccentricity index (LVEI) [32], and the presence of septal flattening at the end of systole on the qualitative assessment were also used as indicators of RV systolic pressures [30]. The LVEI was also used as a measurement of leftward displacement of the interventricular septum (IVS).

2.3.2. Left-Sided Echocardiographic Assessment

The LV end-diastolic diameter (LVEDD) was used as an indicator of LV dilation. The LV shortening fraction (LVSF) and the tissue Doppler imaging (TDI)-derived peak systolic annular velocity at the mitral level of the LV free wall (Sm) were used to assess LV systolic function. To assess the diastolic LV function, we obtained the mitral peak early (E) and late (A) diastolic velocity using the pulsed wave Doppler of the mitral valve inflow. Also, the TDI-derived early diastolic mitral annulus velocity (Em) was measured at the lateral part of the mitral annulus. The E/Em ratio and E/A ratio were calculated as indicators of LV filling pressures. LV Tei index (LVTei) was used as a measurement of global (systolic and diastolic) LV function. It was calculated using the TDI-derived isovolumic contraction (IVC), isovolumic relaxation (IVR) and ejection time (ET) intervals (measured at the lateral part of the mitral

annulus) as previously described [29]. Cui and Robertson reported in 2006 that the mean normal value of the LVTX for infants aged 1–12 months is 0.35 (0.09), and that a LVTX less than 0.5 is the upper limit of normal (2Zscore) [33]. Therefore, a LVTX > 0.5 was defined as LVMD in this study.

2.4. Reproducibility

To explore intra-observer and inter-observer agreement, 30 echocardiographic studies were randomly selected and analysed offline. To estimate the intra-observer agreement, the first observer (RGM) remeasured the LVTX, RVTX and LVEI with a 30-day interval blinded to previous measurements and patient information. To assess the inter-observer agreement, the means of both observers for each measurement were compared.

2.5. Statistical Analysis

Continuous data are presented as the median (range) or mean (standard deviation) after testing for normality with the Shapiro–Wilk test; categorical data are presented as frequencies and percentage. Mean comparison was performed using the Student’s *t* test or Wilcoxon Mann–Whitney test as appropriate. Proportions were compared using the Chi-square test or exact methods as necessary. Pearson and Spearman coefficients were used to assess correlations between continuous data. A receiver operator curve (ROC) analysis was used to determine the diagnostic accuracy of NT-proBNP for LVMD. The best cut-off value of NT-proBNP to detect LVMD was empirically estimated based on the Liu method, and values of sensitivity (Se), specificity (Sp), negative predictive value (NPV) and positive predictive value (PPV) were calculated for the obtained cut point. We selected 2 predefined predictive models for PICU admission. The selection of the included variables was based on the theoretical background and the exploratory analysis. Model 1 (proposed model) included age, BROSJOD score and NT-proBNP levels and model 2 (traditional model) included age and BROSJOD score. Prediction models were evaluated through multivariate logistic regression analysis. The discriminating ability of each model was assessed by the area under the receiver operator characteristic (AUC) curve. The AUCs from the obtained models were then compared by using the DeLong method [34] to determine whether any model resulted in increased predictive accuracy. The reliability of echocardiographic measurements was evaluated with the intra-class correlation (ICC) coefficients and Bland–Altman (BA) analysis [35]. Based on the 95% confident interval of the ICC coefficients, values less than 0.5, between 0.5 and 0.75, between 0.75 and 0.9, and greater than 0.90 were considered indicative of poor, moderate, good, and excellent reliability, respectively. All the statistical analyses were performed using the Stata 13.0. (StataCorp. 2013. Stata Statistical Software: Release 13. College Station, TX: StataCorp LP.). A *p* value < 0.05 was considered statistically significant.

3. Results

3.1. Baseline Characteristics and Outcomes of Patients with RSVB

We enrolled a total of 50 cases of RSVB with a median age of 2 (1–6.5) months (40% female). The control group consisted of 50 healthy infants with no differences regarding age, sex or body surface area (BSA) distribution (Table 1). RSVB patients were admitted 2.76 (1.23) days after the initial symptoms, with a median BROSJOD score of 6 (1–14), a median SpO₂ of 93% (87–98%), and a median heart rate of 118 bpm (89–179 bpm). Up to nine (18%) cases presented RA and a BROSJOD score > 10. A total of 10 (20%) cases needed PICU admission within 1.20 (0.38) days from hospitalization (length of PICU stay 5 (2–9) days) and were classified as having severe RSVB. A total of 3 of these 10 cases required MV and seven of them required continuous positive airway pressure (CPAP). No cases of arrhythmia different from sinus tachycardia were observed. No patient required inotropic support and none of the included patients died.

3.2. Echocardiographic Alterations in Patients with RSVB

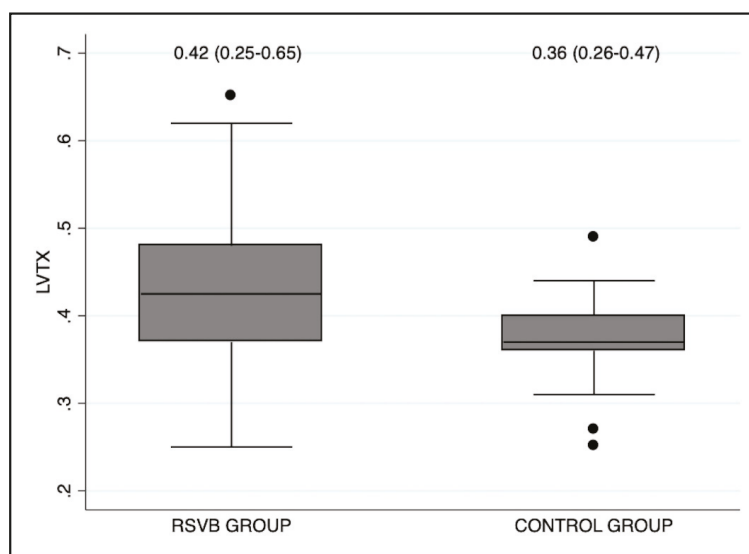


Figure 3. Box-plot diagram showing that the cases of RSVB presented higher values of LVTX at admission than healthy controls ($p = 0.008$). LVTX (Left ventricular Tei index).

The RSVB group had a higher proportion of pericardial effusion (34% vs. 6%; $p < 0.001$). All cases of pericardial effusion were mild and did not require any treatment. We observed higher values of LVTX (0.42 vs. 0.36; $p = 0.008$) in infants with RSVB than in controls (Figure 3). The RSVB group also presented more cases of septal flattening (28% vs. 6%; $p = 0.003$), and higher TRJG (27 vs. 22 mmHg; $p = 0.013$), RVTX (0.39 vs. 0.36; $p = 0.005$) and LVEI (1.08 vs. 1; $p < 0.001$) than the control group. There were no differences between RSVB and control groups regarding echocardiographic parameters of ventricular dimensions, systolic or diastolic function (Table 2).

3.3. Adverse LV–RV Interactions in Patients with RSVB

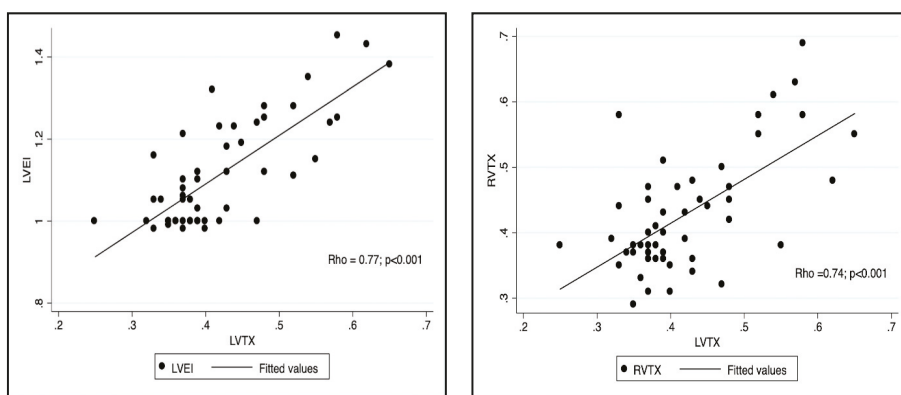


Figure 4. A representation of the correlation found between LVTX and parameters of RV function (RVTX, right panel) and RV pressures (LVEI, left panel). LVTX (Left ventricular Tei index). RVTX (right ventricular Tei index). LVEI (systolic left ventricular eccentricity index).

In the RSVB group, increased LVTX was related to echocardiographic parameters indicating higher RV dimensions (*Rho* RVDD = 0.56, *Rho* RVLVr = 0.60), higher RV pressures (*Rho* TRJG = 0.54, *Rho* ATET = −0.50, *Rho* LVEI = 0.77), and decreased RV global function (*Rho* RVTX = 0.74). We did not find associations of echocardiographic measurements of RV systolic function (TAPSE and St) with LVTX (Table 3 and Figure 4).

3.4. LVMD in Patients with RSVB

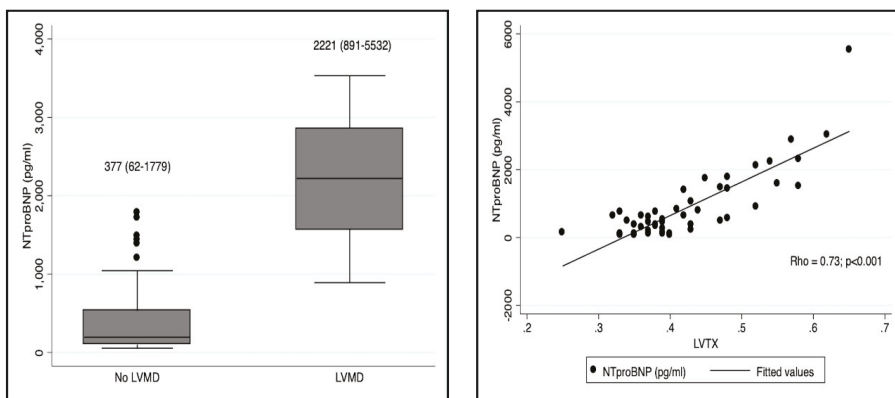


Figure 5. The left panel is a box-plot diagram representing the comparison of NT-proBNP levels between patients with and without LVMD. The right panel represents the correlation found between LVTX and NT-proBNP levels. LVTX (Left ventricular Tei index); LVMD (Left ventricular myocardial dysfunction).

We found LVMD, defined by a LVTX > 0.5, in nine (18%) patients with RSVB (Table 4). LVMD was associated with PICU admission (89% vs. 5%; $p < 0.001$). These patients presented with a higher BROSJOD score (11 vs. 6; $p < 0.001$), lower SpO2 (90% vs. 94%; $p < 0.001$), more cases of RA (55% vs. 9%; $p = 0.001$), and higher NT-proBNP levels (2221 pg/mL vs. 377 pg/mL; $p < 0.001$) than those with a normal LV myocardial function. The LVTX was also strongly correlated with NT-proBNP levels ($Rho = 0.73$) (Figure 5).

3.5. NT-ProBNP as Biomarker for LVMD

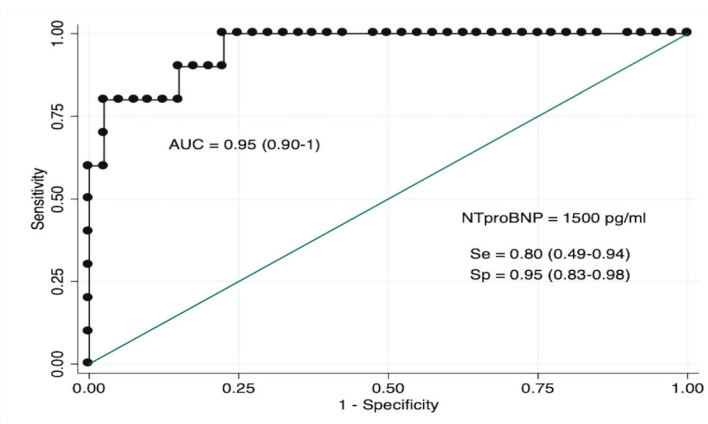


Figure 6. Representation of the receiver operating characteristic curve of NT-proBNP to detect LVMD in infants with RSVB. LVMD (Left ventricular myocardial dysfunction).

The diagnostic performance of NT-proBNP to predict LVMD in infants with RSVB resulted in an area under the ROC curve of 0.91 (CI95% 0.79–0.98) (Figure 6). The best estimated cut-off value to predict LVMD on echocardiography was 1500 pg/mL, correctly classifying 92% of cases, with a Se of 0.80 (CI95% 0.49–0.94), Sp of 0.95 (CI95% 0.83–0.98), a PPV of 0.80 (CI95% 0.49–0.94), and an NPV of 0.95 (CI95% 0.87–0.99) (Youden index 0.75).

3.6. Clinical and Laboratory Predictors of PICU Admission in RSVB

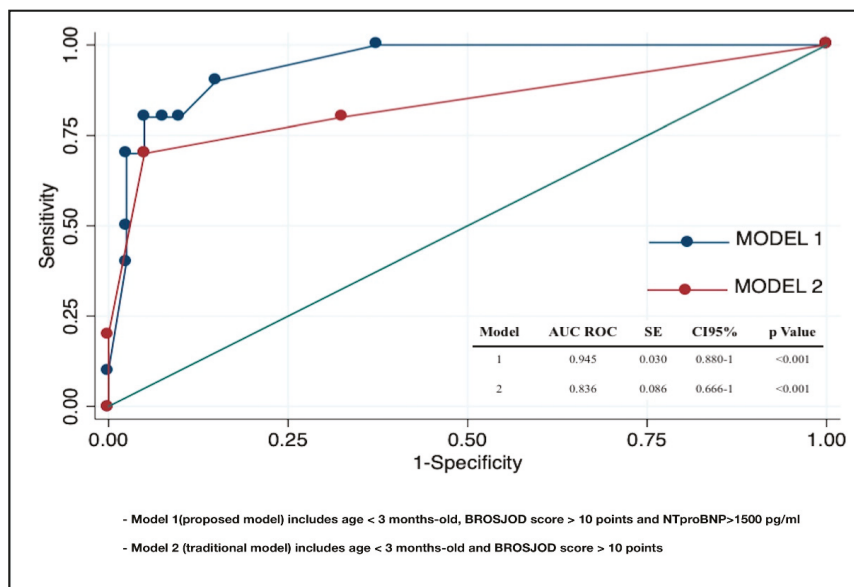


Figure 7. Graphical representation of the comparison between the areas under the receiver operator characteristic curves of the predictive models selected.

We developed two different and predefined prediction models for PICU admission in RSVB. The variables used were clinical parameters that are traditionally used to assess severity in RSVB (age and clinical score), and NT-proBNP as biomarker for LVMD. Model 1 (the proposed model) included age < 3 months, BROSJOD score > 10, and NT-proBNP > 1500 pg/mL. Model 2 (the traditional model) included age < 3 months and BROSJOD score > 10. The diagnostic yield of model 1 for PICU admission was excellent (AUC 0.945, CI95% 0.880–1), and significantly higher than the yield for model 2 ($p = 0.026$). In

model 1, the presence of NT-proBNP levels > 1500 pg/mL was the only independent predictive factor for PICU admission in RSVB, with an OR 27.03 (CI95% (1.50–487), $p = 0.025$) (Table 5 and Figure 7).

3.7. Reproducibility

The intra-observer and inter-observer agreement for LVTX, RVTX and LVEI were good or excellent, with all ICC coefficients > 0.75 (Table 6).

4. Discussion

The main finding of our study is that LVMD was observed at the early stages of the disease in up to 18% of previously healthy infants with RSVB when assessed by DTI-derived LVTX. The LVMD was associated with a more severe respiratory state, PICU admission, and echocardiographic signs of RV pressure overload and RVMD, indicating the presence of adverse RV–LV interactions in cases of severe RSVB. Also, we observed that NT-proBNP accurately identified LVMD. Moreover, we found an added benefit to the addition of NT-proBNP to the clinical evaluation in predicting the development of severe disease in this population.

CHD is an important cause of morbidity and mortality in RSVB [5]. This may be related to multiple physiological factors including baseline compromised cardiorespiratory function and the potential development of PH. However, little is known about LVMD and its association with RV function, pulmonary hemodynamics, and outcomes in previously healthy infants with RSVB. In accordance with the literature, the present study reveals that conventional parameters of myocardial function are not altered in RSVB [17–19]. Only one previous study has assessed myocardial performance using the TEI index in RSVB [12]. Our results are consistent with those reported by Thorburn et al. who found RVMD in ventilated patients with severe RSVB. However, they did not demonstrate any association between PH and RVMD. This may be due to the use of TRJG alone as an echocardiographic marker of RV pressure, and the presence of PH may have been underestimated. In a recent work from our group, we used a combination of different echocardiographic parameters to assess RV pressures and PH was reported in up to 22% of RSVB cases at early stages of the disease. In agreement with Thorburn et al., we did not find an association between PH and RV or LVMD [13]. We assessed ventricular function only by conventional parameters (TAPSE and LVSF).

To the best of our knowledge, this is the first study to evaluate LVMD using TDI-derived LVTX, and to assess RV–LV interactions in infants with RSVB. LVTX, which includes both systolic and diastolic time intervals to assess the global cardiac dysfunction, is an easily performable, recordable and reproducible parameter with normal reference values that can be applied to the entire spectrum of the paediatric population, regardless of age, heart rate, and BSA [36]. Using LVTX, we found LVMD in nearly 20% of cases. The RV shares muscle fibres, the inter-ventricular septum (IVS), and the pericardial sac with the LV. Consequently, changes in RV affect the LV, a concept termed ventricular interdependence [16,37,38]. In this study, we observed a moderate to strong correlation between LVTX and leftward displacement of the IVS (LVEI), raised RV pressures (TRGJ, ATET) and reduced RV global function (RVTX), confirming the presence of adverse RV–LV interactions in cases with severe RSVB. These results do not imply causality, but in the absence of primary (myocarditis, cardiomyopathies, CHD) or secondary (sepsis, severe acidosis...) causes of LVMD, we suggest RV pressure overload and RV dysfunction due to pulmonary disease as the underlying condition for LVMD in our RSVB cohort. Recent paediatric studies have reported that PH can induce complex changes in LV geometry and causes an abnormal relaxation and non-uniform contraction pattern in the LV wall, leading to LVMD [14–16], supporting our hypothesis. These observations could add new insights into the pathophysiology of RSVB, highlighting a key role of the cardiovascular system, especially LV myocardial performance in

this setting. Validating our findings in similar populations in different settings may also provide a basis to implement new therapeutic approaches for this disease, which currently has no effective treatment. Possible new therapeutic approaches may include the initiation of early respiratory support in cases with increased NT-proBNP, pulmonary vasodilators to reduce RV pressure overload and avoiding epinephrine in cases with LVMD.

In RSVB, the major goals are the prevention and early identification of infants at risk for severe disease in order to provide the best management options and decrease morbidity. Current guidelines recommend only clinical observation for this purpose in infants without known comorbidities [3]. However, most clinical scores for RSVB are not well validated and fail to predict outcomes [39,40]. Recently, the BROSJOD score, a validated clinical score for RSVB, has shown a strong capacity to predict the evolution in the course of RSVB, but it is not yet generalizable due to the single-centre character of the study [26]. In this context, the identification of novel biomarkers with adequate predictive value for disease severity in RSVB is an area of increasing research interest. Neutrophins, cytokines and leukotrienes are promising but not widely available for clinical practice [41]. Previous studies have also tested cardiac troponin as a prognostic marker with inconsistent results [9,10,12,13]. The LVMD found in our population was only identifiable by TDI-echocardiography, suggesting that it was mild in most of our patients. Nevertheless, this does not mean that LVMD is inconsequential in RSVB. Remarkably, most patients with LVMD presented with severe disease at admission and most of them required PICU admission. Of note, we included non-ventilated infants at early stages of the disease (mean time of 2.76 (1.23) days after the initial symptoms), when the patients had not yet been admitted to the PICU, increasing the prognostic value of our results. Therefore, assessing and understanding myocardial function in RSVB seems to be relevant.

Another interesting finding of our study was that NT-proBNP could be a useful biomarker for LVMD and subsequent outcomes in RSVB. Previous studies have also documented the correlation between LVTX and NT-proBNP plasma levels [42–44]. We explored the diagnostic accuracy of NT-proBNP to detect LVTX > 0.50, which was high (AUC 0.91), with an optimal cut-off value of 1500 pg/mL (Se 0.80, Sp 0.95, PPV 0.80, NPV 0.95). We also tested the benefit in adding NT-proBNP to the currently used clinical data to assess outcomes in RSVB. Although the predictive models including age and BROSJOD score presented a high predictive accuracy for PICU admission in our population, we observed that the addition of NT-proBNP to this model increased the predictive value significantly, and that NT-proBNP was the only independent factor within the analysed values that predicted a severe course of the disease. Most cases of RSVB are mild forms manageable on an outpatient basis without the need for laboratory exams. Nevertheless, many children sufficiently ill to require hospitalization will routinely have laboratory studies drawn. Adding NT-proBNP measurement to these studies could be useful in order to identify high-risk patients who benefit from echocardiographic screening to PH, RVMD or LVMD. Based on our results, it might be reasonable to perform an echocardiogram in those patients with NT-proBNP levels > 1500 pg/mL.

This work included some limitations. Our study was performed at a single centre and with a relatively small size. We excluded irritable or unstable patients, where the technical difficulties due to respiratory comorbidity and the patient's inability to tolerate the evaluation could impact the results. The PICU admission criteria and, subsequently, the definition of severe diseases in the study are based on the protocol of our hospital, which can vary between institutions. Therefore, a larger multicentre cohort study including irritable or unstable cases and with uniform PICU admission criteria may be needed for the verification and generalization of our results. Finally, the assessment of myocardial function and PH on echocardiography was not confirmed by an independent gold-standard method, such as cardiac magnetic resonance imaging or right heart catheterization, and therefore some patients could have been misclassified.

5. Conclusions

Adverse RV–LV interactions and LVMD could be present in healthy infants with RSVB during the early stages of the disease, negatively impacting the outcome. NT-proBNP seems to be an adequate biomarker for LVMD. Adding NT-proBNP to traditional clinical markers to assess outcomes in RSVB could improve the early detection of those cases that will develop a severe illness. Future research is needed in order to confirm these results and to design new therapeutic approaches based on them.

Subcutaneous and Mediastinal Emphysema Followed by Group A Beta-Hemolytic Streptococci Mediastinitis. A Complicated Course after Adenotonsillectomy: Case Report

Abstract: Tonsillectomy is a commonly performed surgery in the daily practice of an otorhinolaryngologist. For patients as well as health professionals, the best known complication is post-operative bleeding. Among the less noted, but potentially life-threatening, complications are the development of subcutaneous emphysema and the presence of bacteremia due to group A hemolytic streptococci. In this report, we describe a severely complicated clinical course after an uncomplicated adenotonsillectomy in a young boy. Increased awareness of relatively unknown complications after adenotonsillectomy amongst surgeons, pediatricians and anesthesiologists is desirable to facilitate rapid diagnosis and adequate treatment in order to prevent life-threatening situations.

Keywords: tonsillectomy; subcutaneous emphysema; mediastinal emphysema; mediastinitis; complication; bacteremia

1. Introduction

Adenotonsillectomy is one of the most frequently performed surgical procedures in the daily practice of an otorhinolaryngologist, especially in children. Nevertheless, the operation is associated with several severe pre- and post-operative complications. According to literature, primary or secondary bleeding, pain and temporary taste disorders are the most common complications [1–5]. In the Netherlands, according to the national guideline, potential postoperative bleeding and taste disorders are obliged to be mentioned by the otorhinolaryngologist during the pre-operative intake [2,3,6,7]. Other less frequent complications include damage to teeth, otalgia, lingual edema, injury to the glossopharyngeal nerve and injury to the carotid artery [4]. Infectious complications are not frequently reported but can be serious in case of bacteremia [8]. Furthermore, a known but rare and potentially life-threatening complication is the development of (cervico)facial subcutaneous and/or mediastinal emphysema [9–13].

In this case report, we describe the case of a young boy with cervicofacial subcutaneous and mediastinal emphysema after adenotonsillectomy followed by a serious systemic infection caused by group A beta-hemolytic streptococci. We will summarize the current literature on cervicofacial subcutaneous and/or mediastinal emphysema and infectious complications after adenotonsillectomy.

2. Case Report

A 22-month-old boy with Down syndrome was admitted to our department for elective adenotonsillectomy because of sleep apnea due to adenoidal and tonsillar hypertrophy.

Despite conservative treatment for the previous five months with nasal rinsing and intranasal steroid spray, his symptoms had deteriorated and he was indicated for surgery with post-operative observation overnight. Except for the presence of habitual belching, his medical history revealed no other abnormalities.

After a nontraumatic and uneventful orotracheal intubation, guillotine adenotonsillectomy was performed under general anesthesia. Hemostasis was achieved by dry gauze compress on both sides, no bipolar cautery was necessary. Both tonsils were easily removed without remarkable adhesions and there was no excessive bleeding during or after the procedure. Our patient was monitored in the recovery room and discharged to the ward after 40 min.

The next morning during visitation rounds, the patient's dismissal home was postponed due to inadequate fluid intake. The physical examination and vital signs showed no aberrant findings. In the afternoon the patient was reassessed because of a swelling on the right side of his face. His vital signs were normal and there was no fever or difficulty breathing. Further physical examination showed facial swelling on the right side and crepitus was felt during palpation. There were no signs of cellulitis. Oral examination of the tonsil bed revealed normal wound healing without obvious mucosal tears. Ultrasound confirmed the presence of subcutaneous emphysema.

The progression of the emphysema quickly resulted in signs of an obstructed airway with a saturation of 81% SpO₂ and the use of accessory muscles of respiration. The patient was quickly transferred to the pediatric intensive care unit where he was intubated. Shortly after successful intubation, the patient went in cardiac arrest and 2 min of cardiopulmonary resuscitation was performed. Bedside evaluation ruled out pneumothorax, cardiac tamponade, hypoxia or airway obstruction and hypovolemia. Cardiac ultrasonography showed a diminished ventricular function.

Blood tests showed white blood cell count of 0.78×10^3 /uL and a C-reactive protein of 142 mg/L. Blood cultures were positive with group A beta-hemolytic streptococci. A computed tomography scan (Appendix Figure A1) revealed mediastinal infectious infiltration besides subcutaneous emphysema. In retrospect, the cause of the cardiopulmonary arrest turned out to be due to sepsis/mediastinitis.

Our patient was treated with broad spectrum antibiotics, inotropes and intravenous immunoglobulin. The further course was uneventful. The subcutaneous emphysema resolved over the following days and the patient could be extubated 6 days after admission to the PICU. Finally, 15 days after surgery he was discharged home. Fortunately, follow-up consultations showed no neurological residual symptoms.

3. Discussion

Subcutaneous emphysema has been described in the literature as a complication following tonsillectomy. The seriousness of emphysema varies and includes bilateral cases, pneumomediastinum, pneumothorax and even pneumoperitoneum.

Massive emphysema can compress the trachea, especially in young children, since their tracheal rings are soft. Due to the connection between the parapharyngeal and retropharyngeal space, emphysema can subsequently spread to the mediastinum, causing a pneumomediastinum and even pneumothorax, with major respiratory consequences [14,15]. The typical clinical finding by physical examination is crepitus on palpation. Other diagnoses such as hematoma, allergic reaction or necrotizing fasciitis have to be excluded.

The latter is especially important to distinguish, since rapid treatment with intravenous antibiotics and surgical debridement can be curative. Local tenderness and erythema with variant vital signs are warning signs of infection [16].

It has been suggested that patients with severe adhesions of the tonsil to the superior constrictor muscle, for example after recurrent tonsillitis or peritonsillar abscess, are more prone to develop postoperative subcutaneous emphysema. Due to the adhesions, the dissection of the tonsils from the tonsillar bed can be difficult, increasing the risk of injury to the tonsillar fossa [12]. Accordingly,

assuming that removing pediatric tonsils is easier, we found only three cases of pediatric patients with subcutaneous emphysema since 2000, with ages of 6, 7 and 11 years [15,17,18].

Although the exact pathophysiological mechanism is still unknown, “ascending” and “descending” routes are described [9,17,19].

In the ascending mechanism, a rupture occurs anywhere along the tracheobronchial tree from a pre-existing abnormality such as an alveolar bleb or laryngocele or from an acquired defect from traumatic intubation. Following excessive positive pressure ventilation or because of increased intrathoracic pressure, the pre-existing defect can rupture causing the entry of air into the peritracheal or perialveolar tissue. In the case of an alveolar rupture, air can pass through the perivascular sheaths into the mediastinum. Through the subfascial tissue, air can ‘ascend’ to the subcutaneous tissues of the neck and facial area [17].

In the descending pathway, subcutaneous air infiltration into the pharyngeal space is caused by deep dissection into the tonsil fossa, causing a breach of the superior constrictor muscle and the underlying fascia. Increased intrathoracic pressure (coughing, vomiting, physical exertion, straining and/or manual positive pressure mask ventilation) allows air to migrate through the defect.

Since the subcutaneous emphysema was initially limited to our patient’s face and there was a nontraumatic intubation, we consider the ‘descending’ pathway to be more likely.

The habitual belching also supports the presence of the descending mechanism.

In order to prevent the occurrence of subcutaneous emphysema, it is important to perform careful surgery. In our patient, we performed a tonsillectomy using the Guillotine technique, according to the Dutch guideline. The aim, as in all techniques, is to remove the tonsils completely with minimal hemorrhage and minimal postoperative complications [20]. However, to date there is no international consensus on which technique is best to perform a tonsillectomy. In the case reports describing the development of subcutaneous emphysema, different techniques were used (i.e., electro-dissection with bipolar scissors, tonsil dissector, Ultracision Harmonic scalpel and cold steel elevators). Conclusions about the used technique and its role in the development of subcutaneous emphysema cannot be made. A tonsillotomy (intracapsular, partial or subtotal tonsillectomy), in which the tonsil parenchyma is removed without damage to the tonsillar fossa and the superior constrictor muscle, might minimize the risk of postoperative subcutaneous emphysema [20,21]. Furthermore, if possible, patients can be instructed to avoid activities that increase intrathoracic pressure. Unfortunately, our patient could not repress the belching.

The treatment of subcutaneous emphysema is mostly conservative but includes broad-spectrum antibiotics to prevent infection from the oral cavity. In case of an evident mucosal rupture, reparation of the damage is recommended. Medication to suppress increasing intrathoracic pressure, such as anti-emetics, codeine or stool softeners can be prescribed [9]. In most cases the subcutaneous emphysema resolves spontaneously and no further treatment is necessary. Of the 43 cases described in a review by Saravakos, three patients needed re-intubation, one patient required temporary tracheostomy to secure their airway and three patients underwent thoracotomy for air drainage out of the mediastinum [9,10,18,22–25].

Our patient was intubated because of progressive, airway-obstructing emphysema, but despite effective airway management he deteriorated due to a systemic infectious disease.

Bacteremia after tonsillectomy has also been described and is relatively innocent in most cases. According to the literature, transient bacteremia occurs in 22% to 70% of all post-tonsillectomy patients and generally ceases within 20 to 40 min in healthy patients [26]. The most commonly responsible micro-organism is the *Haemophilus influenzae*. Although group A beta-hemolytic streptococci are frequently found in local tonsillar oropharyngeal cultures, they are rare in blood cultures and we found only two previous cases describing the presence of a severe systemic group A streptococcal infection in otherwise healthy patients after tonsillectomy. In the first case, a four-year-old girl developed a severe streptococcal septic shock syndrome the night after surgery. In the second case, a four-year-old boy revealed invasive streptococcal infection symptoms 5 days after surgery. He died 4 days after

re-admission due to a ruptured mycotic aneurysm of the ascending aorta and hemorrhagic pericarditis caused by group A streptococcal sepsis [8].

Invasive infections with group-A-streptococci can be devastating due to endotoxin release resulting in a septic shock syndrome. The overall mortality of such streptococcal septic shock syndrome is around 50% [27].

Although rare, serious infectious complications after tonsillectomy can occur and should be kept in mind. Prompt recognition and treatment are necessary. Authors should discuss the results and how they can be interpreted in the context of previous studies and of the working hypotheses. The findings and their implications should be discussed in the broadest context possible. Future research directions may also be highlighted.

4. Conclusions

We described a severely complicated clinical course after an uncomplicated adenotonsillectomy. Since the development of subcutaneous emphysema as well as the presence of a group A hemolytic streptococci bacteremia after tonsillectomy are both rare but life-threatening complications, we should all be aware of their (co-)existence. Intensive co-operation by surgeons, pediatricians and anesthesiologists is necessary for fast and adequate diagnosis and treatment to prevent further damage.

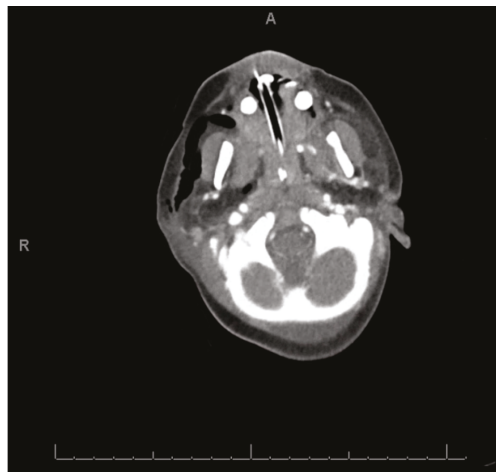

Fine Needle Aspiration Cytology for Neck Masses in Childhood. An Illustrative Approach

Abstract: The primary indication of fine-needle aspiration cytology of the head and neck region is a thyroid nodule or a mass located in the cervical area or the head. Although a thyroid nodule may raise the suspicion of malignancy, less than one in 20 cases results in a carcinoma. In addition, the list of differential diagnoses is quite different according to the age of the patient. A number of benign lesions, such as branchial cysts, sialadenosis, and sialoadenitis are often seen in childhood and youth. The malignant lesions that are on the top of the list of a pediatric mass of the head and neck (H&N) region include rhabdomyosarcoma, neuroblastoma, and papillary carcinoma of the thyroid gland. This critical review of the diagnostic features of a pediatric mass of the H&N region is accompanied by panels of several cytology features that may be of help to the cytopathologist and clinician.

1. Introduction

In the era of transcriptomics and advancements identified at increasing pace in this 2nd decade of the 3rd millennium, an apparently simple approach with a needle, a slide, and some staining tools may be awkward. It seems that the fine needle aspiration biopsy was performed first in 1857, although several techniques and new protocols have transformed this seemingly simple procedure into a practice that is impressively diffuse worldwide. Aside from scarring in some patients, there are complications due to unnecessary surgery which is well known to many pediatricians. In adults, fine needle aspiration cytology (FNAC) has been used with great success as the primary screening test for thyroid nodules [1–3]. In non-thyroid nodules, FNAC has also increased rates of sensitivity and specificity in numerous studies [4]. However, such a structured approach has remained unused in the evaluation of pediatric nodules and instead, urgent analysis using scalpel and surgery is performed. This critical review of the literature highlights the information we can receive using FNAC in pediatrics and shows some illustrative cytologic features that may be extremely useful for both training or experienced cytologists and pediatricians. The present study was designed to critically review the role of FNAC and its utility in pediatric head and neck (H&N) lesions. It is not a comprehensive atlas and has no aim to fill all gaps of the H&N lesions in pediatrics, which are covered in excellent texts and books. Nevertheless, our paper emphasizes the procedure and specifies the spectrum of the H&N lesions in the pediatric age group, highlighting some studies gathered from the literature comparing cytology and histology of the H&N lesions.

2. Methodology

A neck mass that is resistant to antibiotics for more than four weeks should be considered the primary indication to proceed with non-thyroid FNAC. Other signs should also include cases of asymmetric benign lymphadenopathy as well as cervical lymph nodal enlargement showing

unusual location, fast expansion, evidence of weight loss or loss of appetite, and night sweats. The identification of skin changes and/or a fixed/immobile mass may favor a malignant lesion and is also an indication to proceed with FNAC. An FNAC with a critical result may often be managed in our institution within a few hours planning for surgery to be performed in the same day or the day after. Nonthyroidal FNAC should be conducted while keeping in mind that the patient may be a potential surgical candidate. Other indications for an FNAC may involve an atypical presentation with systemic symptoms; the urgency made clear by the medical team or family and the willingness to diagnose the lesion before the typical 2–7 days of surgical processing. In consideration of the high percentage of papillary thyroid carcinomas in childhood and youth, FNAC should be offered as the first procedure for all pediatric thyroid nodules following an ultrasound scan showing a lesion with a diameter of 1 cm or more. In the case of pediatric thyroid nodules with lesions measuring less than 1 cm in diameter, an FNAC with a critical result processing (same day or day after or within 24 h) should be offered in the event that concerning ultrasonographic results are present. Ultrasound anomalies will include hypoechogenicity, irregularity of the margins, or increased vascularity of the lesion. FNAC is usually performed in the Otolaryngology/ear-nose-throat (ENT) clinical department or inpatient ward by specialized and well-trained personnel, including a cytopathologist, an interventional radiologist, or a (pediatric) surgeon. Topical (4% lidocaine cream) anesthesia is used with some general low sedation, and all biopsies should be performed using image guidance. In our opinion, the practice to use palpation should be discouraged or left to very palpable nodules to reduce the annual false negativity rate [5–7]. The procedure involves the use of a 25- to 27-gauge needle, and a range of 3 to 5 passes are performed for each targeted site, representing a single FNA procedure. If a patient has multiple targeted nodules or masses, various aspirates are usually performed at the discretion of the medical personnel. The aspiration of the material is then used for smear preparation, which includes air-dried slides stained with Diff-Quik and alcohol-fixed slides stained with the Papanicolaou stain. It is paramount to perform additional testing at the same time to avoid unnecessary delay in the diagnosis. In fact, residual material is typically used for ThinPrep processing (Hologic Inc., Marlborough, MA, USA), microbiology, and molecular biology studies. To confirm whether the material is adequate in a lymph node, a small drop of the aspirate is placed onto the preparation slides for immediate assessment (also technically labelled ‘rapid on-site evaluation’), while the remainder is rinsed in a cell preservative. Typically, 10 million cells are considered adequate for cytopathology assessment, which requires 2–3 passes indeed.

The cell block preparation is routinely performed in our institution and not only in case of ambiguous interpretation of the aspirates. It is also important to advise the lab technician to stain some tissue sections of the cell block with hematoxylin-eosin and keep some unstained tissue sections for histochemical (special) stains, immunohistochemical stains, and further ancillary testing as required. The cytology aspirates are interpreted initially by a cytotechnologist and subsequently by a pediatric pathologist with an intra-institutional cytopathology consultation adjudged by a cytopathologist. FNAC cases receive diagnoses with an adequacy interpretation (unsatisfactory, satisfactory), a primary interpretation (nondiagnostic, negative for malignant cells, atypical cells present, suspicious for cancerous cells, or positive for malignant cells), and a free text explanatory diagnosis. The category ‘less than optimal’ is not often used in our institutions to avoid non-categorical decisions.

It is also advisable to perform a yearly outcome rating using spreadsheet-based correlation to surgical histopathology and clinical follow-up. In the case of clinical monitoring, laboratory values and clinical presentation are part of a 6-month–1-year follow-up, while surgical histopathology, which is based on either an incisional surgical biopsy or an excisional surgical biopsy, is considered the reference standard in the diagnosis of tumors of the H&N region. In the setting of a quality assurance program, true positives are cytopathologic results that warrant surgical treatment and are confirmed as such using surgical histopathologic biopsy. True negatives are cytopathologic results that did not designate a need for surgery and are established as such using the surgical histopathologic biopsy. Clinical true negatives are negative conditions on cytology that resolve or did not progress without surgical

intervention. In case of false positives cytology, cytopathology results are positive, but there would have been no need for surgical treatment, while false negatives are unremarkable cytopathologic results without a need for surgery, although a surgical intervention would have been the right option. To avoid bias in any cytology-pathology correlation quality assurance program, it is prudent that pathologists interpreting surgical histopathology slides are distinct from cytopathologists interpreting the FNAC. Some infective or non-malignant conditions, such as atypical mycobacterial infection, cervicofacial abscess, or lymphatic malformations, may require surgical diagnosis or treatment but may also appropriately be managed by medical therapy. If the appropriate medical treatment is initiated and results efficacious and efficient, the result is labeled as an actual clinical positive. The 2015 Standards for Reporting of Diagnostic Accuracy (STARD) guideline for reporting diagnostic accuracy studies should be used [8].

In the setting of procedure complications, care should be taken when considering the side effects of FNAC, e.g., infection and damage to nearby structures. By reviewing the literature, we found a limited core of evidence for such side effects if a safe procedure is applied. In particular, an honest and straightforward report provided by Chen et al. [9], who reported a 19-year-old girl with a painful goiter, which became more painful after fine needle aspiration (FNA). The patient's second FNAC revealed only many neutrophils and an antibiotic treatment improved the pain, but the goiter persisted. The third FNA revealed cytology of papillary carcinoma cells and the total thyroidectomy showed ischemic necrosis with neutrophilic aggregation around the needle track other than a papillary thyroid carcinoma. This report reveals the possibility of missing malignant cells in a background of an infection following an improper FNA. Secondary infection and ischemic necrosis may indeed occur after FNA, and aseptic procedures are necessary to prevent bacteria from seeding into the thyroid gland. Disinfection of the FNAC site and experienced personnel are mandatory for laboratories that harbor periodic accreditation by the College of the American Pathologists (CAP) operating in healthcare institutions in United States of America and Canada. Thus, side effects may occur following an FNA procedure. Nevertheless, we consider that FNAC in children and adolescents is accurate, safe, and well-accepted in a wide range of lesions of the head and neck regions. A CAP accreditation or a similar accreditation outside of North America should be requested by all pediatricians and parents of the affected child.

3. Diagnostics

In most of the cases, FNAC of the H&N region is performed to investigate clinically suspicious lymphadenopathy, and the primary differential diagnoses include congenital anomaly, reactive/infectious lymphadenopathy, lymphoma, and metastatic disease, but also thyroid gland disease and salivary gland disease.

3.1. Congenital Lesion

The age is also particularly important to keep in mind, and 75% of branchial cysts occur in 20–40 year-old patients [10–14]. Benign squamous-lined cysts are usually characterized by abundant inflammatory cells (neutrophils), with few unremarkable squamous epithelial cells with bland nuclear features, and cholesterol crystals, while a large number of squamous cells with or without occasional nuclear hyperchromasia, nuclear membrane irregularity, and high nucleus to cytoplasm ratio portend for a malignant diagnosis.

3.2. Reactive/Infectious Lymphadenopathy and Malignant Lymphoma

In about 2/3 of cases, de novo lymphadenopathies of the H&N region are benign, and even a history of malignancy present in a child with a de novo lymphadenopathy will have a rate of benignancy probably approaching half of the cases [15,16]. Moreover, additional surgical procedures have been avoided in up to 61% of cases in one review [17]. The cytopathological diagnosis of reactive is mostly accurate in children and youth with less in 1 out of 20 (~5%) subsequent (false-negative)

malignant diagnoses [2,18]. Cytologic features of reactive lymphadenopathy include polymorphic lymphoid cells showing a clear-cut sequence of maturation, prominent reactive cells arising from germinal centers, the presence of tingible body macrophages, the lack of a monomorphic lymphoid population and the simultaneous presence of a variegated (non-homogeneous) cell population smear, and the lack of a subpopulation (even minimal) of large, irregular lymphoid cells potentially indicative of Hodgkin's lymphoma, anaplastic T-cell lymphoma, large B-cell lymphoma). Necrotizing granulomata are often characteristic of underlying tuberculous infection (particularly systemic), although they may also be found in fungal infection and other acid-fast bacilli (AFB) (e.g., mycobacteria causing scrofula). In a child, the finding of granulomata may suggest non-tuberculous AFB, especially in a child, and cat-scratch disease should be considered in this age group. Granulomas without evidence of necrosis are suggestive of sarcoidosis, toxoplasmosis, or foreign-body giant cell reaction. In all cases, a thorough microbiological investigation is paramount (e.g., *Bartonella henselae* for cat-scratch disease). The correlation between clinical and laboratory findings using electronic medical charts or liaising with the clinician is essential. In fact, serological tests may be useful in a subset of cases for differentiating systemic lupus erythematosus lymphadenitis from Kikuchi–Fujimoto's disease, which is histiocytic necrotizing lymphadenitis. Finally, it is important not to forget that a florid granulomatous pattern can mislead the cytopathologist disguising both Hodgkin's lymphoma and Non-Hodgkin's lymphoma.

3.3. Rhabdomyosarcoma and Neuroblastoma

In a pediatric setting, the most fearful malignant diagnoses in the H&N region, apart from malignant lymphoma, are rhabdomyosarcoma and neuroblastoma. Rhabdomyosarcoma is considered to harbor three main subtypes, including embryonal, which is the most frequent type, the alveolar, and the pleomorphic, which most commonly seen in adults. Rhabdomyosarcoma occurs very often in the head and neck region and the extremities, with the trunk reserved for the third location. Cytomorphology features of the embryonal rhabdomyosarcoma include a variability of patterns including round to spindle-shaped cells, some pleomorphism (different from the marked pleomorphism of the pleomorphic type of the rhabdomyosarcoma of the adult), a variable number of rhabdomyoblasts may be the distinctive clue for the cytopathologist, and, occasionally, inclusion-like cytoplasmic condensation, which is also known as myogenic differentiation [18]. Rhabdomyoblastic differentiation is characterized by elongated, strap- or tadpole-shaped cytoplasm, and nuclear eccentricity. The nuclear diagnostic clues also rely on dense hyperchromatic chromatin and nuclear membrane irregularity (Figure 1a,b). The alveolar rhabdomyosarcoma is distinctively identified by larger, uniformly round to variably polygonal cells with an increased number of mitotic figures in the background with scattered rhabdomyoblasts and giant cells with wreath-like nuclei. Metastatic neuroblastoma to the neck is quite rare in adulthood, but it is a principal differential diagnosis in infants and children, especially in infants. Although most neuroblastomas arise in the adrenal gland or the paravertebral sympathetic chain bilaterally, this pediatric tumor can occur anywhere along the sympathetic chain. Cytomorphology of neuroblastoma may be entirely different according to the degree of ganglionic differentiation of the neuroblastoma. These features include a fibrillary matrix, dyshesive small undifferentiated cells, sparse Homer–Wright rosettes, a nuclear pattern labeled as “salt and pepper” for the variability of the granularity of the nuclear chromatin, and, occasionally, ganglion-like cells (Figure 1c,d). In rare occasions, necrotic debris and dysmorphic calcifications are seen [18]. It is paramount to distinguish reactive/reparative changes from the diagnoses mentioned above [19] (Figure 1e,f). A spectrum of appearance needs to be kept in mind in case of benign fibrous proliferation. The retention of a low nucleus to cytoplasm ratio is crucial in case of prior radiation where cells may be large, showing irregularity of the nuclei, multinucleation, all features that may be quite worrisome. In fact, the resolution may decrease the inflammatory background, making the diagnosis particularly distressful for an inexperienced pathologist. Moreover, the myofibroblasts that occur in benign fibrous proliferations may become slender with less conspicuous nucleoli during the

healing process. In all cases, the identification of pleomorphism, nuclear hyperchromasia, high nucleus to cytoplasm ratio, and atypical mitoses suggest malignancy that needs to be surgically acted upon as soon as possible.

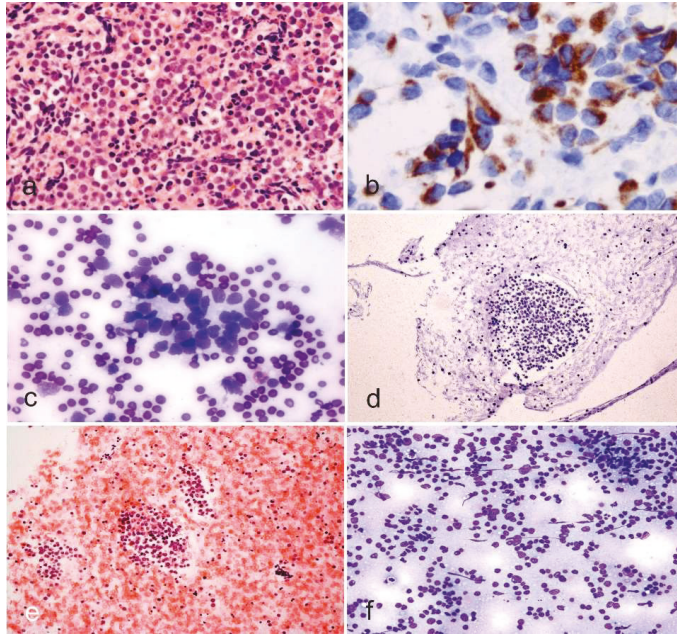


Figure 1. (a,b) Rhabdomyosarcoma cytology in cell block (Papanicolaou, $\times 200$) and smears fixed and immunostained with the antibody anti-desmin (Avidin-Biotin-Complex immunostaining, $\times 630$). (c,d) Neuroblastoma cytology in smears and cell block showing hyperchromatic cells with high nucleus to cytoplasm ratio (Diff-Quik, $\times 100$ and $\times 100$, c and d, respectively). (e,f) Reactive changes of soft tissue showing a mixture of cells with variable morphology (cell block and smears stained with Papanicolaou and Diff-Quik, $\times 100$ and $\times 100$, e and f, respectively).

3.4. Thyroid Gland Disease

The introduction of synoptic reports has been crucial in improving healthcare worldwide, allowing a common platform for adequately assessing patients with neoplastic disease. Thyroid cases receive an adequacy interpretation, a first interpretation using “The Bethesda System for Reporting Thyroid Cytopathology” (TBSRTC), and a free text explanatory diagnosis with a comment according to the pathologist or cytopathologist [2]. It is also encouraged that the cytopathologist or the pathologist liaise with the clinical team in case an FNAC may indicate suspicious malignant cells or some distinct cancerous cells. TBSRTC categories include insufficient for diagnosis, benign, atypical cells of undetermined significance, suspicious for a follicular neoplasm, suspicious for a Hürthle cell neoplasm, suspicious for malignancy (papillary carcinoma, medullary carcinoma, lymphoma, metastatic tumor, other), and malignant. Despite iodine supplementation, multinodular goiter (MNG) occurs in North America. MNG is a common disorder of the thyroid gland with multiple nodules [18]. The macrofollicular pattern of a follicular neoplasm is indistinguishable from MNG. Cytologically, a benign follicular nodule shows mainly macrofollicles, low/moderate cellularity, cohesive follicular cells with uniformity and even spacing, coarse chromatin, as well as colloid, which may be copious. The differential diagnosis of benign follicular nodules includes

suspicious follicular nodule, suspicious Hürthle cell nodule, and papillary carcinoma. In some benign nodules, focal cytologic atypia may be present and becomes a diagnostic challenge. Of note, Hürthle cell metaplasia is often seen in MNG and the cells may show at places marked nuclear atypia. Hashimoto or chronic lymphocytic thyroiditis is characterized by a mixed population of lymphocytes, tingible-body macrophages, dendritic-lymphocytic clusters, Hürthle cells and scant colloid. Hyperplastic Hürthle cells nodules may occur in Hashimoto thyroiditis mimicking a Hürthle cell tumor [18]. The differential diagnosis of Hashimoto thyroiditis includes a reactive lymph node, MNG with predominant Hürthle cell change, primary malignant lymphoma of the thyroid gland, Hürthle cell neoplasm, and papillary thyroid carcinoma. A subacute thyroiditis and Riedel disease are not a common event in pediatric age or youth. The category of suspicious for a follicular neoplasm has some cytologic features including marked cellularity, scant colloid, predominant microfollicles or epithelial trabeculae, and enlarged, crowded follicular cells (differently from the uniformity and even spacing of the benign lesions) [18]. In a pediatric setting, a suspicious for a follicular neoplasm poses a differential diagnosis of a benign follicular nodule, papillary thyroid carcinoma, and parathyroid adenoma or carcinoma. Other malignant masses have other distinguishing features in childhood and youth. A suspicious for Hürthle cell neoplasm diagnosis has cytologic features showing an almost complete cell population of Hürthle cells, usually dyshesive cells with prominent nucleolus, and pseudopsammoma bodies. Cytological features of papillary thyroid carcinoma include sheets, microfollicles, and papillae, although the nuclear changes need to be searched carefully. The nuclear changes include grooves, pseudoinclusions, “powdery” chromatin, and thickened and irregular nuclear membrane. There is also nuclear crowding or molding. Cells show a variable amount of cytoplasm and psammoma bodies may be present. The differential diagnosis of papillary carcinoma includes a benign follicular nodule, a follicular neoplasm, Hashimoto thyroiditis, radiotherapy effect, and a hyalinizing trabecular tumor. Although the anaplastic carcinoma does not play any role in childhood or youth, an important entity to keep in mind is the medullary carcinoma. Cytologically, this endocrine parafollicular cells derived tumor shows numerous isolated cells, loose aggregates of cells with epithelioid, plasmacytoid, or spindle-shaped morphology, nuclear changes (rounding or elongation, granularity of the chromatin, inconspicuous nucleolus, pseudoinclusions, and multiple nuclei), cytoplasmic changes (red granules) on Diff-Quik stained preparations, and amyloid. Although rare, two primary malignant lymphomas of the thyroid gland need to be kept in mind and include the diffuse large B cell lymphoma and the extra-nodal marginal zone B-cell lymphoma.

3.5. Salivary Gland Disease

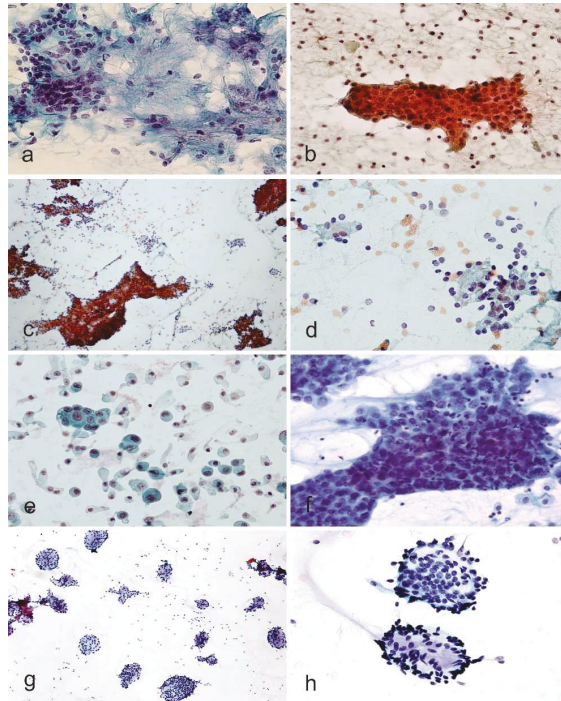


Figure 2. (a,b) Pleomorphic adenoma and Warthin tumor (Papanicolaou stain, $\times 100$ and $\times 100$, a and b, respectively). (c,d) Acinic cell carcinoma (Papanicolaou stain, $\times 40$ and $\times 100$, c and d, respectively). (e,f) Mucoepidermoid carcinoma (Papanicolaou stain, $\times 400$ and Papanicolaou stain, $\times 400$, e and f, respectively). The mucin in the background and the nuclear detail are supportive of a diagnosis of mucoepidermoid carcinoma. (g,h) Adenoid cystic carcinoma (Diff-Quik, $\times 100$ and $\times 100$, g and h, respectively). For the details of the single salivary gland tumors, please refer to the text.

Salivary gland lesions are rare in children, although an increase of salivary gland disease in adolescence and youth has been reported recently [20–22]. Previous research has shown that salivary gland tumors are rare in the young population, but the incidence of all primary salivary gland carcinomas increased with increasing patient age, particularly in patients younger than 30 years. Lesions of the major cephalic salivary glands, with the exception of mumps and cytomegaly, are unusual in children and adolescents, but these lesions may give rise to some different tentative diagnoses [23–25]. Since malignant salivary gland tumors are relatively more frequently recognized in younger patients, a safe approach is advisable, and intradepartmental consultation is crucial. Cytologic diagnoses of malignant tumors are confirmed histologically in 93% of cases, while benign tumor diagnoses are confirmed on histology in 95% of cases. Inflammatory lesions are confirmed on histology in 73%, while benign salivary gland tissue is ascertained as such histologically in 18% of cases [26]. Non-rare malignant salivary gland tumors in childhood and youth are a mucoepidermoid carcinoma, adenoid cystic carcinoma, acinic cell carcinoma, malignant lymphomas, and metastatic tumors from a tumor of the H&N region or paraganglia (e.g., neuroblastoma). Benign neoplasms include pleomorphic adenoma and Warthin’s tumor (Figure 2a,b). In childhood, 80–90% of all malignant salivary gland tumors are constituted by mucoepidermoid carcinomas, adenoid-cystic carcinomas, and acinic cell carcinomas.

In adults, the corresponding figure is only 45% [23]. Despite the low incidence of 15–25% of malignant neoplasms for adults identified in 1969 [27], in a study carried out on 2632 patients following teams and investigations reported a significantly higher relative proportion in young patients [23]. Acinic cell carcinoma is characterized by a hypercellular aspirate with a clean background with tumor cells seen in disorganized clusters with loss of round groupings and lack of an associated ductal epithelium and on higher magnification cells show some uniformity resembling normal serous acinar cells with the cytoplasm being foamy or bubbly and harboring fine dark granules (Figure 2c,d) [28,29]. The examination of the background highlights many naked nuclei. Apart from clear cell tumors, mainly low-grade mucoepidermoid carcinoma and epithelial-myoeplithelial carcinoma), oncocytic tumors, sialadenosis, and normal salivary gland tissue need to be kept in the differential diagnosis list. Smears of mucoepidermoid carcinoma are usually low in cellularity with a particularly striking dirty background of mucin and debris. In the smears, the presence of scattered cell clusters of intermediate cells with overlapping epithelial groups, some mucin-coated cells (goblet-cells-like), and few squamous epithelial cells are particularly evident features for the diagnosis of mucoepidermoid carcinoma (Figure 2e,f). However, both components may be quite bland or missing in one or all slides. According to the grade of differentiation, nuclear features may vary from bland to hyperchromasia with a high nucleus to cytoplasm ratio, although this tumor is usually low-grade in childhood and adolescence. Some potential pitfalls in diagnosing the mucoepidermoid carcinoma are some cystic nature of these

tumors, which may harvest only hypocellular (even acellular in some cases) mucoid material [30]. Moreover, extracellular mucin is typically copious, mimicking the fibrillary stroma seen in pleomorphic adenomas, although the mucin of pleomorphic adenomas stains less intensely and has no fibrillary pattern. Finally, squamous metaplasia is not only characteristic of mucoepidermoid carcinoma but may be found in other tumors, such as pleomorphic adenoma and Warthin’s tumor (Figure 2a,b). The adenoid cystic carcinoma features are large globules of extracellular matrix with or without surrounding basaloid cells. In FNAs with a predominance of basaloid tumor cells, both benign and malignant salivary gland tumors of epithelial–myoepithelial differentiation should be considered in the differential diagnosis (Figure 2g,h) [28,29]. If TBSRTC has received a warming acceptance in many countries, the Milan System for Reporting Salivary Gland Cytology (MSRSGC) seems that will have similar success in the coming years [31–35]. The MSRSGC is an evidence-based tiered classification system that comprises six diagnostic categories associated with an average risk of malignancy (ROM) and clinical management strategies (Table 1). It is expected that the MSRSGC will improve communication between the cytopathologist and the treating pediatrician, facilitating cytologic-histologic correlation, and lead to overall improved patient care.

4. Study Comparison

FNAC is now being considered as a valuable diagnostic aid in many children’s hospitals across continents, not only in North America. In most studies, FNAC reveals good aspects, showing the early availability of results, its simplicity, minimal trauma or injury, and the low rate of complications. Ancillary techniques, including flow cytometry, cytogenetics, immunohistochemistry on the cell block, and electron microscopy can be easily applied for the characterization of tumors [20,21,37,38]. Furthermore, FNA does not usually need heavy sedation, and general anesthesia is not necessary. FNAC of the H&N region is a well-accepted technique that has high specificity in most studies [21]. In Table 2, a comparison of four studies is provided.

5. Limitations

Most of the studies have several limitations that are inherent in their retrospective nature. First, the lack of standardization of the enrolled patients is reflective of both the diversity of pediatric nodules and the variable diagnostic and treatment approaches of different clinical and surgical teams [17]. In fact, there is often a significant variation in the use, duration, and timing of antibiotic treatment, and the accessibility of the clinical and surgical services was also variable and change over time was present in most of the retrospective studies. The lack of universal follow-up is also an essential drawback of numerous FNAC studies. The importance of the monitoring may be enshrined for all patients with negative FNAC results that need to be instructed to follow up if the mass persists, increases in size, or any concerns remain.

6. Conclusions

The potential avoidance of surgery with associated scarring, early and late septic and non-septic surgical complications, general anesthetic risk, recovery time, and significant expense bills have all been heralded as benefits of FNAC, especially given the high prevalence of non-neoplastic pediatric tumor and masses of the H&N region. FNAC shows an impressive diagnostic accuracy in numerous studies. FNAC is supported by an active lab safety profile and carries a very limited number of drawbacks considering that in the case of a dubious cytology result, a surgery can be planned in a very short time identifying FNAC as a useful triage procedure. In conclusion, FNAC is a safe, well-tolerated, and accurate tool for diagnosing pediatric masses of thyroid and non-thyroid origin in childhood and youth. FNAC plays a vital role in giving comfort to obviate the need for unnecessary immediate surgery in benign nodules (congenital/reactive/inflammatory) and plan a primary surgical intervention in malignant lesions. In consideration of significant health care changes worldwide, we would like to strongly emphasize that when such a triage of pediatric masses of the H&N region is handled, there is a potential decrease in both surgical morbidity and health care costs.

Preterm Perinatal Hypoxia-Ischemia Does not Affect Somatosensory Evoked Potentials in Adult Rats

Abstract: Somatosensory evoked potentials (SSEPs) are a valuable tool to assess functional integrity of the somatosensory pathways and for the prediction of sensorimotor outcome in perinatal injuries, such as perinatal hypoxia-ischemia (HI). In the present research, we studied the translational potential of SSEPs together with sensory function in the male adult rat with perinatal HI compared to the male healthy adult rat. Both somatosensory response and evoked potential were measured at 10-11 months after global perinatal HI. Clear evoked potentials were obtained, but there were no group differences in the amplitude or latency of the evoked potentials of the preceding sensory response. The bilateral tactile stimulation test was also normal in both groups. This lack of effect may be ascribed to the late age-of-testing and functional recovery of the rats.

1. Introduction

Somatosensory evoked potentials (SSEPs) are a valuable tool to assess functional integrity of the somatosensory pathways of the peripheral and central nervous systems [1]. SSEPs are widely used for the prediction of motor outcomes in perinatal injuries, where the long-term effects of the injury are difficult to ascertain early in life [2]. Hypoxic-ischemic encephalopathy (HIE) is a common injury in neonates, with a global occurrence of 8.5 infants per 1000 live births in 2010 [3]. Infants with HIE, especially preterm infants, are considered to be at risk for developmental disorders [4]. They present a heterogeneous clinical picture, varying by individual, and ranging from major disorders like cerebral palsy (CP) to less severe impairments like developmental coordination disorder (DCD). DCD is commonly associated with other developmental comorbidities, including attention deficit/hyperactivity disorder (ADHD) and learning disabilities, and could be related to an impaired sensory process.

Several studies have shown that SSEPs, in combination with other electrophysiological tools and neuroimaging, are useful in the diagnosis of encephalopathy after HIE and could improve

the prediction of infants that will have poor neurodevelopment outcomes two years after perinatal HIE [2,5–7]. However, the predictive value of SSEPs decreases with longer follow-up periods. Neonatal SSEP latencies do not correlate with neurodevelopmental outcomes at school-going age in infants with mild HIE. The long-term prognostic value of neonatal SSEPs in this patient group is unclear [1]. It is also unknown whether the neonatal SSEP abnormalities persist in adults with HIE. On the other hand, SSEPs are suited to evaluate patients suffering from more severe forms of disability such as cerebral palsy (CP), in whom neurological deficits might reflect disruption of motor as well as sensory connections [8,9], suggesting a neural network disorder. Furthermore, both motor and behavioral skills involve the process of receiving a sensory input. In this context, motor-behavioral deficits could be treated by sensory-based therapies. Indeed, this may be acceptable as one component of a comprehensive treatment plan in the management of children with developmental, behavioral, and motor disorders of different etiology [10].

SSEP is a relatively simple, objective, and reproducible diagnostic procedure that assesses the effect of the somatosensory input in the peripheral and central neuronal networks. In the present experiments, we used a perinatal rat model of hypoxic-ischemia (HI) injury by submersion [11]. Previous studies using this model of global perinatal preterm HI demonstrated that severe HI (submersion lasting for 19–20 min) decreased locomotor activity in the adult rat, while milder HI insults might increase locomotion [12,13]. In this respect, our experimental group is a cohort of male adult rats that recovered from moderate global perinatal HI and showed cognitive (memory) as well as motor abnormalities (hyperactivity) within the spectrum of ADHD at the age of 6–8 months [14]. To test whether this cohort had a problem in coordination (DCD), we evaluated the sensory functioning using a bilateral tactile stimulation test and we recorded cortical SSEPs after unilateral tibial nerve stimulation at 11 months of age [14].

The present study reports the outcomes of the SSEPs and behavioral tasks of sensory functioning of male adult rats subjected to moderate perinatal HI. We hypothesized that long-term sensory deficits were relevant to the combined sensory and motor deficits previously demonstrated in this cohort of male rats after perinatal HI.

2. Materials and Methods

2.1. Rodents and Ethics Approval

The experiments were performed in Sprague-Dawley rats from Charles River (Leiden, The Netherlands). The rats were housed at the Central Animal Experimentation Facilities of the Maastricht University, The Netherlands. Experimental female rats were synchronized with luteinizing hormone-releasing hormone (Cat. L4513, Sigma-Aldrich, The Netherlands), and time-mated between 15:00 and 07:00 the following morning. All experiments were conducted under ethical approval from the Dutch Central Committee for Animal Testing according to the guidelines of the EU directive 2010/63/EU (approval code: AVD107002016540, approved on 16 July 2016).

2.2. Perinatal Hypoxia-Ischemia (HI) Procedure

In the afternoon of embryonic day 21 (expected delivery on E21–E22), a pregnant female rat was euthanized by rapid decapitation and the uterine horns, still containing the pups, rapidly removed and submerged in saline solution at 37 °C for 16–18 min according to previously-described methodology [12,13]. After submersion, the pups were delivered, manually stimulated to breathe, and placed in a closed pediatric incubator to recover for an hour (HI group). The control Cesarean-section rats (C-section) were delivered from the same litters without submersion and placed in the closed pediatric incubator to recover with their HI littermates. After recovery, the mixed litter of HI and C-section pups was placed with a foster mother that had given birth the day before to minimize the impact of maternal care differences on outcomes. The mortality rate for the HI procedure was 39%.

2.3. Housing

After weaning, the rats were fed a standard laboratory diet and housed in pairs in individually ventilated cages, up to 8 months of age, when they were housed 4 per cage in larger filter top cages. The rats were housed on a reverse day night cycle (lights off at 7:00/lights on at 19:00).

2.4. Adhesive Removal ('Sticker Test')

The adhesive removal test was performed at 10 months of age. Somatosensory response was assessed with a bilateral tactile stimulation test adapted from a method previously reported [15,16]. For the sticker test, rats were placed in an empty cage with videotaping from the sides. One investigator restrained the rat, whilst another investigator placed two brightly colored circular adhesive labels (1.27 cm diameter, Avery office products, Houten, The Netherlands) on the dorsum of both forepaws of the rat. Adult rats normally touch and remove the stickers with their teeth. The time from placing the rat in the arena to the initial purposeful sticker contact ('noticed') and to removal from both paws ('removed') was recorded and the latency time from initial contact to removal was calculated. The time limit for adhesive removal was 180 s. Group sizes for this test were C-section ($n = 12$) and HI ($n = 11$).

2.5. Sedation

For the SSEPs, the rats were placed under anesthesia with an induction of midazolam (0.5 mg/kg), followed by a mixture of ketamine (0.75 mg/kg), medetomidine (0.06 mg/kg) and atropine (0.04 mg/kg) in saline (KMA). Sedation was maintained during the procedure with an intraperitoneal infusion of the KMA mixture.

2.6. Somatosensory Evoked Potentials (SSEPs)

The SSEP was conducted according to methodology previously described by Zhang, et al. [17] at the age of 11 months. A Nicolet Viking IV P™ (Nicolet Biomedical, Madison, WI, USA) was utilized to record and analyze the waveform of SSEPs. Twelve-millimeter long monopolar needle electrodes with attached lead wire were used for active, reference, and ground electrodes. A sedated rat was placed on a board and the needle electrodes were carefully inserted into the scalp and placed on the surface of the skull, parallel with the long axis of the rat body. The active electrode was located on the midline of the skull and crossed the point of bregma for right hemisphere recording.

The reference electrode was placed on the skull surface over the olfactory bulb and the ground electrode was placed in the shoulder. Left tibial nerve stimulation was performed with 0.2 ms pulses at 1.7 Hz (filter set to 2–3000 Hz) with an intensity of 1–3 mA, depending on the twitch response, for an average of 500 stimuli. We studied the cortical SSEPs P₁ and N₂ amplitudes and latencies, which were registered by a child neurologist (JSHV) and reviewed together with a clinical neurophysiologist (VHvKM) and a clinical neurophysiology technician (PB).

We recorded 6 male rats per group, for the following groups: C-section (body weights: 601 ± 36 g) and HI (body weights: 574 ± 33 g).

2.7. Statistics

Stata 10 (Statacorp, TX, USA) was used to assess group differences by means of the non-parametric Kruskal-Wallis H-test followed by post-hoc Dunn's test of equality. Regarding SSEPs, the averaged value between two runs was used. *P* values <0.05 were considered as statistically significant. Figures regarding average ± standard error means were constructed with GraphPad Prism 6 (GraphPad Software Inc., La Jolla, CA, USA). Outliers were not considered in the analysis.

3. Results

3.1. Adhesive Removal Test ('Sticker Test')

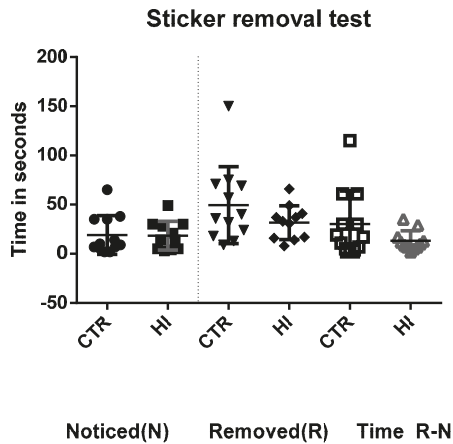


Figure 1. The adhesive removal test showing the latency to notice (N) and remove the stickers from the front paws (R), as well as the time elapsed between notice and removal (R-N). CTR: control C-section group, HI: hypoxia-ischemia group.

The results of the sticker test are shown in Figure 1. There were no significant differences between groups regarding the time the rats took to notice the sticker on their paws ($p = 0.943$), the time to remove it ($p = 0.546$), or the time from notice to removal ($p = 0.244$).

3.2. Evoked Potentials

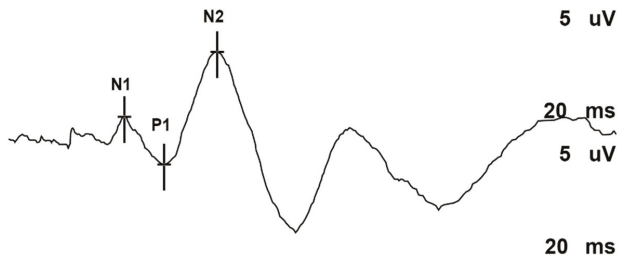


Figure 2. Representative example of tibial somatosensory evoked potentials (SSEPs) recording in adult rats. N₁, P₁ and N₂ cortical latency and amplitude.

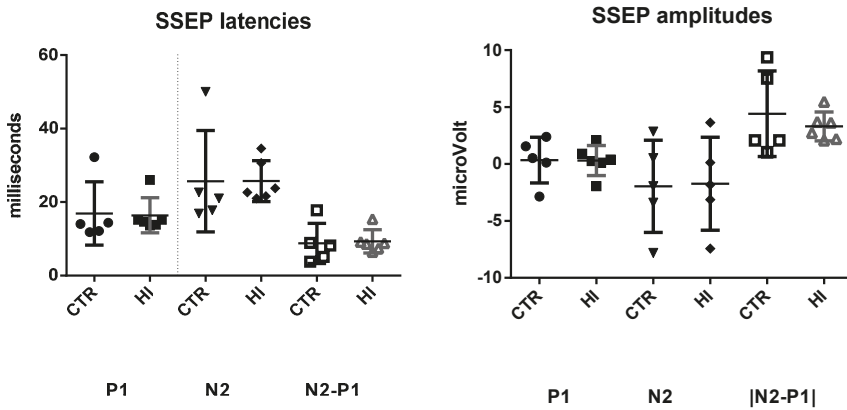


Figure 3. The latencies and amplitudes of the SSEP test. Each data point represents a single male animal; horizontal lines represent regional medians with the standard error medians. P1 latencies, N2 latencies, P1 amplitude, N2 amplitude, Absolute differences in amplitude. CTR: control C-section group, HI: hypoxia-ischemia group.

Reproducible SSEPs were obtained in all rats. After exclusion of one outlier, our group sizes were: C-section ($n = 5$) and HI ($n = 6$). There were no significant differences for the amplitude of the P₁ peak ($p = 0.078$), the N₂ peak ($p = 0.891$), or the absolute difference in the amplitude of the P₁-N₂ peaks ($p = 0.469$). There were also no significant group effects on the latencies of these peaks P₁ ($p = 0.667$), N₂ ($p = 0.558$) (Figures 2 and 3). Exclusion of the outlier did not statistically change the results.

4. Discussion

In human newborns, particularly those born preterm, HI is an important cause of long-term neurological disabilities, such as learning and memory deficits and sensorimotor and motor functioning deficits like CP [18,19]. The present study investigated the long-term effects of moderate HI on somatosensory functioning in male survivors using an established rat model of preterm HI.

Recording of SSEPs is a quantitative method for evaluation of both the central and peripheral nervous system. Peripheral sensory information reaches the parietal-occipital cortex by thalamocortical pathways e.g., corona radiata and internal capsule. The parietal cortex connects to neocortical areas including premotor, prefrontal areas as well as to the cerebellum through pontine nuclei. Merging this information with the basal ganglia, pre-Rolandic motor areas control motor activity through the descending corticospinal tracts [20]. SSEPs are suited to evaluate children and adult patients suffering from CP [9]. Through the findings of neuroimaging studies, a correlation has been reported in CP patients between disrupted descending corticospinal pathways and disrupted thalamocortical pathways connecting to the sensory cortex [20]. The role of SSEPs in children and adults with milder deficits after HI is unclear. Identifiable sensory processing and motor interaction during early childhood, e.g., reaching and touching objects using hands and mouth, provides a critical foundation for normal growth, development, and learning. This sensorimotor integration explains why sensory impairments affect motor recovery, and why sensory based strategies might promote motor and behavioral recovery.

The seminal work reported by de Louw, et al. (2002) on the short-term effect of severe perinatal HI on spinal cord apoptosis using this perinatal model of submersion showed an increased lumbar grey and white-matter apoptosis [21]. These changes may contribute to the permanent motor deficits, which are the main neurological manifestations of brain injury in the premature infant. We investigated whether preterm HI had a long-term effect on expected sensorimotor deficits.

In the adhesive removal test, we did not observe a statistically significant effect of HI. We used the time for removal from both paws, since we caused a global insult which was expected to affect both hemispheres equally. In adult rats with unilateral lesions, a bias to touching the non-affected forepaw first has been reported [15]. A previous study of neonatal unilateral hypoxic-ischemic injury also did not find significant group differences with the adhesive removal among five-week-old rats with a modest brain injury [16].

Tibial SSEPs evaluate the somatosensory pathway including dorsal columns of the rat’s spinal cord and the contralateral parietal cortex. Our study found that the perinatal HI insult did not influence

the SSEPs. A previous study with SSEPs after neonatal stroke in the rat, found profound unilateral changes in SSEPs one week after the insult, but recovery of the deficits 3 weeks postnatally. This may indicate large-scale plasticity of the somatosensory networks even after a unilateral neonatal injury [22]. It is thus possible that sufficient recovery occurred at 11 months after the global asphyxic insult and ameliorated changes observed in evoked potentials.

SSEPs were performed unilaterally (left tibialis nerve stimulation) assuming symmetrical and global central nervous system impact inherent to the global perinatal hypoxic-ischemic insult. This statement has been corroborated by the symmetrical adhesive removal test, which complements the SSEP data. In summary, we did not find any permanent significant sensory behavioral or electrophysiological changes in rat adulthood explaining the hyperactivity disorder and recognition memory deficit shown by this rat cohort. However, these results raise the question whether the somatosensory functioning of our rats has sufficiently recovered over time, or whether the SSEPs was not sensitive enough to detect deficits in adult rats.

There are several methodological and study limitations that could explain why we failed to detect preclinical SSEPs:

- (a) Due to our cross-sectional design, we might have missed SSEP changes in early postnatal age and adolescence.
- (b) Midazolam, ketamine and medetomidine were used as systemic anesthetics during SSEPs recordings. Accordingly, this anesthetic combination may have influenced SSEPs results; however, both experimental groups received the same anesthetic regime [23]. In humans, SSEPs are known to be less sensitive to the injectable anesthetics that we used, than to inhalation anesthetics [24].
- (c) The lumbar spinal cord apoptosis observed in severe HI models (19–20 min of submersion) may not necessarily be the postnatal hallmark of the moderate HI model (16–18 min of submersion) used in this experiment [21].
- (d) Evidence supports more neurological impairments and higher mortality for male preterm infants. In line with the human data, behavioral studies have consistently shown that the male sex is associated with an increased risk of long-term motor deficits in the rat preterm HIE [11]. Therefore, only male rats were included in this study.
- (e) Our global HI insult was conducted around the time of birth, when the rodent brain development is comparable to that of human infants born at a very low gestational age [11]. Studying SSEPs in larger animal models with brain development comparable to humans, such as sheep, may be more predictive of the human clinical situation [25]. However, larger animals are less suitable for chronic, long term studies.

Despite the aforementioned limitations, the present study found that, in the rat, moderate global HI did not influence the sensorimotor measurements assessed at 11 months. The moderate severity of the insult and the neuroplasticity observed early in life may explain the lack of a measurable effect on the adult survivors. More research is warranted to further confirm our results.

Highlights:

1. SSEPs are used to clinically assess the integrity of peripheral and central somatosensory pathways after perinatal HI.
2. Childhood SSEPs are often used to predict long-term outcomes, but it is unknown if sensory pathway deficits persist into adulthood.
3. We showed the electrophysiological and behavioral integrity of the somatosensory pathways in adult rats subjected to moderate perinatal HI.

Clinicopathological Spectrum of Bilirubin Encephalopathy/Kernicterus

Abstract: Bilirubin encephalopathy/kernicterus is relatively rare, but continues to occur despite universal newborn screening. What is more interesting is the spectrum of clinical and even neuropathological findings that have been reported in the literature to be associated with bilirubin encephalopathy and kernicterus. In this review, the authors discuss the array of clinicopathological findings reported in the context of bilirubin encephalopathy and kernicterus, as well as the types of diagnostic testing used in patients suspected of having bilirubin encephalopathy or kernicterus. The authors aim to raise the awareness of these features among both pediatric neurologists and neuropathologists.

Keywords: bilirubin encephalopathy; kernicterus; neurological symptoms; diagnosis; neuropathology

1. Introduction

Bilirubin encephalopathy/kernicterus is a relatively uncommon occurrence. Although neonatal jaundice is quite common, affecting 60%–80% of newborns overall [1], severe hyperbilirubinemia (> 20 mg/dL) that could potentially lead to kernicterus and neurodevelopmental complications is said to be much rarer, affecting less than 2% of newborn infants [2]. Associated risk factors can include a low gestational age, low birth weight, hemolysis, sepsis, cephalohematoma or easy bruising, and exclusive breast feeding. Recent literature has shed light on the wide range of clinical symptomatology and pathological findings associated with bilirubin encephalopathy/kernicterus [3,4]. Bilirubin-induced neurological complications continue to occur in industrialized countries, but a disproportionately increased burden is reported in low- and middle-income countries, primarily because of delays in delivering treatments that are more readily available in high-income countries [1,5]. This review aims to provide a comprehensive overview of the clinical, radiological, and neuropathological features associated with bilirubin encephalopathy/kernicterus that have been reported in the literature, as well as the string of diagnostic tests used in patients suspected of having bilirubin encephalopathy or kernicterus. The authors hope to raise awareness of the wide spectrum of findings that should raise the possibility of bilirubin encephalopathy or kernicterus to pediatric neurologists and neuropathologists alike.

2. Clinical Presentation

Acute bilirubin encephalopathy encompasses the acute illness caused by severe hyperbilirubinemia. Presenting signs and symptoms include decreased feeding, lethargy, abnormal tone (hypotonia and/or hypertonia), high-pitched cry, retrocollis and opisthotonus, setting-sun sign, fever, seizures, and possibly death [6,7]. Seizures usually resolve several weeks after the acute insult. Therefore, persistent seizures in a child with kernicterus should prompt a search for another concomitant condition.

The so-called ‘kernicteric facies’ in acute bilirubin encephalopathy includes a combination of the setting-sun sign (i.e., paresis of upward gaze) with eyelid retraction, which together comprise the Collier sign, and facial dystonia. These findings make the infant appear stunned, scared, or anxious. Some infants may also exhibit disconjugate or wondering eyes. This kernicteric facies persists for at least two to three weeks after acute bilirubin encephalopathy [8].

Recent reviews and studies have also reported apnea in both preterm and term infants in conjunction with other findings of acute bilirubin encephalopathy and also as an isolated early abnormality [9–11]. Apnea may also be a sign of seizures in a newborn with jaundice, albeit infrequently. These authors also suggested that apneic events are a common clinical sign of bilirubin neurotoxicity in late preterm and term neonates with severe jaundice associated with bilirubin levels greater than 25 mg/dL. Clinical findings suggestive of bilirubin-induced disturbance in control of breathing include (1) new onset of frequent apnea, bradycardia, and desaturations concurrent with marked hyperbilirubinemia; (2) apnea, bradycardia, and desaturation that require intubation and assisted ventilation in an infant with marked hyperbilirubinemia; and (3) acute worsening of frequency and severity of apnea from baseline levels in an infant with marked hyperbilirubinemia [9]. Any noticeable change in the frequency and/or severity of apnea should prompt a measurement of total serum bilirubin levels as it may suggest acute bilirubin encephalopathy.

Kernicterus describes the long-term outcome of acute bilirubin encephalopathy and encompasses a tetrad of clinical features that are typically evident after one year of age: (i) abnormal motor control, movements, and muscle tone; (ii) an auditory processing disturbance with or without hearing loss; (iii) oculomotor impairments, especially impairment of the upward vertical gaze; and (iv) dysplasia of the enamel of deciduous (baby) teeth [12].

Auditory complications, a disabling neurological finding in kernicterus, are typically characterized by varying degrees of auditory neuropathy/dys-synchrony (AN/AD) ranging from central auditory processing difficulties with normal hearing to severe AN/AD with absent auditory brainstem responses, and possibly accompanying severe hearing loss and deafness [12]. In fact, the brainstem cochlear nuclei are said to be one of the first structures affected by elevated total bilirubin, followed by the auditory nerve [13,14]. Although the cochlea is not directly affected by elevated bilirubin levels, it is thought that damage to the cochlea may occur secondary to damage to the cochlear nucleus and/or auditory nerve [15].

Patients with so-called ‘motor predominant’ kernicterus due to lesions in the globus pallidus (interna and externa) and subthalamic nucleus reportedly present with an athetotic or dyskinetic form of cerebral palsy. In the most severe form of ‘motor predominant’ kernicterus, one may observe severe dystonia/athetosis that prevents voluntary movements, including ambulation, speech, and self-feeding, and may be accompanied by severe hypertonia and muscle cramping. Mild and moderate forms of kernicterus may also present with motor symptoms that include dystonia with or without athetosis and gross motor developmental delays, although patients with moderate kernicterus may experience greater difficulty ambulating due to choreoathetoid movements [16].

Bilirubin-induced neurological dysfunction (BIND) (aka subtle kernicterus) was actually defined by the presence of subtle developmental disabilities without the classical findings of kernicterus [12]. Patients may exhibit neurodevelopmental disabilities with a history of excessive hyperbilirubinemia and prior signs of bilirubin encephalopathy. Subtle kernicterus spectrum disorders may also be associated with conditions related to the findings of classical kernicterus, such as auditory imperception, aphasia, and other neurodevelopmental disorders (e.g., central auditory processing disorders, sensory and sensorimotor integration disorders, hypotonia, ataxia or clumsiness) [12]. An important clinical issue of subtle kernicterus/BIND seems to be auditory neuropathy, defined as impaired auditory brainstem reflexes with normal otoacoustic emissions or cochlear microphonic responses. Auditory brainstem response is said to be absent or abnormal, reflecting damage to the auditory nerve and/or auditory brainstem nuclei [7]. Le Pichon et al. (2017), however, suggested using the term Kernicterus

Spectrum Disorders to encompass all neurological sequelae of bilirubin neurotoxicity, acknowledging that kernicterus is symptomatically broad and diverse [17].

3. Diagnostic Testing

Infants who appear jaundiced should be evaluated with a risk score or total serum/transcutaneous bilirubin measurement [2,18]. The transcutaneous method of measuring bilirubin has the advantage of being less invasive, with results becoming available much more quickly compared to serum measurement and is potentially more cost effective, but this method may not be reliable at bilirubin levels greater than 15 to 20 mg/dL [19]. The bilirubin levels should be interpreted in relation to the infant's age in hours. Recommendations from the American Academy of Pediatrics state that laboratory tests should be ordered for all infants with jaundice who require phototherapy, including neonatal blood type, direct antibody titer/Coombs test, complete blood count, blood smear, and direct/conjugated bilirubin level [2].

In neonates, serum unconjugated bilirubin (UCB) is usually elevated during the first two weeks of postnatal life due to the increased breakdown of fetal erythrocytes, deficient albumin transport to the liver, and decreased conjugation leading to physiological jaundice of the newborn, requiring no treatment [20]. In some newborn infants however, serum levels of unconjugated bilirubin can increase significantly due to impaired postnatal maturation of hepatic transport, impaired conjugation of bilirubin, or augmented hemolysis. This jaundice is pathologic and may lead to death or severe neurodevelopmental complications in survivors [20]. Unconjugated bilirubin levels close to 20 mg/dL have been reported to be related to kernicterus [21].

Measurement of free/unbound bilirubin (i.e., bilirubin not bound to albumin) can also be an important marker of the risk of hyperbilirubinemia. A study by Morioka et al. (2015) involving 18 preterm (<30 weeks) infants (birth weight < 1000 g) diagnosed with kernicterus between 2002 and 2012 based on clinical history, neurological examinations, and laboratory investigations, found the median age at which total bilirubin levels peaked was 28 days after birth. The majority of these infants (16/18) were 14 or more days of age and the latest age recorded for peak total bilirubin levels was 86 days. The median serum total and unbound bilirubin levels in this cohort at that age were 17.0 mg/dL and 1.67×10^{-3} mg/dL, respectively. Nine of 18 infants had high total and unbound bilirubin, while seven of eight infants with low total bilirubin had high unbound bilirubin. The results of this work suggest that chronic high unbound bilirubin levels may help identify early low-birth weight infants at risk of developing kernicterus [22]. Measurement of unbound bilirubin is still not feasible in most parts of the world, but we believe the above-mentioned study emphasizes the importance of developing an accurate method for its determination in clinical practice.

Iskander et al. (2014) performed a longitudinal observational study in which the neurologic status and auditory impairment (automated auditory brainstem response) were evaluated (both at admission and posttreatment) in 193 term/near-term infants that were admitted to hospital for jaundice. Relationships of total serum bilirubin (TSB) and the bilirubin-albumin (B/A) ratio to advancing stages of neurotoxicity were compared using receiver operating characteristic curves. The authors found a stepwise relationship between median and threshold values of TSB and the B/A ratio, and the progression of acute neurotoxicity. However, they concluded that the B/A ratio did not improve the prediction of bilirubin encephalopathy over total serum bilirubin levels alone [23]. Other authors similarly consider a high B/A ratio in preterm infants to be a risk factor and suggest its use in conjunction with TSB for the evaluation and treatment of premature infants with hyperbilirubinemia [24]. Elevated B/A ratios may be especially helpful to predict the risk of bilirubin neurotoxicity in cases of so-called low bilirubin kernicterus in which bilirubin-induced neuronal injury is said to occur at total bilirubin levels that are thought to be non-hazardous with low albumin levels [25]. Novel methods for bilirubin quantification have been developed in recent years. A detailed discussion of these methods is beyond the scope of this article, but the interested reader is referred to the excellent review by Ngashangva et al. (2019) [26].

The above-mentioned methods, although accurate, are fairly expensive, and therefore may not be accessible in low-income countries. The Bilistick method is an in vitro point-of-care diagnostic method for measuring TSB from capillary or venous blood samples [27]. This is a much cheaper method and multiple studies have found it to be an accurate alternative [28,29]. The Bilistick method also has the added advantage of having a much shorter turn-around-time (time interval between specimen collection and reporting of TSB result) compared to serum measurement and even transcutaneous measurement of bilirubin [27].

The bilirubin-induced neurological dysfunction (BIND) score is a nine-point scale assessing mental status, muscle tones, and crying patterns (Table 1). A BIND score of 0 is normal, while BIND scores 1–3, 4–6, and 7–9 are meant to represent mild, moderate, and severe acute bilirubin encephalopathy, respectively [30,31]. El Houchi et al. (2017) studied the ability of the BIND score to predict not only neurologic and auditory disability, but also its relationship to total serum bilirubin concentration. BIND scores of 220 term and near-term infants (117 boys, 103 girls; age range = 0.1 – 13.3 years) with severe hyperbilirubinemia were obtained at 6- and 8-h intervals. Median highest total serum bilirubin in this cohort was recorded at 29.7 mg/dL, with a range 17–61 mg/dL. The authors found that a BIND score ≥ 4 had a specificity of 87.3% and sensitivity of 97.4% for predicting a poor neurologic outcome, and a specificity and sensitivity of 87.3% and 92.6%, respectively, for predicting long-term hearing impairment. It is worth noting, however, that four infants with total serum bilirubin levels ≥ 36 mg/dL had BIND scores ≤ 3 and normal outcomes at follow-up, while one infant with a low BIND score developed severe auditory neuropathy. Although a positive correlation between BIND scores and total serum bilirubin was observed, the coefficient of determination was not very high ($r^2 = 0.54$, $p < 0.005$). However, they did demonstrate that the risk of severe acute bilirubin encephalopathy increased with increasing total serum bilirubin, especially TSB above 30 mg/dL [30].

4. Neuroimaging

Signal abnormalities are classically reported in the globus pallidus, hippocampus, and cerebellum, but the nature of these signal abnormalities tends to vary with time. MRI studies of infants in the first days to weeks following acute bilirubin encephalopathy onset (i.e., subacute phase) are said to demonstrate an increased T1-signal in the globus pallidus and subthalamic nucleus, while T2-weighted imaging of these regions is often unremarkable or shows subtle T2-hyperintensity [32,33]. In Wang et al.'s (2008) study involving 24 neonates (including two premature infants) who underwent conventional MRI, the main findings were found to be an abnormal bilateral increased signal intensity in the globus pallidus on T1-weighted images without apparent T2-signal changes for 19 of the 24 patients. Of these 19 patients, 10 of them had a high signal intensity on T1-weighted imaging, but normal T2-signal in the subthalamic nucleus [32].

Interestingly, some authors report that the sensitivity and specificity of T1-signal changes to predict kernicterus during the subacute phase is hindered by both the evolving nature of signal abnormalities and confounding signal changes associated with normal myelination [34]. In infants who later show clinical evidence of chronic bilirubin encephalopathy (i.e., kernicterus), the earliest MRI changes tend to show a high T1-signal in the globus pallidus and subthalamic nucleus. It should be noted that an increased T1-signal in these regions can also be seen as part of normal brain development, such as myelination, and patients with kernicterus may also not necessarily show any abnormalities on MRI [35]. Myelinated white matter tracts such as the internal capsule appear relatively hyperintense on T1-weighted images, while grey matter structures such as the globus pallidus tend to be less hyperintense on T1-weighted images because of the longer relaxation time [35]. Therefore, in infants with incomplete myelination, the globus pallidus may appear brighter and may be confused as pathologic increase in T1-signal intensity. Neuroimaging findings therefore need to be interpreted in the context of obtained clinical history, neurological exam findings, and results of serum biomarkers.

The neuroimaging hallmark of kernicterus is said to be the bilateral and symmetric increase of the T2- and/or FLAIR signal in the globus pallidus and subthalamic nucleus. An increased T2 signal may also be seen in the substantia nigra of the midbrain and dentate nucleus of the cerebellum [33].

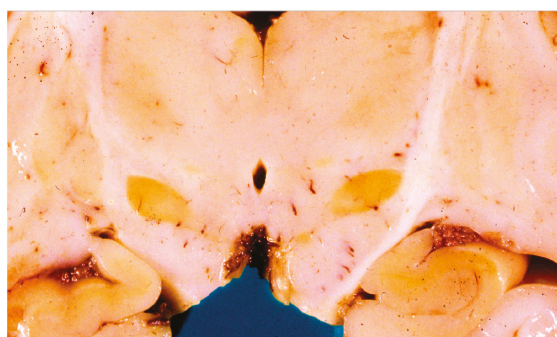
Data regarding findings from more advanced imaging techniques such as diffusion weighted imaging (DWI) and MR spectroscopy (MRS) are still limited. Wisnowski et al. (2016) reported a case of a 3400 g female neonate born at 41-weeks gestation who presented with jaundice before 24 h of life, followed by lethargy and poor feeding, and a total serum bilirubin of 28 mg/dL. She underwent MRI, where DWI showed restricted diffusion in the superior thalamic radiations, ventroanterior (VA), and ventrolateral (VL) nuclei of the thalamus, hippocampus, substantia nigra, subthalamic nucleus, superior cerebellar peduncle, pontine nuclei, and dentate nucleus of the cerebellum. Interestingly, no apparent diffusion restriction in the globus pallidus or descending corticospinal tracts was appreciated. Apparent diffusion coefficient (ADC) images demonstrated the acute involvement of selected white matter tracts, such as superior cerebellar peduncles and superior thalamic radiations. In addition, ¹H-MRS spectra acquired from the right thalamus revealed elevated glutamate/glutamine concentrations [36]. These observations suggest the involvement of cortico-ponto-cerebello-thalamo-cortical pathways. These pathways include descending projections from the motor cortex to the pontine nuclei (i.e., cortico-pontine pathway), and ascending projections from the dentate nucleus to the motor cortex (i.e., the dentato-thalamo-cortical pathway), with the implication that bilirubin toxicity may target not just neurons, but white matter connections as well.

Some studies have suggested that proton (¹H)-MRS studies of infants with acute bilirubin encephalopathy and/or severe hyperbilirubinemia can demonstrate decreases in the ratios of N-acetyl-aspartate (NAA) to choline, and NAA to creatine, as well as increases in the ratio of lactate to NAA in the vicinity of the basal ganglia in neonates who go on to develop kernicterus [32,37,38]. Wu et al.'s (2013) study enrolled 11 patients in their neonatal bilirubin encephalopathy group, eight in their neonatal hyperbilirubinemia group, and nine in their age-matched group, all of whom underwent ¹H-MRS and conventional MRI studies using a 1.5 tesla whole body MR scanner. The authors observed

NAA/Cr and NAA/Cho peak-area ratios in the basal ganglia to be much lower in the neonatal bilirubin encephalopathy group than in the neonatal hyperbilirubinemia and control groups ($p < 0.05$). Their study did not, however, show any statistically significant differences in the peak-ratios of NAA/Cr and NAA/Cho in the basal ganglia between the neonatal hyperbilirubinemia and control groups ($p > 0.05$) or in the thalamus between the three groups. There was also no statistically significant difference observed in the Cho/Cr ratios in the basal ganglia and thalamus between the three groups [38]. These findings suggest that $^1\text{H-MRS}$ can be useful in differentiating infants who go onto develop kernicterus versus those who have severe hyperbilirubinemia but do not go on to develop clinical sequelae. Further research is required to formulate more concrete conclusions regarding the utility of these techniques in the diagnosis of bilirubin encephalopathy and kernicterus.

5. Neuropathology

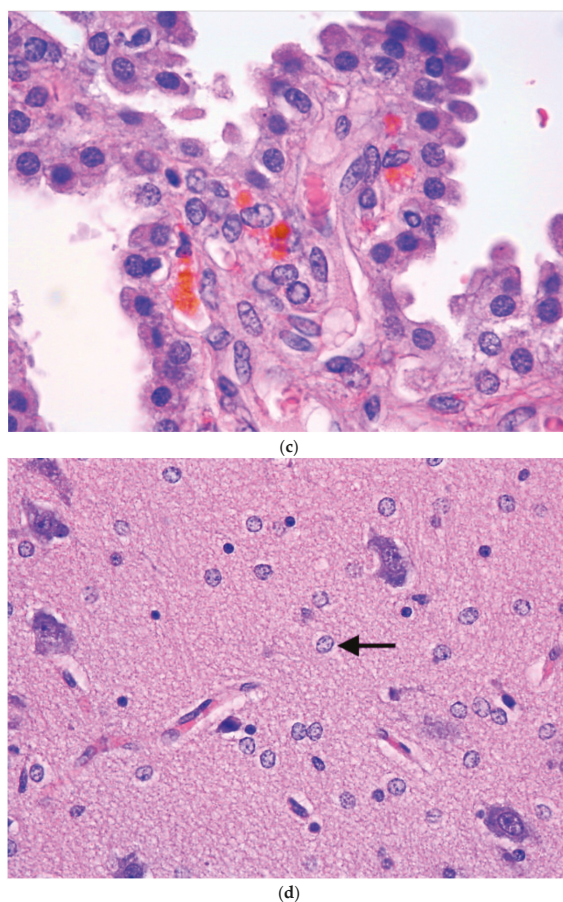


Figure 1. Neuropathologic findings from a patient with kernicterus. (a) Yellowish discoloration of subthalamic nucleus and hippocampus; (b) discoloration of medullary tegmentum, inferior olives, and cerebellar tonsils; (c) cytoplasmic pigment in cells of choroid plexus (20× magnification); (d) Alzheimer’s type II astrocytes (arrow) in keeping with liver failure (20× magnification).

The most consistent abnormality reported in the literature is atrophy of the globus pallidus, but the hippocampus, thalamus, hypothalamus, and subthalamic nucleus may also display atrophy. Classic full-blown kernicterus typically leads to yellow discoloration of the basal ganglia, especially the globus pallidus, and subthalamic nucleus (see Figure 1). Other susceptible areas include the thalamus, mammillary bodies, CA2 sector of the hippocampus, subiculum, indusium griseum, and uncus. Vulnerable areas in the brainstem include the substantia nigra, oculomotor nucleus, trochlear nucleus, cochlear nucleus, vestibular nucleus, inferior colliculus, and superior olivary complex. Purkinje cells and a dentate nucleus of the cerebellum are also reported to be potentially involved [7,39,40].

On microscopic examination, the primary target of injury is neurons. Neuronal changes are those of acute necrosis resembling that seen in hypoxic-ischemic encephalopathy and hypoglycemia. Within a few days after injurious insult, these dead neurons may become encrusted with calcium or iron. Neuronal damage can be found in the lateral and medial nucleus of the globus pallidus, subthalamic nucleus, mammillary bodies, indusium griseum, hippocampus, nucleus of the third and fourth cranial nerves, substantia nigra, and interstitial nucleus of Cajal. Chronic lesions, also referred to as post-kernicteric encephalopathy, display necrosis, vacuolation of the cytoplasm, and prominent neuronal loss, as well as gliosis in the globus pallidus, subthalamic nucleus, and hippocampus [40–42]. With regards to neuronal changes, the earliest (within the first several days of bilirubin-induced injury) neuronal changes consist of swollen granular cytoplasm, often with microvacuolation and the disruption of neuronal and nuclear membranes. Yellow pigment can be prominent within the neuronal cytoplasm. By the end of the first week, dissolution of affected neurons becomes apparent, and nuclear and plasma membranes become poorly defined. In subsequent days to weeks, neuronal loss, often with mineralization, and astrocytosis can be observed. As in other causes of liver injury, Alzheimer’s

type II astrocytes (Figure 1d) can be found throughout the deep grey matter structures, as well as the neocortex, brainstem, and cerebellum [43–45].

Bilirubin staining is said to be best seen in fresh specimens or in frozen sections, especially in infants who survive several days. The anatomic distribution of this staining includes the globus pallidus, subthalamic nucleus, hippocampus (particularly CA2 and CA3 sectors), substantia nigra, cranial nerve nuclei (particularly oculomotor, facial, vestibular, and cochlear nuclei), superior olivary complex, nuclei of lateral lemniscus, inferior colliculus, reticular formation of pons, inferior olivary nuclei, dentate nucleus of the cerebellum, and anterior horn cells of the spinal cord [43,44,46,47]. This period of prominent brain pigmentation lasts for approximately seven to 10 days, and is accompanied by the commencement of neuronal changes that result in post-kernicteric bilirubin encephalopathy [45,48]. We recently encountered a post-mortem case in our institution (not published) in which pigment was found in cells of choroid plexus (Figure 1c). Brito et al. (2013), in their case report of a 32-week old female with kernicterus, suggested that unconjugated bilirubin increases the vascular density of brain regions associated with kernicterus, such as the hippocampus and corpus striatum, while triggering VEGF and VEGFR-2 immunoreactivity, along with albumin extravasation into the brain parenchyma [48].

White matter abnormalities have also been reported in premature infants with kernicterus. For example, periventricular white matter injury in the form of periventricular leukomalacia has been reported as a frequent occurrence in the context of kernicterus [49]. Our recent postmortem case (not published) of kernicterus also showed evidence of chronic periventricular white matter injury typified by the presence of gliosis, macrophages, and sparse microcalcification in the periventricular white matter. With more diffuse periventricular white matter injury, ventriculomegaly and thinned corpus callosum may be observed [49]. A case report from Brito et al. (2012) of a preterm (32 weeks five days, weight = 1600 g) infant who passed away on the fourth day of life with a diagnosis of kernicterus reported a poorer staining intensity of Luxol-fast blue-periodic acid Schiff in the cerebellar white matter compared to an age-matched non-icteric cerebellum. This poor staining intensity indicated a decreased density of myelinated fibres, in keeping with demyelination. Axonal integrity was further assessed with Bodian-Luxol fast blue stain and revealed axons to be severely affected by hyperbilirubinemia compared to the non-icteric brain [50]. Findings from in vivo and in vitro experiments seem to suggest a decreased number of myelinated axons, decreased thickness of myelin sheaths, and less compact axons with more debris in brains exposed to unconjugated bilirubin [51].

6. Management

Management of patients with kernicterus is directed towards neurodevelopmental sequelae, which entails physical, occupational, speech, and audiological therapies; as well as complications including nutritional difficulties, gastroesophageal reflux, sleep disturbances, hypertonicity, and muscle cramps [12]. Established treatment strategies for acute bilirubin encephalopathy, on the other hand, include phototherapy and exchange transfusion [16]. Traditionally, the decision to start phototherapy has been based on birthweight because of the strong positive correlation that is believed to exist between total serum bilirubin and birthweight [7,52]. Interestingly, a Japanese group revised their treatment criteria for the treatment of preterm hyperbilirubinemic infants. The revisions included classifying newborns based on gestational age at birth or corrected gestational age rather than birthweight as it is gestational age at birth or corrected gestational age that is associated with organ maturation. Additionally, the treatment options created were standard phototherapy, intensive phototherapy, and albumin therapy and/or exchange transfusion. Finally, the decision to initiate any of these therapies is based on the total serum bilirubin and unbound bilirubin reference values for gestational age (in weeks) at birth for < 7 days after birth and \geq 7 days of age [53]. Measurement of unbound bilirubin is still not easily achievable in other parts of the world. We believe that further studies are necessary to accurately determine the efficacy of administering these therapies based on bilirubin levels, as well as the bilirubin/albumin ratio. It has also been argued that the

efficacy of treatments for acute bilirubin encephalopathy has generated overconfidence in the medical environment about the management of severe hyperbilirubinemia [54]. This can lead to an increased risk of neurological sequelae, even in western countries. Prevention of tragedies that can arise from severe hyperbilirubinemia and kernicterus requires the implementation of evidence-based guidelines for the management of neonatal jaundice [54]. What is also needed are more devices like the Bili-stick that are relatively cheap, easy to use, and accurate for distinguishing between healthy children and those at risk, especially for low-income countries where the prevalence of kernicterus is higher.

7. Conclusions

Herein, the authors have described the range of clinical, radiological, and neuropathological changes features (summarized in Box 1) that can be encountered in patients with bilirubin encephalopathy/kernicterus. Further research is required to accurately determine the efficacy of available treatment options on various parameters, including total serum bilirubin levels and bilirubin-albumin ratio, as well as whether other more innovative therapeutic options are possible.

Box 1. Key Concepts—Acute Bilirubin Encephalopathy (ABE) and Kernicterus.

Sialidosis: A Review of Morphology and Molecular Biology of a Rare Pediatric Disorder

Abstract: Sialidosis (MIM 256550) is a rare, autosomal recessive inherited disorder, caused by α -N-acetyl neuraminidase deficiency resulting from a mutation in the neuraminidase gene (*NEU1*), located on 6p21.33. This genetic alteration leads to abnormal intracellular accumulation as well as urinary excretion of sialyloligosaccharides. A definitive diagnosis is made after the identification of a mutation in the *NEU1* gene. So far, 40 mutations of *NEU1* have been reported. An association exists between the impact of the individual mutations and the severity of clinical presentation of sialidosis. According to the clinical symptoms, sialidosis has been divided into two subtypes with different ages of onset and severity, including sialidosis type I (normomorphous or mild form) and sialidosis type II (dysmorphic or severe form). Sialidosis II is further subdivided into (i) congenital; (ii) infantile; and (iii) juvenile. Despite being uncommon, sialidosis has enormous clinical relevance due to its debilitating character. A complete understanding of the underlying pathology remains a challenge, which in turn limits the development of effective therapeutic strategies. Furthermore, in the last few years, some atypical cases of sialidosis have been reported as well. We herein attempt to combine and discuss the underlying molecular biology, the clinical features, and the morphological patterns of sialidosis type I and II.

Keywords: sialidosis; neuraminidase; sialidosis I; sialidosis II; lysosomal storage disease; lysosomal exocytosis

1. Introduction

Sialidosis, an autosomal recessive disorder, occurs due to a structural defect in the neuraminidase gene and is characterized by abnormal tissue accumulation as well as urinary excretion of sialylated oligosaccharides and glycolipids [1].

The human neuraminidase gene is located at chromosome band 6p21.3, where the *HLA* locus is also reported to be located [2]. Until 1977, deficiency of Neuraminidase 1 (*NEU1*) was thought to be associated with classical mucopolysaccharidosis I, a severe and rapidly progressive lysosomal storage disease with onset at birth or shortly after birth [3,4]. In 1977, the term sialidosis was first used to describe the syndrome of two siblings having a visual impairment and mild neurological manifestations that slowly developed in their adolescence. Enzymatic assays in cultured fibroblasts and leukocytes from these siblings exhibited an isolated deficiency of *NEU1* [3,4]. Later, Sialidosis was classified into two types: Sialidosis Type I (normomorphous) and Sialidosis Type II (dysmorphic) [5]. In this study, we review the underlying genetics and molecular mechanisms of sialidosis and their correlation with clinical and morphological findings.

2. Background

Sialidase (neuraminidase, EC 3.2.1.18) catalyzes the hydrolysis of terminal sialic acid residues of glycoconjugates. Sialidase has been extensively studied in viruses and bacteria. In these microorganisms, its function is to destroy the sialic acid-containing receptors at the surface of host cells to mobilize bacterial nutrients. In mammals, three types of sialidases have been reported, including the lysosomal, plasma membrane, and cytosolic localized enzymes [1].

In human lysosomes, the degradation of complex macromolecular substrates requires the synergistic action of multiple hydrolases that act synergistically to carry out the degradation process of complex macromolecular substrates efficiently. One such efficient catalytic team is formed by three hydrolases which are ubiquitous, but differentially expressed: the serine carboxypeptidase, protective protein/cathepsin A (PPCA), the sialidase, Neuraminidase-1 (NEU1), and the glycosidase β -Galactosidase (β -GAL) [6]. The different expression of three enzymes can be explained by the fact that deficiency of each leads to three distinct lysosomal storage disorders (LSDs): galactosialidosis (GS) or PPCA deficiency with a secondary combined deficiency of NEU1 and β -GAL, sialidosis or NEU1 deficiency, and GM1-gangliosidosis (GM1) or β -GAL deficiency. Each disease is inherited as an autosomal recessive trait and is distinguished by variable clinical phenotypes, ranging from congenital forms to infantile/juvenile forms. All three present as a systemic disease, involving visceral organs, bone, cartilage, muscle and the nervous system [6].

Catalytic activation of NEU1 is PPCA dependent: The function of NEU1 is to initiate the catabolism glycoproteins and glycolipids, by cleaving their terminal sialic acids. For this, NEU1 depends on its interaction with the auxiliary protein protective protein/cathepsin A (PPCA). PPCA is essential for the stability of NEU1 and acts as a molecular chaperone for the subcellular localization and compartmentalization [7]. It can be assumed that NEU1 mutations that affect its interaction with PPCA may also lead to disease, even if the residues forming the active site of the enzyme remain intact [8]. In fact, researchers using the crystal structures of bacterial sialidases as templates have investigated numerous NEU1 amino acid substitutions related to different clinical phenotypes. Most of those substitutions appear to be located at the core surface of the molecule, demonstrating that they may affect the interaction of NEU1 with its chaperone PPCA. Three pathogenic mutations, F260Y, L270F, and A298V, gathered at the surface of the bacterial sialidases. These enzymes were correctly synthesized yet degraded instantly since the resulting proteins failed to associate with PPCA [9]. A putative region of interaction between NEU1 and PPCA was noticed after a careful study of the hydrodynamic properties of these two proteins. This region appeared to be crucial for NEU1 binding to the precursor form of PPCA. Therefore, *NEU1* mutations affecting amino acids within this domain may affect the stability of the enzyme and subsequent PPCA-mediated transportation to lysosomes [7–9]. It is crucial to remember that a primary defect of PPCA results in the lysosomal disorder galactosialidosis [2]. The similarity in the clinical symptoms of these two disorders can be attributed to the fact that the absence of functional PPCA results in a near-complete secondary deficiency of NEU1 [10].

Mechanisms of Pathogenesis in Sialidosis explained with the help of the Mouse Model: The *Neu1*^{-/-} knockout (KO) mouse model is helpful in understanding the underlying molecular mechanism(s) of sialidosis. *Neu1*^{-/-} mice demonstrated NEU1 as a negative regulator of lysosomal exocytosis. It was observed that in hematopoietic cells, NEU1 negatively regulates lysosomal exocytosis by processing the sialic acids on the lysosomal membrane protein 1 (LAMP1). LAMP1 is an integral membrane protein and plays a useful role in the docking of lysosomes at the plasma membrane (PM). Deficiency or impaired NEU1 activity causes defective processing of the sialic acids on LAMP1, causing accumulation of LAMP1 in an over-sialylated state with a prolonged half-life. This accumulation of over-sialylated LAMP1 increases the number of LAMP1-marked lysosomes that dock at the PM, poised to engage in lysosomal exocytosis upon an influx of calcium. LAMP1's essential function in the docking of lysosomes to the PM has been further supported by the fact that silencing *LAMP1* in NEU1-deficient cells normalize the number of lysosomes docked at the PM and thus decreased the extent of lysosomal

exocytosis. Hence, NEU1 loss of function ultimately results in the excessive extracellular release of lysosomal luminal contents from deficient cells of several tissues and organs (Figure 1). Excessive lysosomal exocytosis has now been associated with various pathological manifestations which are characteristic of sialidosis, including its role in neurodegeneration and links with Alzheimer’s disease, hearing loss, muscle atrophy and splenomegaly [11]. Moreover, phagocytosis in macrophages, which is regulated by NEU1, as well as NEU1-dependent regulation of insulin signaling are the other pathways that have been considered as additional pathological mechanisms involved in the NEU1 loss of function of the organs [12].

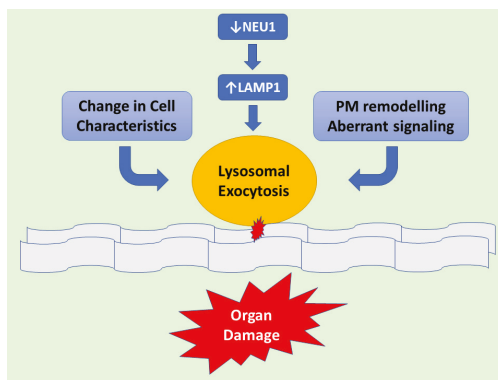


Figure 1. Schematic representation demonstrating downstream of NEU1 deficiency leads to LAMP1 accumulation causing an increased number of lysosomes at the plasmatic membrane (PM) resulting in exacerbated lysosomal exocytosis. Lysosomal-associated membrane protein 1 (LAMP1), aka lysosome-associated membrane glycoprotein 1 or CD107a, is a protein that in humans is determined by the *LAMP1* gene. This abnormal release of lysosomal content causes extracellular PM remodeling. Hence changes in cell characteristics take place with subsequent organ pathogenesis.

3. Morphological and Clinical Aspects of Sialidosis and *NEU1* Mutation(s)

3.1. Method of Study Selection, Criteria, and Data Extraction

Initially, an electronic search was done on Google Scholar, Scopus, and PUBMED. The search was conducted between the time of January 1980 to January 2018. The words used were sialidosis I, sialidosis II, congenital sialidosis, infantile sialidosis, juvenile sialidosis and combinations of these words. In the next step, reference lists of the publications were checked to identify any additional studies. The search was limited to studies published in English in the open literature in peer-reviewed journals.

Cases of sialidosis I typically present later in life (second to third decade); therefore, sialidosis I was discussed briefly in this study. However, for sialidosis II, all cases found were included in the paper since this condition is present in the pediatric group of patients.

Sialidosis (MIM #256550) is known as an autosomal recessive inherited disease. However numerous times, genetic alterations have been found in *NEU1* of unrelated sialidosis patients. So far, more than 40 mutations within the *NEU1* gene have been identified in patients with sialidosis types I and II. Age of onset and severity of the clinical manifestations are paralleled with *NEU1* mutations and the level of residual neuraminidase activity, demonstrating the existence of significant genotype-phenotype correlation in sialidosis.

NEU1 protein variants have been categorized into three groups based on biochemical properties. In the first group, the mutant enzyme stays catalytically inactive and does not localize to the lysosomes; whereas in the second group, the mutant protein localizes to the lysosomes yet is enzymatically inactive.

Finally, in the third group, the mutant protein has residual activity and localizes to the lysosomes. An association appears to exist between individual mutations and the clinical severity of sialidosis [7]. In the least severe form of sialidosis, the modification is thought to cause a decrease in sialidase activity. However, mutant sialidase has residual activity as well as localizing to the lysosomes. Hence, leading to sialidosis I.

3.2. *Sialidosis I*

Also known as cherry-red spot myoclonus syndrome, type I sialidosis is the less severe, non-neuropathic subtype of this disease. Patients typically exhibit symptoms in the second or third decade of life. Symptoms may include gait abnormalities, decreased visual acuity, or both. Patients usually have no physical defects. Their intelligence level may range from normal to slightly impaired [13]. Myoclonus is an essential feature of sialidosis I, which over the course of the disease tends to get disabling. Precipitating factors may include light touch, sound stimuli, voluntary movements, passive joint movements, voluntary movements, and dysarthria. Action myoclonus, intentional tremors, cerebellar ataxia, and hyperreflexia are the other commonly found symptoms [14]. Muscle strength may remain normal. However, hypotonia can be seen. In some cases, the patients may become wheelchair-bound as the disease progresses [7]. Laboratory tests for sialidosis include a thin-layer chromatography test that is a useful screening test to find an abnormal urinary oligosaccharide pattern. Peripheral blood smear or bone marrow smear may show the presence of storage granules in lymphocytes. Deficiency of the lysosomal sialidase activity (neuraminidase) can be demonstrated in cultured skin fibroblasts obtained from a skin biopsy and is an important diagnostic step. Importantly, in enzymatic studies, sialidosis is differentiated from galactosialidosis by analyzing the enzymatic activity of β -galactosidase which should be normal. The final diagnosis is made after whole genome sequencing. As mentioned earlier, symptoms and their extent of severity are closely associated with the type of *NEU1* mutations involved and subsequently the levels of residual enzyme activity [15].

Pathologically, cytoplasmic accumulation of sialyloligosaccharides has been observed in many neurons in the central nervous systems (CNS) of sialidosis patients. Moreover, neuroradiological imaging studies frequently reveal diffuse brain atrophy in the advanced stage of sialidosis type I, particularly of the cerebellar area [16]. However, initial neuroradiological investigations can be unremarkable in sialidosis 1. Studies also suggest that the major clinical effects seen are caused by changes at a level above the brainstem [17–20]. Further investigation in this area will help in understanding the underlying pathological mechanism which will consequently lead to the availability of better therapeutic approaches.

Atypical Cases of Sialidosis I

In the last decade, one crucial observation regarding sialidosis I is the presence of isolated instances of action myoclonus. Myoclonus, which is considered an essential feature of sialidosis I, has been seen in patients in the absence of other classic symptoms (macular cherry-red spot and sialyloligosacchariduria). After whole genome sequencing, mutations in *NEU1* were identified. This aspect elucidates the fact that mutations affecting *NEU1* activity can exist in the absence of other clinical signs that are characteristic of sialidosis [21]. This aspect warrants further studies in this area to investigate if there are more cases of sialidosis I than initially predicted.

3.3. *Sialidosis II*

Based on the age at onset of the symptoms, type II sialidosis is further divided into three subtypes: (i) congenital or hydropic (in utero); (ii) infantile (0–12 months); and (iii) juvenile (2–20 years) [7,22].

The congenital or hydropic subtype: Profoundly severe mutational alterations may lead to a complete absence of lysosomal neuraminidase and are lethal during fetal development or at birth. The congenital type of sialidosis, which is the severe form of the disease, is thought to be the result

of such mutations. It manifests itself prenatally and is characterized by ascites and hydrops fetalis, hepatomegaly and stillbirths or death at a very early age [7]. Table 1 summarizes the cases of congenital sialidosis reported from 1979 until now (cases presented before 1979 can be found in a previous review [5]). It can be observed that hydrops, ascites, and edema are the distinguishing features of the severe, congenital group of the disease, followed by coarse features, dysostosis multiplex, and hepatosplenomegaly. Renal involvement, cardiac anomalies, ophthalmic finding, myoclonus, inguinal hernia, telangiectasias, petechiae, bluish to purpuric macules and hydrocephalus are the clinical features that may infrequently manifest [9,22–46]. Studies reporting histopathological features of congenital sialidosis are limited. In one study, light microscopy of fetal tissues (after pregnancy was terminated at 20 weeks) exhibited vacuolation in the liver, bone marrow, kidney, and brain. In addition, an abnormal pattern of vacuolations was also present in the endocrine organs such as the thyroid gland, adrenal gland, hypophysis, testes as well as in the thymus. Moreover, vacuolation of the placenta demonstrated that in congenital sialidosis abnormal storage takes place during the early fetal period [36]. Figure 2 illustrates vacuolation of placenta, spleen, and thymus of a patient with congenital sialidosis.

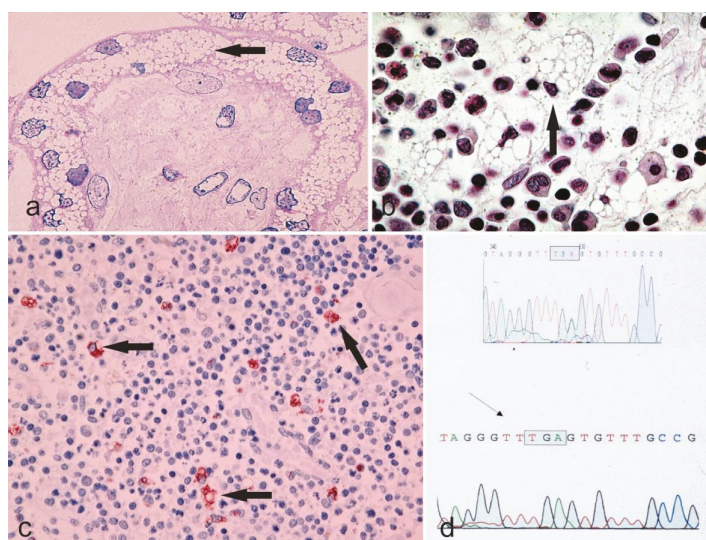


Figure 2. Microphotographs a–c showing the vacuolar degeneration of syncytium-trophoblast of a placenta (Hematoxylin & Eosin staining, 400 \times), bone marrow (Hematoxylin & Eosin staining, 630 \times , the arrow points to a cell with margination of the nucleus due to an engulfment of the cytoplasm with undigested material), and thymus (Anti-CD68 immunostaining, 200 \times with the arrows highlighting the macrophages) from a sialidosis pregnancy. The chromatogram in d shows the genetic alteration of the sialidosis gene.

Infantile/juvenile subtype: It has been suggested that *NEU1* mutations in which mutant enzymes localize to the lysosomes yet stay enzymatically inactive lead to the infantile/juvenile subtype of sialidosis II, which is characterized by the development of progressive mucopolysaccharidosis-like phenotype; Patients presenting with coarse facies, visceromegaly, dysostosis multiplex, vertebral deformities, mental retardation [7,47–55]. Table 2 summarizes the clinical features of the infantile/juvenile subtype. Skeletal abnormalities, mainly dysostosis multiplex appear to be a consistent feature of infantile/juvenile phenotypes, along with coarse facies, hepatosplenomegaly, and severe mental retardation. Ocular manifestations, including cherry red spots, cataracts, nystagmus,

strabismus, and corneal clouding are common as well while hypotonia, renal involvement, and cardiac anomalies are relatively infrequent findings. It is noticeable that earlier onset of disease has a fulminant course. While in late-onset, the patient may survive for more extended periods (only four patients survived for more than two decades). Hearing loss and ataxia may present in the late onset of infantile/juvenile form and tend to worsen with time. One case of sialidosis II was reported in the last decade, in which the patient developed myoclonic seizures at the age of 17, followed by dysphagia and dysphonia. There was a marked delay in motor and cognitive functions since childhood which worsened over time. However, the patient was able to achieve an elementary school education. At the time of diagnosis, the patient was 30 years old and bedridden, with an advanced degree of mental deficiency. It is notable that the patient was able to achieve education demonstrates that her cognitive delay was not as severe in childhood but progressed with age [55]. This detail seems essential and may aid in future developing therapeutic interventions in this area. Also, it is noteworthy that myoclonus, which is considered a characteristic of sialidosis I, is found in both Congenital as well as Infantile/Juvenile subtypes. (Tables 1 and 2).

NEU1 knockout model *Neu1*^{-/-} mice developed a systemic and neurodegenerative condition that is comparable to the early onset of sialidosis II [10] thus helping in understanding the clinical manifestation of this disease. Some typical clinical features that have been studied and explained are as follows. Hepatosplenomegaly is a fairly standard feature in sialidosis II. Enlargement of the spleen observed in *Neu1*^{-/-} mice is consistent with this finding. Histological studies of spleens in mutant mice showed a time-dependent expansion of total splenic cell counts along with an increased number of erythroid precursors and megakaryocytes. Along with these changes in the spleen, an increased number of hematopoietic progenitors in the peripheral blood and an overall lower number of these cells in the bone marrow (BM) was found. Thus, indicating extramedullary hematopoiesis (EMH) as the possible cause of splenic hypertrophy in *Neu1*^{-/-}. Furthermore, immunohistochemical studies of mutant livers showed a high number of erythroblasts, suggesting extramedullary hematopoiesis in this organ as well. Pathological studies of livers revealed initial ballooning followed by progressive, age-dependent filling of sinusoidal cells and hepatocytes with vacuoles [10]. Skeletal abnormalities frequently occur in sialidosis II. According to researchers, a possible hypothesis explaining the underlying pathogenesis is the impaired function of osteoclasts resulting in inefficient bone remodeling and consequently leading to bone deformities [10]. Hearing loss is another feature of sialidosis II that appears late in the disease. Studies of the (KO)model showed both conductive and neurosensory defects contribute to hearing loss in *Neu1*^{-/-} mice. It has been suggested that the absence of NEU1 and the potential exacerbation of lysosomal exocytosis in the inner ear are responsible for the occurrence of hearing the loss in *Neu1*^{-/-} mice. Histopathological studies exhibited thickened, cerumen occlusion in the external auditory canal, while in the middle ear infiltration of connective tissue with signs of chronic inflammation was noticed. Also, in many cells of the extensive cochlea vacuolization was seen [56]. In the brain, *Neu1*-null mice show extensive vacuolization of the epithelial cells of the choroid plexus and the endothelial cells of the ependymal layer 31, 33. Microglia and perivascular macrophages were among the most affected cells. This feature was prominently noticeable in the dentate gyrus and the hippocampus, but these cells are also scattered throughout the cortex and in the cerebellum, causing a widespread microgliosis [10]. Additionally, in the hippocampal region of the *Neu1*-null mice, recent studies have suggested a link between NEU1 deficiency-exacerbated lysosomal exocytosis and the spontaneous occurrence of Alzheimer's disease (AD)-like amyloidogenic process. Essentially accumulation in endo-lysosomes of an over sialylated amyloid precursor protein (APP), which is a newly identified substrate of NEU1, initiates the process. Next Endo-lysosomal APP is proteolytically cleaved to generate amyloid β -peptide isoforms (A β), which is ultimately released extracellularly by excessive lysosomal exocytosis. The finding that intracranial injection of NEU1 in the AD mouse model reduces the numbers of amyloid plaques and the levels of amyloid peptides is exceptionally important, as it demonstrates that NEU1 can be explored as a therapeutic approach for AD [57].

4. Therapeutic Interventions for Sialidosis

Due to the rarity of the disease, establishing optimum therapeutic measures remains a challenge although many promising methods are being proposed and being investigated. One attempt of enzyme replacement therapy (ERT) in *Neu1*^{-/-} mice using a recombinant NEU1 enzyme purified from overexpressing insect cells was made, which helped significantly in increasing levels of the NEU1 protein, and this treatment achieved subsequent correction of the underlying pathology in most of the systemic organs. However, the recombinant protein turned out to be highly immunogenic in the mutant mice and thus causes a severe immune response. Consequently, the therapeutic use of ERT became restricted [58,59]. Another study investigated the efficacy of the immuno-suppressant (Celastrol) along with a proteasomal inhibitor (MG132) as a therapeutic option for sialidosis. Researchers found that MG132 enhances enzyme activity and its localization in cells expressing defective sialidase provided promising results [60]. Additionally, chaperone-mediated gene therapy using a new mouse model has been suggested. The new mouse model ubiquitously expresses a NEU1 variant, which has a V54M amino acid substitution found in an adult patient with type I sialidosis. Mutant mice exhibited signs of lysosomal disease after one year of age, with low residual NEU1 activity detected in most organs and cell types. Injection of aged mutant mice with AAV-PPCA caused improvement of symptoms in the disease phenotype, hence suggesting that some NEU1 mutations associated with type I sialidosis may respond to PPCA-chaperone-mediated gene therapy [61]. Researchers believe that the treatment may be useful for other NEU1 mutations, particularly those in patients with type I sialidosis [8].

5. Conclusions and Future Perspectives

Sialidosis is an autosomal recessive disease resulting due to a mutation in the neuraminidase (*NEU1*) gene. Missense mutations appear to be the most commonly occurring. Among these mutations, a significant molecular heterogeneity is present, with a mixed variety of clinical phenotypes presenting either as sialidosis I or sialidosis II with different levels of severity. The onset of disease, the severity of symptoms, and prognosis differ in sialidosis I and sialidosis II. Bonten et al. demonstrated that this association between the clinical phenotype and severity of the disease is the result of the residual activity of the mutant enzymes. Patients with type II disease have catalytic inactive neuraminidase, while patients with the mild type I disease have active catalytic neuraminidase. In the type I disease, there is an absence of any obvious physical defects, and life expectancy remains unaffected. However, progressive visual loss and myoclonus, which may tend to get worse with time, can be disabling. In type II, the congenital subtype takes a fulminant course with very low life expectancy. Ascites and edema are the prominent features of this subgroup of the disease. In the infantile/juvenile sub type, characteristic features include hepatosplenomegaly, dysostosis multiplex, coarse facies, cherry-red spot, myoclonus, and severe mental retardation. Some clinical manifestations such as ataxia and hearing loss may become progressively severe with age. In the last decade, atypical cases of sialidosis I have been reported, and this aspect warrants further studies in this area to investigate if there are more cases of sialidosis I than initially predicted. Furthermore, the possibility suggested by previous researchers that, in addition to neuraminidase mutations, environmental factors including diet, prophylactic therapies, or other genetic factors may have some effect on the penetrance and severity of the disease and/or phenotype of the disease seems more plausible [7]. Perhaps in the future, a more detailed prenatal history inquiring about the diet, medication, and different types of environmental exposure of parents may help the researchers understand this aspect of the disease. Therapeutic options for sialidosis remain limited. Researchers have emphasized exploring treatment options for sialidosis I [8]. In sialidosis I, symptoms are relatively mild and appear late. Although intelligence level remains normal, myoclonus can be debilitating. Therefore, effective therapy may improve quality of life. In sialidosis type II patients, an early onset, systemic involvement, and a fulminant course make it more challenging to provide treatment. Perhaps it would be worthwhile to explore the suggestion of taking an in utero approach for therapy in the future. Alternatively, carrier detection in affected families, prenatal molecular diagnosis, and improved genetic counseling seem to be a suitable practical approaches.

Finally, NEU1 appears to have a crucial link with the CNS. Studies provide substantial evidence to demonstrate the NEU1 enzyme has a correlation with Alzheimer's disease. Further understanding of NEU1 and its link with the CNS may provide useful information regarding genetics, pathogenesis, and treatment of not only sialidosis, but also Alzheimer's disease.
