# Trigonometrically-Fitted Methods: A Review

**Abstract:** Numerical methods for the solution of ordinary differential equations are based on polynomial interpolation. In 1952, Brock and Murray have suggested exponentials for the case that the solution is known to be of exponential type. In 1961, Gautschi came up with the idea of using information on the frequency of a solution to modify linear multistep methods by allowing the coefficients to depend on the frequency. Thus the methods integrate exactly appropriate trigonometric polynomials. This was done for both first order systems and second order initial value problems. Gautschi concluded that “the error reduction is not very substantial unless” the frequency estimate is close enough. As a result, no other work was done in this direction until 1984 when Neta and Ford showed that “Nyström’s and Milne-Simpson’s type methods for systems of first order initial value problems are not sensitive to changes in frequency”. This opened the flood gates and since then there have been many papers on the subject.

**Keywords:** second order initial value problems; linear multistep methods; Obrechhoff schemes; trigonometrically fitted

## 1. Introduction

In this article, we discuss various methods for the numerical solution of the second order initial value problem

$$\begin{aligned}y'' &= f(x, y), \\y(x_0) &= y_0, \\y'(x_0) &= y'_0.\end{aligned}\tag{1}$$

If the initial value problem contains  $y'(x)$  then it is usually converted to a system of first order

$$\begin{aligned}y'_1(x) &= y_2, \\y_1(x_0) &= y_0, \\y'_2(x) &= f(x, y_1, y_2), \\y_2(x_0) &= y'_0,\end{aligned}\tag{2}$$

by defining new variables  $y_1 = y, y_2 = y'$ . In vector notation the system (2) can be written as

$$\mathbf{y}' = \mathbf{f}(x, \mathbf{y}), \quad \mathbf{y}(x_0) = \mathbf{y}_0,\tag{3}$$

where  $\mathbf{y} = [y_1, y_2]^T$ ,  $\mathbf{f} = [y_2, f(x, y_1, y_2)]^T$ , and  $\mathbf{y}_0 = [y_0, y'_0]^T$ .

Here we are concerned with trigonometrically-fitted methods for (1) and (3).

There are several classes of methods, such as linear multistep methods (including Obrechhoff methods) and Runge-Kutta methods. Here we will introduce each class and then review the extension of those to solution of problems for which the frequency is approximately known in advance.

Linear multistep methods for the solution of (3) are given by

$$\sum_{j=0}^k \alpha_j y_{n+j} = h \sum_{j=0}^{k'} \beta_j f_{n+j}, \tag{4}$$

and of (1) are given by

$$\sum_{j=0}^k \alpha_j y_{n+j} = h^2 \sum_{j=0}^{k'} \beta_j f_{n+j}, \tag{5}$$

where  $y_{n+j}$  is the approximate value at  $x_{n+j}$  and similarly for  $f_{n+j}$ . In here  $k$  is called the *step-number* and  $k'$  is either  $k - 1$  or  $k$ . In the former case the method is called *explicit* and in the latter it is called *implicit*. The coefficients  $\alpha_j$  and  $\beta_j$  are chosen to satisfy stability and convergence, as we describe in the sequel.

We now introduce the *first* and *second characteristic polynomials*,

$$\rho(\zeta) = \sum_{j=0}^k \alpha_j \zeta^j, \tag{6}$$

$$\sigma(\zeta) = \sum_{j=0}^{k'} \beta_j \zeta^j. \tag{7}$$

For (3) explicit methods for which  $\rho(\zeta) = \zeta^k - \zeta^{k-1}$  are called *Adams-Bashforth* and the implicit ones are called *Adams-Moulton*. Explicit methods for which  $\rho(\zeta) = \zeta^k - \zeta^{k-2}$  are called *Nyström methods* and the implicit ones are called *Generalized Milne-Simpson methods*. Gautschi [1] has developed Adams-type methods for first order equation as well as Nyström methods for the second order equation. Neta and Ford [2] only developed Nyström and Generalized Milne-Simpson methods for first order equation.

**Definition 1.** *If, for an arbitrary smooth enough test function  $z(x)$ , we have*

$$\sum_{j=0}^k \alpha_j z(x + jh) - h \sum_{j=0}^{k'} \beta_j z''(x + jh) = C_{p+1} h^{p+1} z^{(p+1)}(x) + O(h^{p+2}), \tag{8}$$

then,  $p$  is called the *order of the linear multistep method (4)* and  $C_{p+1}$  is its *error constant*.

The expression given by (8) is called the *local truncation error at  $x_{n+k}$  of the method (4)*, when  $z(x)$  is the *theoretical solution of the initial value problem (1)*.

In a similar fashion we have for (5)

$$\sum_{j=0}^k \alpha_j z(x + jh) - h^2 \sum_{j=0}^{k'} \beta_j z''(x + jh) = C_{p+2} h^{p+2} z^{(p+2)}(x) + O(h^{p+3}). \tag{9}$$

Throughout, we shall assume that the linear multistep method (4) satisfies the following hypotheses (see [3]):

- $\alpha_k = 1, |\alpha_0| + |\beta_0| \neq 0, \sum_{j=0}^{k'} |\beta_j| \neq 0$ .
- No common factors for the characteristic polynomials  $\rho$  and  $\sigma$ .
- $\rho(1) = 0, \rho'(1) = \sigma(1)$ ; this is a necessary and sufficient condition for the method to be *consistent*.
- The method is *zero-stable*; that is, all the roots  $\zeta_\ell$  of  $\rho$  satisfy  $|\zeta_\ell| < 1$  for  $\ell > 1$  and  $\zeta_1 = 1$ .

For the method (5) for second order initial value problems we have

- $\alpha_k = 1, |\alpha_0| + |\beta_0| \neq 0, \sum_{j=0}^{k'} |\beta_j| \neq 0.$
- No common factors for the characteristic polynomials  $\rho$  and  $\sigma.$
- $\rho(1) = \rho'(1) = 0, \rho''(1) = 2\sigma(1);$  which is a necessary and sufficient condition for the method to be consistent.
- The method is zero-stable.

We now consider the test equation (see, e.g., Chawla and Neta [4])

$$y''(x) = -\lambda^2 y(x). \tag{10}$$

Let  $\zeta_s, s = 1, 2, \dots, k$  denote the zeros of the polynomial

$$\Omega(\zeta, H^2) = \rho(\zeta) + H^2\sigma(\zeta), \tag{11}$$

for  $H = \lambda h$  and let  $\zeta_1, \zeta_2$  correspond to perturbations of the principal roots of  $\rho(\zeta).$  We define interval of periodicity  $(0, H^2)$  if, for all  $H^2$  in the interval, the roots  $\zeta_s$  of (11) satisfy  $\zeta_1 = e^{i\theta(H)}, \zeta_2 = e^{-i\theta(H)}, |\zeta_s| \leq 1, s \geq 3$  and  $\theta(H)$  is real.

If the interval of periodicity is  $(0, \infty),$  then the method is called P-stable. Lambert and Watson [5] had shown that P-stable linear multistep methods are implicit of order at most 2.

**Remark 1.** If the problem (1) has periodic solutions and the period is not known, then the P-stability is desirable. If the period is known approximately, then one can use the ideas in Gautschi [1], Neta and Ford [2], and others to be reviewed here.

Another important property when solving (1) is the phase lag which was introduced by Brusa and Nigro [6]. Upon applying a linear two-step method to the test Equation (10), we obtain a difference equation of the form

$$A(H)y_{n+2} + B(H)y_{n+1} + C(H)y_n = 0, \tag{12}$$

whose solution is

$$y_n = B_1\lambda_1^n + B_2\lambda_2^n, \tag{13}$$

where  $B_1$  and  $B_2$  are constants depending on the initial conditions. The quadratic polynomial

$$A(H)\lambda^2 + B(H)\lambda + C(H) = 0, \tag{14}$$

is called the stability polynomial. The solutions to (14) are given by

$$\begin{aligned} \lambda_1 &= e^{(-a(H)+ib(H))H}, \\ \lambda_2 &= e^{(-a(H)-ib(H))H}. \end{aligned} \tag{15}$$

If  $a(H) \equiv 0$  and  $b(H) \equiv 1,$  then we get the exact solution to the test Equation (10). The difference between the amplitudes of the exact solution of (10) and numerical solution is called dissipation error, see [7]. The expansion  $b(H) - 1$  in powers of  $H$  is called phase lag expansion. The modulus of the leading terms is the phase lag of the method. See also Thomas [8] and Twizell [9].

**Remark 2.** Raptis and Simos have developed methods with minimal phase-lag and also P-stable methods in [10–14].

We now introduce an extension to the linear multistep methods. These are called multiderivative or Obrechhoff methods, see Obrechhoff [15] or [16].

For the first order equation we have

$$\sum_{j=0}^k \alpha_j y_{n-j+1} = \sum_{i=1}^{\ell} \sum_{j=0}^k \beta_{ij} h^i y_{n-j+1}^{(i)} \tag{16}$$

and for the second order equation

$$\sum_{j=0}^k \alpha_j y_{n-j+1} = \sum_{i=1}^{\ell} \sum_{j=0}^k \beta_{ij} h^{2i} y_{n-j+1}^{(2i)} \tag{17}$$

According to Lambert and Mitchell [17], the error constant decreases more rapidly with increasing  $\ell$  rather than the step  $k$ . Thus, one can get one-step high order methods. A list of Obrechhoff methods for various  $k$  and  $\ell$  is given in [17] for first order equations and in [18] for second order equations.

Several P-stable Obrechhoff methods for second-order initial-value problems (for  $\ell \leq 3$ ) were derived by Van Daele and Vanden Berghe [19]. Ananthakrishnaiah [18] has also included the case  $\ell = 4$ .

Lastly, we introduce Runge-Kutta-Nyström (RKN) methods.

The general form of an explicit  $k$ -stage two-step Runge-Kutta-Nyström method (RKN) for the solution of (1) is given by, see Franco and Rández [20]

$$Y_i = (1 + c_i)y_n - c_i y_{n-1} + h^2 \sum_{j=1}^k a_{ij} f(x_n + c_j h, Y_j), \tag{18}$$

$$y_{n+1} = 2y_n - y_{n-1} + h^2 \sum_{i=1}^k b_i f(x_n + c_i h, Y_i). \tag{19}$$

Vigo-Aguar and Ramos [21] introduced methods based on Runge-Kutta collocation.

**Definition 2.** *Trigonometrically-fitted RKN method (18)–(19) integrates exactly the functions  $\sin(\lambda x)$  and  $\cos(\lambda x)$  with  $\lambda > 0$  the principal frequency of the problem when applied to the test Equation (10).*

In general, a method integrates exactly the set of functions  $\{u_1(x), u_2(x), \dots, u_r(x)\}$ ,  $r \leq k$  if the following conditions are satisfied

$$\begin{aligned} u_{\ell}(x_n + h) &= 2u_{\ell}(x_n) - u_{\ell}(x_n - h) + h^2 \sum_{i=1}^k b_i u_{\ell}''(x_n + c_i h), \ell = 1, \dots, r \\ u_{\ell}(x_n + c_i h) &= (1 + c_i)u_{\ell}(x_n) - c_i u_{\ell}(x_n - h) + h^2 \sum_{j=1}^k a_{ij} u_{\ell}''(x_n + c_j h), \\ i &= 1, \dots, k, \ell = 1, \dots, r \end{aligned} \tag{20}$$

## 2. Methods Based on Linear Multistep Methods

The idea of fitting functions other than monomials goes back to Greenwood [22], Brock and Murray [23], Dennis [24], Gautschi [1] and Salzer [25].

The first paper suggesting the use of the frequency of the solution is due to Gautschi [1]. He considered Störmer type methods for the solution of (1). The idea is to allow the coefficients to depend on the frequency  $\omega$ . Let  $\mathcal{L}$  be a functional defined by

$$\mathcal{L}y = \sum_{j=0}^k [\alpha_j y(x_0 + (n + 1 - j)h) - h\beta_j f(x_0 + (n + 1 - j)h)], \tag{21}$$

where  $\alpha_0 = 1$ . Since we are introducing trigonometric functions, we refer to order as *algebraic order* and define *trigonometric order* as follows:

**Definition 3.** A linear functional  $\mathcal{L} \in C^s[a, b]$  is said to be of algebraic order  $p$ , if

$$\mathcal{L}x^r \equiv 0, \quad r = 0, 1, \dots, p,$$

and  $\mathcal{L}x^{p+1}$  does not vanish. Therefore we have  $p + 1$  conditions for methods of algebraic order  $p$ .

The method

$$\sum_{j=0}^k \alpha_j y_{n+j} = h \sum_{j=0}^{k'} \beta_j(v) f_{n+j}, \tag{22}$$

where  $v = \omega h$  and  $\alpha_k = 1$  is said to be of trigonometric order  $q$  relative to the frequency  $\omega$  if the associated linear functional

$$\mathcal{L}y(x) = \sum_{j=0}^k \alpha_j y_{n+j} - h \sum_{j=0}^{k'} \beta_j(v) y'_{n+j}$$

satisfies

$$\mathcal{L}1 \equiv 0,$$

and

$$\mathcal{L} \cos(r\omega x) \equiv \mathcal{L} \sin(r\omega x) \equiv 0, \quad r = 1, 2, \dots, q,$$

and  $\mathcal{L} \cos((q + 1)\omega x)$  and  $\mathcal{L} \sin((q + 1)\omega x)$  are not both identically zero.

Therefore, methods of trigonometric order  $q$  satisfy  $2q + 1$  conditions.

Linear multistep or trigonometrically fitted method for second order ordinary differential equations (ODEs) (1) satisfy an additional condition

$$\mathcal{L}x \equiv 0$$

for the same order, see Lambert [3].

**Remark 3.** The trigonometric order is lower than the algebraic order, since the trigonometric polynomials requires two conditions for each degree, see Lambert [3].

Gautschi [1] allowed the coefficients  $\alpha_j$  to depend on  $v$  and listed several explicit and implicit methods of trigonometric orders  $q \leq 3$ . The form of the explicit methods is:

$$y_{n+1} + \alpha_{q1}(v)y_n + \alpha_{q2}(v)y_{n-1} = h^2 \sum_{j=1}^{2q-1} \beta_{qj}(v) f_{n+1-j}. \tag{23}$$

We only list the methods of trigonometric orders 1 and 2 using powers of  $\cos(v)$  instead of the Taylor series expansions shown in [1]. Those Taylor series expansions should be used when  $h \rightarrow 0$ .

For  $q = 1$ , the coefficients are:

$$\alpha_{11} = -2, \quad \alpha_{12} = 1, \quad \beta_{11} = \left( \frac{2 \sin(v/2)}{v} \right)^2. \tag{24}$$

For  $q = 2$ , the coefficients are:

$$\begin{aligned} \alpha_{21} &= \frac{2}{3} (\cos(2v) - 4 \cos(v)), \\ \alpha_{22} &= -\alpha_{21} - 1, \\ \beta_{21} &= \frac{1 - 16 \cos(v)^3 + 9 \cos(v) + 7}{6 v^2 (2 \cos(v) + 1)}, \\ \beta_{22} &= \frac{1}{3} \frac{8 \cos(v)^3 - 9 \cos(v)^2 - 3 \cos(v) + 4}{v^2 (2 \cos(v) + 1)}, \\ \beta_{23} &= \frac{1}{2} \frac{1 - \cos(v)}{v^2 (2 \cos(v) + 1)}. \end{aligned} \tag{25}$$

The form of the implicit methods is:

$$y_{n+1} + \alpha_{q1}(v)y_n + \alpha_{q2}(v)y_{n-1} = h^2 \sum_{j=0}^{2q-2} \beta_{qj}(v)f_{n+1-j}. \tag{26}$$

For  $q = 1$ , the coefficients are:

$$\begin{aligned} \alpha_{11} &= \frac{2 \cos(v)}{1 - 2 \cos(v)}, \\ \alpha_{12} &= -\alpha_{11} - 1, \\ \beta_{10} &= \frac{2(1 - \cos(v))}{v^2 (2 \cos(v) - 1)}. \end{aligned} \tag{27}$$

For  $q = 2$ , the coefficients are:

$$\begin{aligned} \alpha_{21} &= -2, \\ \alpha_{22} &= 1, \\ \beta_{20} &= \frac{1}{2} \frac{1 - \cos(v)}{v^2 (2 \cos(v) + 1)}, \\ \beta_{21} &= \frac{2 + \cos(v) - 3 \cos(v)^2}{v^2 (2 \cos(v) + 1)}, \\ \beta_{22} &= \beta_{20}. \end{aligned} \tag{28}$$

Neta and Ford [2] have constructed the *Nyström* and *Generalized Milne-Simpson methods* for a first order (3) where the coefficients  $\beta_j$  are functions of the frequency. Here we list a few of those.

For  $q = 1$ , the explicit method is

$$y_{n+2} - y_n = \frac{2 \sin(v)}{v} h f_{n+1}. \tag{29}$$

For  $q = 2$ , the explicit method is

$$y_{n+4} - y_{n+2} = -h \frac{\sin(v)}{v(1 + 2 \cos(v))} [f_n + 2(1 - 2 \cos(v))(1 + \cos(v))f_{n+1} + (4 \cos(v) \cos(2v) + 1)f_{n+2} - 4 \cos(v)(1 + \cos(v))f_{n+3}]. \tag{30}$$

For  $q = 1$ , the implicit method is a one-parameter family

$$y_{n+2} - y_n = h \left[ \beta_0 f_n + \left( \frac{2 \sin(v)}{v} - 2\beta_0 \cos(v) \right) f_{n+1} + \beta_0 f_{n+2} \right]. \tag{31}$$

Note that the choice  $\beta_0 = 0$  leads to the explicit method (29).

For  $q = 2$ , the implicit method is

$$y_{n+3} - y_{n+1} = h \frac{\sin(v)}{v(1 + 2 \cos(v))} [f_{n+1} + 2(1 + \cos(v))f_{n+2} + f_{n+3}]. \tag{32}$$

Vigo-Aguiar and Ramos [26] show how to choose the frequency for nonlinear ODEs. Van der Houwen and Sommeijer [27] have developed predictor-corrector methods. Neta [28] has developed exponentially fitted methods for problems whose oscillatory solution is damped. Raptis and Allison [29] have used the idea for the solution of Schrödinger equation. Stiefel and Bettis [30] have stabilized Cowell’s method [31] by fitting trigonometric polynomials. Lambert and Watson [5] introduced symmetric multistep methods which have non-vanishing interval of periodicity. Quinlan and Termaine [32] have developed high order symmetric multistep methods. Simos and Vigo-Aguiar [33] have developed exponentially-fitted symmetric methods of algebraic order eight based on the work of [32]. They demonstrated the superiority of their method on two orbital examples integrated on a long time interval  $t \in [0, 10^5]$ . Another idea developed by Neta and Lipowski [34] is to use the energy of the system instead of integrating the angular velocity. They have demonstrated the benefit of their method using several examples for perturbation-free flight and a more general case on long time flight. Vigo-Aguiar and Ferrándiz [35] have developed a general procedure for the adaptation of multistep methods to numerically solve problems having periodic solutions. Vigo-Aguiar et al. [36] and Martín-Vaquero and Vigo-Aguiar [37] have developed methods for stiff problems by using Backward Differentiation Formulae (BDF) methods. See also Neta [38].

Sommeijer et al. [39] have suggested a different idea for trigonometrically-fitted methods. Instead of requiring fitting cosine and sine functions of multiple of the frequency, they suggest taking several frequencies in some interval around the known frequency. The frequencies are chosen to be the roots of a Chebyshev polynomial, so that we minimize the maximum error. Such methods were called minimax methods. See also Neta [40].

We now give more details. Suppose we have an interval  $[\underline{\omega}, \bar{\omega}]$  of frequencies and we pick  $q$  frequencies

$$\omega_j = \frac{1}{2} \left( (\bar{\omega})^2 + (\underline{\omega})^2 \right) + \frac{1}{2} \left( (\bar{\omega})^2 - (\underline{\omega})^2 \right) \cos\left(\frac{2j-1}{2q} \pi\right)^{1/2}.$$

The idea is to interpolate the sine and cosine functions of those frequencies

$$\mathcal{L}1 \equiv 0,$$

and

$$\mathcal{L} \cos(\omega_r x) \equiv \mathcal{L} \sin(\omega_r x) \equiv 0, \quad r = 1, 2, \dots, q.$$

Thus for the second order initial value problem, we have the system

$$(h\omega_j)^2 \left\{ \sum_{\ell=0}^{k/2-1} 2b_\ell \cos((k/2 - \ell)h\omega_j) + b_{k/2} \right\} = - \sum_{\ell=0}^k a_\ell \cos((k/2 - \ell)h\omega_j),$$

for  $j = 1, \dots, q$ . Unfortunately, this yields very messy coefficients and we will not list any of them here.

### 3. Methods Based on Obrechhoff Methods

Simos [41] has developed a P-stable trigonometrically-fitted Obrechhoff method of algebraic order 10 for (1).

$$y_{n+1} - 2y_n + y_{n-1} = \sum_{j=1}^3 h^{2j} [b_{j0}y_{n+1}^{(2j)} + 2b_{j1}y_n^{(2j)} + b_{j0}y_{n-1}^{(2j)}], \tag{33}$$

where

$$\begin{aligned} b_{10} &= \frac{89}{1878} - \frac{15120}{313}b_{31}, \\ b_{11} &= \frac{425}{939} + \frac{15120}{313}b_{31}, \\ b_{20} &= -\frac{1907}{1577520} + \frac{660}{313}b_{31}, \\ b_{21} &= \frac{30257}{1577520} + \frac{690}{313}b_{31}, \\ b_{30} &= \frac{59}{3155040} - \frac{13}{313}b_{31}. \end{aligned} \tag{34}$$

In order to ensure P-stability, the coefficient  $b_{31}$  must be

$$\begin{aligned} b_{31} = & \left( 190816819200[1 - \cos(H)] - 95408409600H^2 + 7950700800H^4 \right. \\ & \left. - 265023360H^6 + 4732560H^8 - 52584H^{10} + 1727H^{12} \right) / (3568320H^{12}). \end{aligned} \tag{35}$$

The method requires an approximation of the first derivative which is given by

$$y'_{n+1} = \frac{1}{2h} (y_{n-1} - 4y_n + 3y_{n+1}) - \frac{h}{12} (y''_{n-1} + 2y''_n + 3y''_{n+1}). \tag{36}$$

He showed that the local truncation error is

$$LTE = \left( -\frac{2923}{209898501120} + \frac{59}{1577520}b_{31} \right) h^{12}y_n^{(12)}.$$

Wang et al. [42] have suggested a slight modification to the coefficient  $b_{31}$  as follows

$$b_{31} = \frac{3155040 - 1428000H^2 + 60514H^4 - a_1 \cos(H)}{5040H^2(-15120 + 6900H^2 - 313H^4 + a_2 \cos(H))}, \tag{37}$$

where  $a_1 = 3155040 + 149520H^2 + 3814H^4 + 59H^6$  and  $a_2 = 15120 + 660H^2 + 13H^4$ .



Wang et al. [42] have developed a method of algebraic order 12 as follows

$$\begin{aligned}
 y_{n+1} - 2y_n + y_{n-1} &= h^2 (\alpha_1 (y''_{n+1} + y''_{n-1}) + \alpha_2 y''_n) \\
 &+ h^4 (\beta_1 (y''_{n+1} + y''_{n-1}) + \beta_2 y''_n) \\
 &+ h^6 (\gamma_1 (y''_{n+1} + y''_{n-1}) + \gamma_2 y''_n),
 \end{aligned}
 \tag{38}$$

where

$$\begin{aligned}
 \alpha_1 &= \frac{229}{7788}, \beta_1 = -\frac{1}{2360}, \beta_2 = \frac{711}{12980}, \\
 \gamma_1 &= \frac{127}{39251520}, \gamma_2 = \frac{2923}{3925152},
 \end{aligned}$$

and  $\alpha_2$  is chosen so the method is P-stable,

$$\alpha_2 = -2H^{-2} + H^2\beta_2 - H^4\gamma_2 + 2 \cos(H) (H^{-2} - \alpha_1 + H^2\beta_1 - H^4\gamma_1).$$

The method is of algebraic order 12 and the local truncation error is now

$$LTE = \frac{45469}{1697361329664000} h^{14} (\omega^{12} y''_n - y_n^{(14)}).$$

The first order derivative is obtained by

$$\begin{aligned}
 y'_{n+1} &= \frac{1}{66h} (305y_{n+1} - 544y_n + 239y_{n-1}) + \frac{h}{1980} (-5728y''_n - 571y''_{n-1} + 119y''_{n+1}) \\
 &+ \frac{h^2}{2970} (128y'''_n - 173y'''_{n-1}) + \frac{h^3}{2970} (-346y_n^{(4)} - 13y_{n-1}^{(4)}) + \frac{h^5}{62370} (-71y_n^{(6)} + y_{n-1}^{(6)}).
 \end{aligned}$$

**Remark 4.** Neta [43] has developed a P-stable method of algebraic order 18.

Vanden Berghe and Van Daele [44] have suggested fitting a combination of monomials and exponentials, i.e., the set  $\{1, x, \dots, x^K, e^{\pm\mu x}, xe^{\pm\mu x}, \dots, x^P e^{\pm\mu x}\}$ . Clearly when  $\mu$  is purely imaginary, we get the cosine and sine functions. When  $K = -1$ , we get only the exponential functions and when  $P = -1$  we get only monomials (which is the well known Obrechhoff method). Even when  $K = -1$ , we are not getting the cosine and sine functions of multiples of the frequency as in the previously discussed methods. They developed methods of algebraic order 8. Here we list only two of those, one with  $K = 5, P = 1$  (39) and the other with  $K = 7, P = 0$  (40).

The first method is given by

$$\begin{aligned}
 b_{10} &= \frac{1}{12} - 2b_{20} - 2b_{21}, \\
 b_{11} &= \frac{5}{12} + 2b_{20} + 2b_{21}, \\
 b_{20} &= \frac{v^5 \sin(v) + 2(\cos(v) + 5)v^4 + 48(\cos(v) - 1)A}{12v^4(v^3 \sin(v) - 4(1 - \cos(v))^2)}, \\
 b_{21} &= \frac{5v^5 \sin(v) - 2 \cos(v)(\cos(v) + 5)v^4 - 48(\cos(v) - 1)B}{12v^4(v^3 \sin(v) - 4(1 - \cos(v))^2)},
 \end{aligned}
 \tag{39}$$

where  $A = (v^2 + \cos(v) - 1)$  and  $B = (v^2 \cos(v) + \cos(v) - 1)$ .

The second method is

$$\begin{aligned}
 b_{10} &= \frac{1}{30} - 12b_{20}, \\
 b_{11} &= \frac{7}{15} + 12b_{20}, \\
 b_{20} &= \frac{4 \cos(v)v^2 + 56v^2 - 3v^4 + 120 \cos(v) - 120}{120v^2(12 \cos(v) - 12 + \cos(v)v^2 + 5v^2)}, \\
 b_{21} &= \frac{1}{40} + 5b_{20}.
 \end{aligned}
 \tag{40}$$

#### 4. Methods Based on Runge-Kutta

For a trigonometrically-fitted method, we have (see Franco and Rández [20])

$$\begin{aligned}
 \sum_{i=1}^k b_i \cos(c_i v) &= \frac{2(\cos(v) - 1)}{v^2}, \\
 \sum_{i=1}^k b_i \sin(c_i v) &= 0, \\
 \sum_{j=1}^k a_{ij} \cos(c_j v) &= \frac{\cos(c_i v) + c_i \cos(v) - (1 + c_i)}{v^2}, \quad i = 1, \dots, k, \\
 \sum_{j=1}^k a_{ij} \sin(c_j v) &= \frac{\sin(c_i v) - c_i \sin(v)}{v^2}, \quad i = 1, \dots, k.
 \end{aligned}
 \tag{41}$$

The solution for  $k = 3$  is given in Franco [45]

$$\begin{aligned}
 c_1 &= -1, \\
 c_2 &= 0, \\
 c_3 &= 1, \\
 b_1 &= \frac{2 \cos(v) - 2 - v^2}{2v^2(\cos(v) - 1)}, \\
 b_2 &= \frac{(2 - v^2) \cos(v) - 2}{v^2(\cos(v) - 1)}, \\
 b_3 &= b_1, \\
 a_{31} &= 0, \\
 a_{32} &= \frac{2(\cos(v) - 1)}{v^2}, \\
 a_{33} &= 0.
 \end{aligned}
 \tag{42}$$

This method has an algebraic order 2 and reduces to the two-stage explicit Numerov method of Chawla [46]. The method integrates exactly the set of functions  $\{1, x, x^2, \cos(\omega x), \sin(\omega x)\}$ , similar to the idea of Vanden Berghe and Van Daele [44].

Franco and Rández [20] have developed a 7-stage method of algebraic order 7 which integrates exactly the monomials up to  $x^6$  and  $\sin(\omega x)$  and  $\cos(\omega x)$ . A 5-stage family of methods of algebraic order 6 listed here and in Tsitouras [47] has been developed by Fang et al. [48]. Here we list just one member of the family.

$$c_1 = -1, \quad c_2 = 0, \quad c_3 = \frac{1}{2}, \quad c_4 = -\frac{1}{2}, \quad c_5 = 1,
 \tag{43}$$

$$\begin{aligned}
 a_{31} &= -\frac{\sin^2(v/4)}{v^2 \cos(v/2)}, \\
 a_{32} &= \frac{2 \cos(v/2) + 2 \cot(v) \sin(v/2) - 3}{2v^2}, \\
 a_{41} &= \frac{36 + v^2 - 36 \cos(v/2)}{72v^2 \cos(v/2)}, \\
 a_{42} &= \frac{36 \sin(v/2) - v^2 \sin(3v/2) - 18 \sin(v)}{36v^2 \sin(v)}, \\
 a_{43} &= \frac{1}{36}, \\
 a_{51} &= -\frac{2}{9 \cos(v/2)}, \\
 a_{52} &= \frac{2 \cos(v) - 2}{v^2} - \frac{1}{3 \cos(v/2)} - \frac{2 \sin(3v/2)}{9 \sin(v)}, \\
 a_{53} &= \frac{2}{9}, \\

$$\begin{aligned}
 b_1 = b_5 &= \frac{6 \cos(v) - 6 - v^2 - 2v^2 \cos(v/2)}{48v^2 \sin^4(v/4)}, \\
 b_2 &= \frac{(18 + v^2) \cos(v) - 18 - 10v^2 \cos(v/2)}{24v^2 \sin^4(v/4)}, \\
 b_3 = b_4 &= \frac{12 + 5v^2 + (v^2 - 12) \cos(v)}{24v^2 \sin^4(v/4)}.
 \end{aligned} \tag{45}$$

Demba et al. [49] have developed fourth and fifth order Runge-Kutta-Nyström trigonometrically-fitted methods for (1). The idea is based on using 3-stage method to get a 4-stage trigonometrically-fitted method. Here we list the coefficients

$$y_{n+1} = y_n + hy'_n + h^2 \sum_{i=1}^s b_i f(x_n + hc_i, Y_i) \tag{46}$$

$$y'_{n+1} = y'_n + h \sum_{i=1}^s d_i f(x_n + hc_i, Y_i) \tag{47}$$

where  $Y_i$  are given by (18) and

$$\begin{aligned}
 c_1 &= 0, \\
 c_2 &= \frac{3}{16} \frac{v^3 \cos(v) - 5v^2 \sin(v) + 4v^3 - 32v \cos(v) + 160 \sin(v) - 128v}{v(6v \sin(v) + v^2 + 30 \cos(v) - 30)}, \\
 c_3 &= -\frac{3}{500} \frac{-11v^6(4 + \cos(v)) + 55v^5 \sin(v) + v^4(38 \cos(v) + 1536) + T_1 + T_2}{v^2(6v \sin(v) + v^2 + 30 \cos(v) - 30)}, \\
 a_{2,1} &= \frac{1}{32}, \\
 a_{3,1} &= -\frac{1}{1000} \frac{-11v^5 + 384v^3 + 2112 \sin(v) - 2112v}{v^3}, \\

where

$$T_1 = -1920v^3 \sin(v) + 2112v \cos(v) \sin(v) - v^2(672 \cos(v) + 4448) + 10560 \cos(v)^2,$$

and

$$\begin{aligned}
 T_2 &= +3008v \sin(v) - 21120 \cos(v) + 10560, \\
 b_1 &= \frac{1}{24}, \\
 b_2 &= \frac{16}{165} \frac{v^4 + 66v \sin(v) - 21v^2 + 330 \cos(v) - 330}{v^2(v^2 - 32)}, \\
 b_3 &= \frac{25}{264}, \\
 d_1 &= \frac{1}{24}, \\
 d_2 &= \frac{16}{33}, \\
 d_3 &= \frac{125}{264}.
 \end{aligned}

The Taylor series expansion of the coefficients is given by

$$\begin{aligned}
 a_{3,1} &= -4/125 - (33/5000)v^2 + (11/26250)v^4 - (11/1890000)v^6, \\
 b_2 &= 4/11 - (1/3600)v^4 + (1/161280)v^6, \\
 c_2 &= 1/4 - (1/26880)v^4 + (19/7741440)v^6, \\
 c_3 &= 4/5 + (13/4375)v^4 - (257/3780000)v^6.
 \end{aligned}
 \tag{50}$$

### 5. Comments on Order

Definition 1 of order (see (8) and (9)) can be extended to trigonometrically fitted methods. Note that a method is of order  $p$  for first (second) order ODEs if it fits monomials up to degree  $p + 1$  ( $p + 2$ ), respectively. Therefore, methods of trigonometric order  $q$  are methods of order  $2q$ . Method, such as (39) for second order ODEs is of eighth order, since it fits monomial up to degree 5, and  $x^n \cos(\omega x)$ ,  $x^n \sin(\omega x)$ ,  $n = 0, 1$ . In Table 1, we will list all methods used in the examples with their order.

### 6. Numerical Examples

The methods developed originally by Gautschi [1] and those that follow by Neta and Ford [2] fit low order monomials and the sine and cosine functions of multiples of the frequency. On the other hand, the methods developed later by Vanden Berghe and Van Daele [44] use monomials and product of monomials and sine and cosine functions of the frequency. We will demonstrate via the first three examples the difference between the two strategies. Vanden Berghe and Van Daele [50] compared the two approaches in some cases but not used schemes developed by Neta and Ford [2]. In the latter examples we also compare the results to Runge-Kutta-Nyström based method (46)–(49), see [49].

First, we list a method of trigonometric order 2 based on the idea of Vanden Berghe and Van Daele [44], which we obtained using Maple software, see Chun and Neta [51].

$$y_{n+1} + a_1 y_n + a_2 y_{n-1} = h^2 (b_1 f_n + b_2 f_{n-1} + b_3 f_{n-2}), \tag{51}$$

where

$$\begin{aligned} a_1 &= -\sin(v)v - 2\cos(v), \\ a_2 &= -1 - a_1, \\ b_1 &= \frac{v(v\sin(v) - 1)(\cos(v) + 1) + 2\sin(v)}{v^3(1 + \cos(v))}, \\ b_2 &= \frac{v(2 - v\sin(v))(\cos(v) + 1) - 4\sin(v)\cos(v)}{v^3(1 + \cos(v))}, \\ b_3 &= \frac{2 - v\sin(v) - 2\cos(v)}{v^3\sin(v)}. \end{aligned} \tag{52}$$

The Taylor series expansion of the coefficients are

$$\begin{aligned} a_1 &= -2 + \frac{1}{12}v^4 - \frac{1}{180}v^6, \\ a_2 &= -1 - a_1, \\ b_1 &= \frac{13}{12} - \frac{19}{120}v^2 + \frac{37}{4032}v^4 - \frac{41}{362880}v^6, \\ b_2 &= -\frac{1}{6} + \frac{3}{20}v^2 - \frac{59}{10080}v^4 + \frac{13}{36288}v^6, \\ b_3 &= \frac{1}{12} + \frac{1}{120}v^2 + \frac{17}{20160}v^4 + \frac{31}{362880}v^6. \end{aligned} \tag{53}$$

**Example 1.** The first example is chosen so that the exact solution in a combination of sine and cosine of multiples of the frequency, i.e.,

$$y''(x) + 9y(x) = 3\sin(6x), \quad 0 \leq x \leq 40\pi \tag{54}$$

subject to the initial conditions

$$y(0) = 1, \quad y'(0) = 3. \tag{55}$$

The exact solution is

$$y_{exact}(x) = \frac{11}{9}\sin(3x) + \cos(3x) - \frac{1}{9}\sin(6x). \tag{56}$$

The results using  $h = \pi/500$  are given in Table 2. We expect the methods that fit sine and cosine of multiples of the frequency will do better.

**Table 2.** The  $L_2$  norm of the error for the first example using three methods for three different values around the exact frequency.

Based on the results we see that (25) is best when the frequency is known exactly. If it is not known exactly, the method prefers underestimation of the frequency. The second best is (30). This method will have no preference to underestimation.

**Example 2.** *The second example is very similar*

$$y''(x) + 9y(x) = 3 \sin(3x), \quad 0 \leq x \leq 40\pi \tag{57}$$

subject to the initial conditions

$$y(0) = 1, \quad y'(0) = 3. \tag{58}$$

The exact solution is

$$y_{exact}(x) = \frac{7}{6} \sin(3x) + \cos(3x) - \frac{1}{2}x \cos(3x). \tag{59}$$

The results are given in Table 3. Now we expect that the method (51) due to Chun and Neta [51] will perform better, since the exact solution has a product of monomial and cosine. In fact this is the case followed by (25). The method (30) requires smaller step size to converge and the results are not as good as those of the other two methods. Note that for this example all methods have no preference to underestimation of the frequency.

**Example 3.** *What if the frequency of the forcing term is not an integer multiple of the frequency of the homogeneous solution? We now consider the following example*

$$y''(x) + 9y(x) = 3 \sin(4x), \quad 0 \leq x \leq 40\pi \tag{60}$$

subject to the initial conditions

$$y(0) = 1, \quad y'(0) = 3. \tag{61}$$

The exact solution is

$$y_{exact}(x) = \frac{11}{7} \sin(3x) + \cos(3x) - \frac{3}{7} \sin(4x). \tag{62}$$

The results are given in Table 4. Now (51) is best followed by (30).

**Table 4.** The  $L_2$  norm of the error for the third example using three methods for three different values around the exact frequency.

Based on the three examples, we find that (51) is best in the last two examples, but not in the first case where the frequency of the forcing term is a multiple of the frequency of the homogeneous solution.

Before moving to the rest of the experiments, we have decided to rerun the first example on a much longer interval. This will test the quality of those methods in long-term integration. We have taken the same step size  $h = \pi/500$  and integrated for  $0 \leq x \leq 4000\pi$ . The results are given in Table 5. It is clear that the method due to Neta and Ford is no longer viable. The method (51) gave same errors when  $\omega = 3$  but all other cases show lower accuracy at the end of the longer interval

**Example 4.** The fourth example is a system of two second order initial value problems

$$\begin{aligned}
 u''(x) &= -\frac{u(x)}{(u^2(x) + v^2(x))^{3/2}}, \quad 0 \leq x \leq 12\pi \\
 v''(x) &= -\frac{v(x)}{(u^2(x) + v^2(x))^{3/2}}, \quad 0 \leq x \leq 12\pi
 \end{aligned}
 \tag{63}$$

subject to the initial conditions

$$\begin{aligned}
 u(0) &= 0, \quad u'(0) = 1, \\
 v(0) &= 1, \quad v'(0) = 0.
 \end{aligned}
 \tag{64}$$

The exact solution is given by

$$u_{exact}(x) = \sin(x), \quad v_{exact}(x) = \cos(x).
 \tag{65}$$

We have converted this to a system of first order equations and solved it numerically using implicit Adams methods of trigonometric orders 2 and 3 (denoted AI2 and AI3, respectively) and generalized Milne-Simpson

methods (GMS) of the same order, which are (32) and (66), respectively. We also included results from [51] and Runge-Kutta-Nyström method [49]. The results are given in Table 6. For Adams implicit, we have used the Taylor series coefficients as given in [1]. For GMS with  $q = 2$ , we used the coefficients as given in [2]. They did not give the coefficients for  $q = 3$  but suggested to numerically solve the system for the coefficients. We were able now to get the coefficients

$$y_{n+5} = y_{n+3} + h (b_0 f_n + b_1 f_{n+1} + b_2 f_{n+2} + b_3 f_{n+3} + b_4 f_{n+4} + b_5 f_{n+5}), \tag{66}$$

where

$$\begin{aligned} b_0 &= \frac{1 \sin(v)}{6 d_1}, \\ b_1 &= -\frac{1 \sin(v)(2 \cos^2(v) - 1)}{3 d_2}, \\ b_2 &= \frac{1 \sin(v) (16 \cos^5(v) + 8 \cos^4(v) - 16 \cos^3(v) - 6 \cos^2(v) + 4 \cos(v) + 1)}{3 d_1}, \\ b_3 &= -\frac{1 \sin(v) (8 \cos^3(v) - 2 \cos(v) + 1) (4 \cos^3(v) - 4 \cos(v) - 1)}{3 d_1}, \\ b_4 &= \frac{1 \sin(v) (16 \cos^4(v) + 24 \cos^3(v) + 4 \cos^2(v) - 2 \cos(v) + 1)}{6 d_2}, \\ b_5 &= \frac{2 \sin(v) \cos^2(v) (4 \cos(v) + 3)}{3 d_1}, \end{aligned} \tag{67}$$

where

$$d_1 = v \cos(v) (8 \cos^3(v) + 8 \cos^2(v) - 1),$$

and

$$d_2 = v \cos(v) (4 \cos^2(v) + 2 \cos(v) - 1).$$

**Table 6.** The  $L_2$  norm of the error for the fourth example using two implicit methods of trigonometric orders 2 and 3 and one explicit from [51] and one based on Runge-Kutta-Nyström.

**Remark 5.**

1. Adams implicit using the Taylor series for the coefficients did not improve the accuracy by using a higher order.
2. GMS of second trigonometric order gave better results than the Adams implicit. There is no improvement by using  $q = 3$ .
3. The method (51) is superior followed by GMS with  $q = 2$  given by (32).
4. The method based on Runge-Kutta-Nyström could not compete with the others.

**Example 5.** The fifth example is the “almost periodic” problem studied by Stiefel and Bettis [30]

$$z'' + z = 0.001e^{it}, \quad 0 \leq t \leq 12\pi \tag{68}$$



subject to the initial conditions

$$\begin{aligned} z(0) &= 1, \\ z'(0) &= 0.9995i. \end{aligned} \tag{69}$$

The exact solution is

$$z_{exact}(t) = \cos t + 0.0005t \sin t + i(\sin t - 0.0005t \cos t). \tag{70}$$

The solution represents motion on a perturbation of a circular orbit in the complex plane; the point  $z(t)$  spirals slowly outwards.

The first order system equivalent was solved numerically using the above six methods. The results for  $h = \pi/60$  and the exact value of  $\omega = 1$  are given in Table 7.

**Table 7.** The  $L_2$  norm of the error for the fifth example using the six methods of the previous example for the exact frequency.

It is clear that the methods of trigonometric order 3 are better than the lower order ones. Also the GMS is better than Adams implicit due to Gautschi [1]. Again, the method (51) is superior.

The next two examples demonstrate the quality of method for long-term integration.

**Example 6.** The sixth example is the cubic oscillator as given in [52]

$$y''(x) + y(x) = \epsilon y(x)^3, \quad \epsilon = 10^{-3}, \tag{71}$$

with the initial conditions

$$\begin{aligned} y(0) &= 1, \\ y'(0) &= 0, \end{aligned} \tag{72}$$

and the frequency  $\omega = \sqrt{1 - 0.75\epsilon}$ . The exact solution to cubic order in  $\epsilon$  is given in [52]

$$y(x) = \cos(\omega x) + \frac{\epsilon}{128} (\cos(3\omega x) + \cos(\omega x)) + O(\epsilon^3).$$

The results are given in Table 8. It is clear that the methods that converged gave similar results. The methods (32) and (66) did not converge. The error is computed at  $x = 2000\pi$ .

**Table 8.** The  $L_2$  norm of the error for the sixth example using the six methods of the previous example for the exact frequency.

**Example 7.** The last example is a system of two second order ODEs describing two coupled oscillators with different frequencies, see [52].

$$\begin{aligned} x''(t) + x(t) &= 2\epsilon x(t)y(t), \\ y''(t) + 2y(t) &= \epsilon x(t)^2 + 4\epsilon y(t)^3, \end{aligned} \tag{73}$$

with initial conditions

$$\begin{aligned} x(0) &= 1, \\ x'(0) &= 0, \\ y(0) &= 1, \\ y'(0) &= 0, \end{aligned} \tag{74}$$

where  $\epsilon = 10^{-3}$ . The frequencies  $\omega_x = 1$  and  $\omega_y = \sqrt{2} - \frac{3\epsilon}{2\sqrt{2}}$  can be found in [52]. We have compared the solution using the same methods to RKF45 of Maple. The  $L_2$  norm of the difference between the solution of RKF45 and the six methods is given in Table 9. Now Adams implicit based method of trigonometric order 3 and our method (51) performed better than the others. Again, the methods due to Neta and Ford diverged.

## 7. Conclusions

We reviewed various trigonometrically-fitted methods and implemented representatives on several examples of second order initial value problems. In most examples our method from [51] was superior to others except for the first example for which Gautschi’s method performed better. The methods (32) and (66) due to Neta and Ford failed to converge for the last two examples and in the long-term integration of example 1. The method based on Runge-Kutta-Nyström due to Demba et al. [49] could not compete with our method based on Obrechhoff.
